

REGULARITY THEORY FOR 2-DIMENSIONAL ALMOST MINIMAL CURRENTS II: BRANCHED CENTER MANIFOLD

ABSTRACT. We construct a branched center manifold in a neighborhood of a singular point of a 2-dimensional integral current which is almost minimizing in a suitable sense. Our construction is the first half of an argument which shows the discreteness of the singular set for the following three classes of 2-dimensional currents: area minimizing in Riemannian manifolds, semicalibrated and spherical cross sections of 3-dimensional area minimizing cones.

This paper is the third in a series of works aimed at establishing an optimal regularity theory for 2-dimensional integral currents which are almost minimizing in a suitable sense. Building upon the monumental work of Almgren [1], Chang in [4] established that 2-dimensional area minimizing currents in Riemannian manifolds are classical minimal surfaces, namely they are regular (in the interior) except for a discrete set of branching singularities. The argument of Chang is however not entirely complete since a key starting point of his analysis, the existence of the so-called “branched center manifold”, is only sketched in the appendix of [4] and requires the understanding (and a suitable modification) of the most involved portion of the monograph [1].

An alternative proof of Chang’s theorem has been found by Rivière and Tian in [16] for the special case of J -holomorphic curves. Later on the approach of Rivière and Tian has been generalized by Bellettini and Rivière in [3] to handle a case which is not covered by [4], namely that of special Legendrian cycles in S^5 (see also [2] for a further generalization).

Meanwhile the first and second author revisited Almgren’s theory giving a much shorter version of his program for proving that area minimizing currents are regular up to a set of Hausdorff codimension 2, cf. [6, 8, 7, 9, 10]. In this note and its companion papers [11, 12] we build upon the latter works in order to give a complete regularity theory which includes both the theorems of Chang and Bellettini-Rivière as special cases. In order to be more precise, we introduce the following terminology (cf. [13, Definition 0.3]).

Definition 0.1. Let $\Sigma \subset \mathbb{R}^{m+n}$ be a C^2 submanifold and $U \subset \mathbb{R}^{m+n}$ an open set.

- (a) An m -dimensional integral current T with finite mass and $\text{spt}(T) \subset \Sigma \cap U$ is area minimizing in $\Sigma \cap U$ if $\mathbf{M}(T + \partial S) \geq \mathbf{M}(T)$ for any $m + 1$ -dimensional integral current S with $\text{spt}(S) \subset \subset \Sigma \cap U$.
- (b) A semicalibration (in Σ) is a C^1 m -form ω on Σ such that $\|\omega_x\|_c \leq 1$ at every $x \in \Sigma$, where $\|\cdot\|_c$ denotes the comass norm on $\Lambda^m T_x \Sigma$. An m -dimensional integral current T with $\text{spt}(T) \subset \Sigma$ is *semicalibrated* by ω if $\omega_x(\vec{T}) = 1$ for $\|T\|$ -a.e. x .

- (c) An m -dimensional integral current T supported in $\partial\mathbf{B}_{\bar{R}}(p) \subset \mathbb{R}^{m+n}$ is a *spherical cross-section of an area minimizing cone* if $p \ast T$ is area minimizing.

In what follows, given an integer rectifiable current T , we denote by $\text{Reg}(T)$ the subset of $\text{spt}(T) \setminus \text{spt}(\partial T)$ consisting of those points x for which there is a neighborhood U such that $T \llcorner U$ is a (constant multiple of) a C^2 submanifold. Correspondingly, $\text{Sing}(T)$ is the set $\text{spt}(T) \setminus (\text{spt}(\partial T) \cup \text{Reg}(T))$. Observe that $\text{Reg}(T)$ is relatively open in $\text{spt}(T) \setminus \text{spt}(\partial T)$ and thus $\text{Sing}(T)$ is relatively closed. The main result of this and the works [11, 12] is then the following

Theorem 0.2. *Let $m = 2$ and T be as in (a), (b) or (c) of Definition 0.1. Assume in addition that Σ is of class C^{3,ε_0} (in case (a) and (b)) and ω of class C^{2,ε_0} (in case (b)) for some positive ε_0 . Then $\text{Sing}(T)$ is discrete.*

Clearly Chang’s result is covered by case (a). As for the case of special Lagrangian cycles considered by Bellettini and Rivière in [3] observe that they form a special subclass of both (b) and (c). Indeed these cycles arise as spherical cross-sections of 3-dimensional special Lagrangian cones: as such they are then spherical cross sections of area minimizing cones but they are also semicalibrated by a specific smooth form on \mathbb{S}^5 .

Following the Almgren-Chang program, Theorem 0.2 will be established through a suitable “blow-up argument” which requires several tools. The first important tool is the theory of multiple valued functions, for which we will use the results and terminology of the papers [6, 8]. The second tool is a suitable approximation result for area minimizing currents with graphs of multiple valued functions, which for the case at hand has been established in the preceding note [11]. The last tool is the so-called “center manifold”: this will be constructed in the present paper, whereas the final argument for Theorem 0.2 will then be given in [12]. We note in passing that all our arguments use heavily the uniqueness of tangent cones for T . This result is a, by now classical, theorem of White for area minimizing 2-dimensional currents in the euclidean space, cf. [19]. Chang extended it to case (a) in the appendix of [4], whereas Pumberger and Rivière covered case (b) in [15]. A general derivation of these results for a wide class of almost minimizers has been given in [13]: the theorems in there cover, in particular, all the cases of Definition 0.1.

The proof of Theorem 0.2 is based, as in [4], on an induction statement, cf. Theorem 1.8 below. This and the next paper [12] can be thought as the two main steps in its proof. For this reason, before detailing the construction of the branched center manifold, which is the main object of this note, we will state Theorem 1.8, show how Theorem 0.2 follows from it and give a rough outline of the contributions of this and the next note [12].

1. PRELIMINARIES AND THE MAIN INDUCTION STATEMENT

1.1. **Basic notation and first main assumptions.** For the notation concerning submanifolds $\Sigma \subset \mathbb{R}^{2+n}$ we refer to [7, Section 1]. With $\mathbf{B}_r(p)$ and $B_r(x)$ we denote, respectively, the open ball with radius r and center p in \mathbb{R}^{2+n} and the open ball with radius r

and center x in \mathbb{R}^2 . $\mathbf{C}_r(p)$ and $\mathbf{C}_r(x)$ will always denote the cylinder $B_r(x) \times \mathbb{R}^n$, where $p = (x, y) \in \mathbb{R}^2 \times \mathbb{R}^n$. We will often need to consider cylinders whose bases are parallel to other 2-dimensional planes, as well as balls in m -dimensional affine planes. We then introduce the notation $B_r(p, \pi)$ for $\mathbf{B}_r(p) \cap (p + \pi)$ and $\mathbf{C}_r(p, \pi)$ for $B_r(p, \pi) + \pi^\perp$. e_i will denote the unit vectors in the standard basis, π_0 the (oriented) plane $\mathbb{R}^2 \times \{0\}$ and $\vec{\pi}_0$ the 2-vector $e_1 \wedge e_2$ orienting it. Given an m -dimensional plane π , we denote by \mathbf{p}_π and \mathbf{p}_π^\perp the orthogonal projections onto, respectively, π and its orthogonal complement π^\perp . For what concerns integral currents we use the definitions and the notation of [17]. Since π is used recurrently for 2-dimensional planes, the 2-dimensional area of the unit circle in \mathbb{R}^2 will be denoted by ω_2 .

By [11, Lemma 1.1] in case (b) we can assume, without loss of generality, that the ambient manifold Σ coincides with the euclidean space \mathbb{R}^{2+n} . In the rest of the paper we will therefore always make the following

Assumption 1.1. T is an integral current of dimension 2 with bounded support and it satisfies one of the three conditions (a), (b) or (c) in Definition 0.1. Moreover

- In case (a), $\Sigma \subset \mathbb{R}^{2+n}$ is a C^{3,ε_0} submanifold of dimension $2 + \bar{n} = 2 + n - l$, which is the graph of an entire function $\Psi : \mathbb{R}^{2+\bar{n}} \rightarrow \mathbb{R}^l$ and satisfies the bounds

$$\|D\Psi\|_0 \leq c_0 \quad \text{and} \quad \mathbf{A} := \|A_\Sigma\|_0 \leq c_0, \quad (1.1)$$

where c_0 is a positive (small) dimensional constant and $\varepsilon_0 \in]0, 1[$.

- In case (b) we assume that $\Sigma = \mathbb{R}^{2+n}$ and that the semicalibrating form ω is C^{2,ε_0} .
- In case (c) we assume that T is supported in $\Sigma = \partial\mathbf{B}_R(p_0)$ for some p_0 with $|p_0| = R$, so that $0 \in \partial\mathbf{B}_R(p_0)$. We assume also that $T_0\partial\mathbf{B}_R(p_0)$ is \mathbb{R}^{2+n-1} (namely $p_0 = (0, \dots, 0, \pm|p_0|)$) and we let $\Psi : \mathbb{R}^{2+n-1} \rightarrow \mathbb{R}$ be a smooth extension to the whole space of the function which describes Σ in $\mathbf{B}_2(0)$. We assume then that (1.1) holds, which is equivalent to the requirement that R^{-1} be sufficiently small.

In addition, since the conclusion of Theorem 0.2 is local, by [13, Proposition 0.4] we can also assume to be always in the following situation.

Assumption 1.2. In addition to Assumption 1.1 we assume the following:

- $\partial T \llcorner \mathbf{C}_2(0, \pi_0) = 0$;
- $0 \in \text{spt}(T)$ and the tangent cone at 0 is given by $\Theta(T, 0) \llbracket \pi_0 \rrbracket$ where $\Theta(T, 0) \in \mathbb{N} \setminus \{0\}$;
- T is irreducible in any neighborhood U of 0 in the following sense: it is not possible to find S, Z non-zero integer rectifiable currents in U with $\partial S = \partial Z = 0$ (in U), $T = S + Z$ and $\text{spt}(S) \cap \text{spt}(Z) = \{0\}$.

In order to justify point (iii), observe that we can argue as in the proof of [13, Theorem 3.1]: assuming that in a certain neighborhood U there is a decomposition $T = S + Z$ as above, it follows from [13, Proposition 2.2] that both S and Z fall in one of the classes of Definition 0.1. In turn this implies that $\Theta(S, 0), \Theta(Z, 0) \in \mathbb{N} \setminus \{0\}$ and thus $\Theta(S, 0) < \Theta(T, 0)$. We can then replace T with either S or Z . Let $T_1 = S$ and argue similarly if it is not irreducible: obviously we can apply the argument above one more time and find a

T_2 which satisfies all the requirements and has $0 < \Theta(T_2, 0) < \Theta(T_1, 0)$. This process must stop after at most $N = \Theta(T, 0)$ steps: the final current is then necessarily irreducible.

1.2. Branching model. We next introduce an object which will play a key role in the rest of our work, because it is the basic local model of the singular behavior of a 2-dimensional area minimizing current: for each positive natural number Q we will denote by $\mathfrak{B}_{Q,\rho}$ the flat Riemann surface which is a disk with a conical singularity, in the origin, of angle $2\pi Q$ and radius $\rho > 0$. More precisely we have

Definition 1.3. $\mathfrak{B}_{Q,\rho}$ is topologically an open 2-dimensional disk, which we identify with the topological space $\{(z, w) \in \mathbb{C}^2 : w^Q = z, |z| < \rho\}$. For each $(z_0, w_0) \neq 0$ in $\mathfrak{B}_{Q,\rho}$ we consider the connected component $\mathfrak{D}(z_0, w_0)$ of $\mathfrak{B}_{Q,\rho} \cap \{(z, w) : |z - z_0| < |z_0|/2\}$ which contains (z_0, w_0) . We then consider the smooth manifold given by the atlas

$$\{(\mathfrak{D}(z, w), (x_1, x_2)) : (z, w) \in \mathfrak{B}_{Q,\rho} \setminus \{0\}\},$$

where (x_1, x_2) is the function which gives the real and imaginary part of the first complex coordinate of a generic point of $\mathfrak{B}_{Q,\rho}$. On such smooth manifold we consider the following flat Riemannian metric: on each $\mathfrak{D}(z, w)$ with the chart (x_1, x_2) the metric tensor is the usual euclidean one $dx_1^2 + dx_2^2$. Such metric will be called the *canonical flat metric* and denoted by e_Q .

When $Q = 1$ we can extend smoothly the metric tensor to the origin and we obtain the usual euclidean 2-dimensional disk. For $Q > 1$ the metric tensor does not extend smoothly to 0, but we can nonetheless complete the induced geodesic distance on $\mathfrak{B}_{Q,\rho}$ in a neighborhood of 0: for $(z, w) \neq 0$ the distance to the origin will then correspond to $|z|$. The resulting metric space is a well-known object in the literature, namely a flat Riemann surface with an isolated conical singularity at the origin (see for instance [20]). Note that for each z_0 and $0 < r \leq \min\{|z_0|, \rho - |z_0|\}$ the set $\mathfrak{B}_{Q,\rho} \cap \{|z - z_0| < r\}$ consists then of Q nonintersecting 2-dimensional disks, each of which is a geodesic ball of $\mathfrak{B}_{Q,\rho}$ with radius r and center (z_0, w_i) for some $w_i \in \mathbb{C}$ with $w_i^Q = z_0$. We then denote each of them by $B_r(z_0, w_i)$ and treat it as a standard disk in the euclidean 2-dimensional plane (which is correct from the metric point of view). We use however the same notation for the distance disk $B_r(0)$, namely for the set $\{(z, w) : |z| < r\}$, although the latter is *not isometric* to the standard euclidean disk. Since this might be create some ambiguity, we will use the specification $\mathbb{R}^2 \supset B_r(0)$ (or $\mathbb{R}^2 \supset B_r$) when referring to the standard disk in \mathbb{R}^2 .

1.3. Admissible Q -branchings. When one of (or both) the parameters Q and ρ are clear from the context, the corresponding subscript (or both) will be omitted. We will always treat each point of \mathfrak{B} as an element of \mathbb{C}^2 , mostly using z and w for the horizontal and vertical complex coordinates. Often \mathbb{C} will be identified with \mathbb{R}^2 and thus the coordinate z will be treated as a two-dimensional real vector, avoiding the more cumbersome notation (x_1, x_2) .

Definition 1.4 (Q -branchings). Let $\alpha \in]0, 1[$, $b > 1$, $Q \in \mathbb{N} \setminus \{0\}$ and $n \in \mathbb{N} \setminus \{0\}$. An admissible α -smooth and b -separated Q -branching in \mathbb{R}^{2+n} (shortly a Q -branching) is the

graph

$$\text{Gr}(u) := \{(z, u(z, w)) : (z, w) \in \mathfrak{B}_{Q, 2\rho}\} \subset \mathbb{R}^{2+n} \quad (1.2)$$

of a map $u : \mathfrak{B}_{Q, 2\rho} \rightarrow \mathbb{R}^n$ satisfying the following assumptions. For some constant $C_i > 0$ we have

- u is continuous, $u \in C^{3, \alpha}$ on $\mathfrak{B}_{Q, 2\rho} \setminus \{0\}$ and $u(0) = 0$;
- $|D^j u(z, w)| \leq C_i |z|^{1-j+\alpha} \forall (z, w) \neq 0$ and $j \in \{0, 1, 2, 3\}$;
- $[D^3 u]_{\alpha, B_r(z, w)} \leq C_i |z|^{-2}$ for every $(z, w) \neq 0$ with $|z| = 2r$;
- If $Q > 1$, then there is a positive constant $c_s \in]0, 1[$ such that

$$\min\{|u(z, w) - u(z, w')| : w \neq w'\} \geq 4c_s |z|^b \quad \text{for all } (z, w) \neq 0. \quad (1.3)$$

The map $\Phi(z, w) := (z, u(z, w))$ will be called the *graphical parametrization* of the Q -branching.

Any Q -branching as in the Definition above is an immersed disk in \mathbb{R}^{2+n} and can be given a natural structure as integer rectifiable current, which will be denoted by \mathbf{G}_u . For $Q = 1$ a map u as in Definition 1.4 is a (single valued) $C^{1, \alpha}$ map $u : \mathbb{R}^2 \supset B_{2\rho}(0) \rightarrow \mathbb{R}^n$. Although the term branching is not appropriate in this case, the advantage of our setup is that $Q = 1$ will not be a special case in the induction statement of Theorem 1.8 below. Observe that for $Q > 1$ the map u can be thought as a Q -valued map $u : \mathbb{R}^2 \supset B_{2\rho}(0) \rightarrow \mathcal{A}_Q(\mathbb{R}^n)$, setting $u(z) = \sum_{(z, w_i) \in \mathfrak{B}} \llbracket u(z, w_i) \rrbracket$ for $z \neq 0$ and $u(0) = Q \llbracket 0 \rrbracket$. The notation $\text{Gr}(u)$ and \mathbf{G}_u is then coherent with the corresponding objects defined in [8] for general Q -valued maps.

1.4. The inductive statement. Before coming to the key inductive statement, we need to introduce some more terminology.

Definition 1.5 (Horned Neighborhood). Let $\text{Gr}(u)$ be a b -separated Q -branching. For every $a > b$ we define the *horned neighborhood* $\mathbf{V}_{u, a}$ of $\text{Gr}(u)$ to be

$$\mathbf{V}_{u, a} := \{(x, y) \in \mathbb{R}^2 \times \mathbb{R}^n : \exists (x, w) \in \mathfrak{B}_{Q, 2\rho} \text{ with } |y - u(x, w)| < c_s |x|^a\}, \quad (1.4)$$

where c_s is the constant in (1.3).

Definition 1.6 (Excess). Given an m -dimensional current T in \mathbb{R}^{m+n} with finite mass, its *excess* in the ball $\mathbf{B}_r(x)$ and in the cylinder $\mathbf{C}_r(p, \pi')$ with respect to the m -plane π are

$$\mathbf{E}(T, \mathbf{B}_r(p), \pi) := (2\omega_m r^m)^{-1} \int_{\mathbf{B}_r(p)} |\vec{T} - \vec{\pi}|^2 d\|T\| \quad (1.5)$$

$$\mathbf{E}(T, \mathbf{C}_r(p, \pi'), \pi) := (2\omega_m r^m)^{-1} \int_{\mathbf{C}_r(p, \pi')} |\vec{T} - \vec{\pi}|^2 d\|T\|. \quad (1.6)$$

For cylinders we omit the third entry when $\pi = \pi'$, i.e. $\mathbf{E}(T, \mathbf{C}_r(p, \pi)) := \mathbf{E}(T, \mathbf{C}_r(p, \pi), \pi)$. In order to define the spherical excess we consider T as in Assumption 1.1 and we say that π *optimizes the excess* of T in a ball $\mathbf{B}_r(x)$ if

- In case (b)

$$\mathbf{E}(T, \mathbf{B}_r(x)) := \min_{\tau} \mathbf{E}(T, \mathbf{B}_r(x), \tau) = \mathbf{E}(T, \mathbf{B}_r(x), \pi); \quad (1.7)$$

- In case (a) and (c) $\pi \subset T_x \Sigma$ and

$$\mathbf{E}(T, \mathbf{B}_r(x)) := \min_{\tau \subset T_x \Sigma} \mathbf{E}(T, \mathbf{B}_r(x), \tau) = \mathbf{E}(T, \mathbf{B}_r(x), \pi). \quad (1.8)$$

Note in particular that, in case (a) and (c), $\mathbf{E}(T, \mathbf{B}_r(x))$ differs from the quantity defined in [10, Definition 1.1], where, although Σ does not coincide with the ambient euclidean space, τ is allowed to vary among *all* planes, as in case (b). Thus a notation more consistent with that of [10] would be, in case (a) and (c), $\mathbf{E}^\Sigma(T, \mathbf{B}_r(x))$. However, the difference is a minor one and we prefer to keep our notation simpler.

Our main induction assumption is then the following

Assumption 1.7 (Inductive Assumption). T is as in Assumption 1.1 and 1.2. For some constants $\bar{Q} \in \mathbb{N} \setminus \{0\}$ and $0 < \alpha < \frac{1}{2\bar{Q}}$ there is an α -admissible \bar{Q} -branching $\text{Gr}(u)$ with $u : \mathfrak{B}_{\bar{Q},2} \rightarrow \mathbb{R}^n$ such that

- (Sep) If $\bar{Q} > 1$, u is b -separated for some $b > 1$; a choice of some $b > 1$ is fixed also in the case $\bar{Q} = 1$, although in this case the separation condition is empty.
- (Hor) $\text{spt}(T) \subset \mathbf{V}_{u,a} \cup \{0\}$ for some $a > b$;
- (Dec) There exist $\gamma > 0$ and a $C_i > 0$ with the following property. Let $p = (x_0, y_0) \in \text{spt}(T) \cap \mathbf{C}_{\sqrt{2}}(0)$ and $4d := |x_0| > 0$, let V be the connected component of $\mathbf{V}_{u,a} \cap \{(x, y) : |x - x_0| < d\}$ containing p and let $\pi(p)$ be the plane tangent to $\text{Gr}(u)$ at the only point of the form $(x_0, u(x_0, w_i))$ which is contained in V . Then

$$\mathbf{E}(T \llcorner V, \mathbf{B}_\sigma(p), \pi(p)) \leq C_i^2 d^{2\gamma-2} \sigma^2 \quad \forall \sigma \in [\frac{1}{2}d^{(b+1)/2}, d]. \quad (1.9)$$

The main inductive step is then the following theorem, where we denote by $T_{p,r}$ the rescaled current $(\iota_{p,r})_\# T$, through the map $\iota_{p,r}(q) := (q - p)/r$.

Theorem 1.8 (Inductive statement). *Let T be as in Assumption 1.7 for some $\bar{Q} = Q_0$. Then,*

- (a) *either T is, in a neighborhood of 0, a Q multiple of a \bar{Q} -branching $\text{Gr}(v)$;*
- (b) *or there are $r > 0$ and $Q_1 > Q_0$ such that $T_{0,r}$ satisfies Assumption 1.7 with $\bar{Q} = Q_1$.*

Theorem 0.2 follows then easily from Theorem 1.8 and [13].

1.5. Proof of Theorem 0.2. As already mentioned, without loss of generality we can assume that Assumption 1.1 holds, cf. [13, Lemma 1.1] (the bounds on \mathbf{A} and Ψ can be achieved by a simple scaling argument). Fix now a point p in $\text{spt}(T) \setminus \text{spt}(\partial T)$. Our aim is to show that T is regular in a punctured neighborhood of p . Without loss of generality we can assume that p is the origin. Upon suitably decomposing T in some neighborhood of 0 we can easily assume that (Sep) in Assumption 1.7 holds, cf. the argument of Step 4 in the proof of [13, Theorem 3.1]. Thus, upon suitably rescaling and rotating T we can assume that π_0 is the unique tangent cone to T at 0, cf. [13, Theorem 3.1]. In fact, by [13, Theorem 3.1] T satisfies Assumption 1.7 with $\bar{Q} = 1$: it suffices to chose $u \equiv 0$ as admissible smooth branching. If T were not regular in any punctured neighborhood of 0, we could then apply Theorem 1.8 inductively to find a sequence of rescalings T_{0,ρ_j} with $\rho_j \downarrow 0$ which satisfy Assumption 1.7 with $\bar{Q} = Q_j$ for some strictly increasing sequence of

integers. It is however elementary that the density $\Theta(0, T)$ bounds Q_j from above (see for instance the argument of the next section leading to Lemma 2.1), which is a contradiction.

2. THE BRANCHED CENTER MANIFOLD

2.1. The overall approach to Theorem 1.8. From now on we fix T satisfying Assumption 1.7. Observe that, without loss of generality, we are always free to replace T by $T_{0,r}$ with r sufficiently small (and ignore whatever portion falls outside $\mathbf{C}_2(0)$). Indeed we will do this several times. Hence, if we can prove that something holds in a sufficiently small neighborhood of 0, then we can assume, without loss of generality, that it holds on $\mathbf{C}_2(0)$. For this reason we can assume that the constant C_i in Definition 1.4 and Assumption 1.7 is as small as we want. In turns this implies that there is a well-defined orthogonal projection $\mathbf{P} : \mathbf{V}_{u,a} \cap \mathbf{C}_1 \rightarrow \text{Gr}(u) \cap \mathbf{C}_2$, which is a $C^{2,\alpha}$ map.

By the constancy theorem, $(\mathbf{P}_\#(T \llcorner \mathbf{C}_1)) \llcorner \mathbf{C}_{1/2}$ coincides with the current $Q\mathbf{G}_u \llcorner \mathbf{C}_{1/2}$ (again, we are assuming C_i in Definition 1.4 sufficiently small), where $Q \in \mathbb{Z}$. If Q were 0, condition (Dec) in Assumption 1.7 and a simple covering argument would imply that $\|T\|(\mathbf{C}_{1/2}(0)) \leq C_0 C_i^2$, where C_0 is a constant depending on n and \bar{Q} . In particular, when C_i is sufficiently small, this would violate, by the monotonicity formula, the assumption $0 \in \text{spt}(T)$. Thus $Q \neq 0$. On the other hand condition (Dec) in Assumption 1.7 implies also that Q must be positive (again, provided C_i is smaller than a geometric constant).

Now, recall from [13, Theorem 3.1] that the density $\Theta(p, T)$ is a positive integer at any $p \in \text{spt}(T) \setminus \text{spt}(\partial T)$. Moreover, the rescaled currents $T_{0,r}$ converge to $\Theta(0, T) \llbracket \pi_0 \rrbracket$. It is easy to see that the rescaled currents $(\mathbf{G}_u)_{0,r}$ converge to $\bar{Q} \llbracket \pi_0 \rrbracket$ and that $(\mathbf{P}_\# T)_{0,r}$ converges to $\Theta(0, T) \llbracket \pi_0 \rrbracket$. We then conclude that $\Theta(0, T) = Q\bar{Q}$.

We summarize these conclusions in the following lemma, where we also claim an additional important bound on the density of T outside 0, which will be proved later.

Lemma 2.1. *Let T and u be as in Assumption 1.7 for some \bar{Q} and sufficiently small C_i . Then the nearest point projection $\mathbf{P} : \mathbf{V}_{u,a} \cap \mathbf{C}_1 \rightarrow \text{Gr}(u)$ is a well-defined $C^{2,\alpha}$ map. In addition there is $Q \in \mathbb{N} \setminus \{0\}$ such that $\Theta(0, T) = Q\bar{Q}$ and the unique tangent cone to T at 0 is $Q\bar{Q} \llbracket \pi_0 \rrbracket$. Finally, after possibly rescaling T , $\Theta(p, T) \leq Q$ for every $p \in \mathbf{C}_2 \setminus \{0\}$ and, for every $x \in B_2(0)$, each connected component of $(\{x\} \times \mathbb{R}^n) \cap \mathbf{V}_{u,a}$ contains at least one point of $\text{spt}(T)$.*

Since we will assume during the rest of the paper that the above discussion applies, we summarize the relevant conclusions in the following

Assumption 2.2. T satisfies Assumption 1.7 for some \bar{Q} and with C_i sufficiently small. $Q \geq 1$ is an integer, $\Theta(0, T) = Q\bar{Q}$ and $\Theta(p, T) \leq Q$ for all $p \in \mathbf{C}_2 \setminus \{0\}$.

The overall plan to prove Theorem 1.8 is then the following:

- (CM) We construct first a branched center manifold, i.e. a second admissible smooth branching φ on $\mathfrak{B}_{\bar{Q}}$, and a corresponding Q -valued map N defined on the normal bundle of $\text{Gr}(\varphi)$, which approximates T with a very high degree of accuracy (in particular more accurately than u) and whose average $\eta \circ N$ is very small;

(BU) Assuming that alternative (a) in Theorem 1.8 does not hold, we study the asymptotic behavior of N around 0 and use it to build a new admissible smooth branching v on some $\mathfrak{B}_{k\bar{Q}}$ where $k \geq 2$ is a factor of Q : this map will then be the one sought in alternative (b) of Theorem 1.8 and a suitable rescaling of T will lie in a horned neighborhood of its graph.

The first part of the program is the one achieved in this paper, whereas the second part will be completed in [12]: in the latter paper we then give the proof of Theorem 1.8. Note that, when $Q = 1$, from (BU) we will conclude that alternative (a) necessarily holds: this will be a simple corollary of the general case, but we observe that it could also be proved resorting to the classical Allard's regularity theorem.

2.2. Smallness condition. In several occasions we will need that the ambient manifold Σ is suitably flat and that the excess of the current T is suitably small. This can, however, be easily achieved after scaling. More precisely we have the following

Lemma 2.3. *Let T be as in the Assumptions 1.7. After possibly rescaling, rotating and modifying Σ outside $\mathbf{C}_2(0)$ we can assume that, in case (a) and (c) of Definition 0.1,*

- (i) Σ is a complete submanifold of \mathbb{R}^{2+n} ;
- (ii) $T_0\Sigma = \mathbb{R}^{2+\bar{n}} \times \{0\}$ and, $\forall p \in \Sigma$, Σ is the graph of a C^{3,ε_0} map $\Psi_p : T_p\Sigma \rightarrow (T_p\Sigma)^\perp$.

Under these assumptions, we denote by \mathbf{c} and \mathbf{m}_0 the following quantities

$$\mathbf{c} := \sup\{\|D\Psi_p\|_{C^{2,\varepsilon_0}} : p \in \Sigma\} \quad \text{in the cases (a) and (c) of Definition 0.1} \quad (2.1)$$

$$\mathbf{c} := \|d\omega\|_{C^{1,\varepsilon_0}} \quad \text{in case (b) of Definition 0.1} \quad (2.2)$$

$$\mathbf{m}_0 := \max\{\mathbf{c}^2, \mathbf{E}(T, \mathbf{C}_2, \pi_0), C_i^2, c_s^2\}, \quad (2.3)$$

where C_i and c_s are the constants appearing in Definition 1.4 and Assumption 1.7. Then, for any $\varepsilon_2 > 0$, after possibly rescaling the current by a large factor, we can assume

$$\mathbf{m}_0 \leq \varepsilon_2. \quad (2.4)$$

We postpone the proof of this (simple) technical lemma to a later section.

2.3. Conformal parametrization. In order to carry on the plan outlined in the previous subsection, it is convenient to use parametrizations of Q -branchings which are not graphical but instead satisfy a suitable conformality property. To simplify our notation, the map Ψ_0 will be simply denoted by Ψ .

If we remove the origin, any admissible Q -branching is a Riemannian submanifold of $\mathbb{R}^{2+n} \setminus \{0\}$: this gives a Riemannian tensor $g := \Phi^\sharp e$ (where e denotes the euclidean metric on \mathbb{R}^{2+n}) on the punctured disk $\mathfrak{B}_{Q,2\rho} \setminus \{0\}$. Note that in (z, w) the difference between the metric tensor g and the canonical flat metric e_Q can be estimated by (a constant times) $|z|^{2\alpha}$: thus, as it happens for the canonical flat metric e_Q , when $Q > 1$ it is not possible to extend the metric g to the origin. However, using well-known arguments in differential geometry, we can find a conformal map from $\mathfrak{B}_{Q,r}$ onto a neighborhood of 0 which maps the conical singularity of $\mathfrak{B}_{Q,r}$ in the conical singularity of the Q -branching. In fact, we need the following accurate estimates for such a map.

Proposition 2.4 (Conformal parametrization). *Given an admissible b -separated α -smooth Q -branching $\text{Gr}(u)$ with $\alpha < 1/(2Q)$ there exist a constant $C_0(Q, \alpha) > 0$, a radius $r > 0$ and functions $\Psi: \mathfrak{B}_{Q,r} \rightarrow \text{Gr}(u)$ and $\lambda: \mathfrak{B}_{Q,r} \rightarrow \mathbb{R}_+$ such that*

- (i) Ψ is a homeomorphism of $\mathfrak{B}_{Q,r}$ with a neighborhood of 0 in $\text{Gr}(u)$;
- (ii) $\Psi \in C^{3,\alpha}(\mathfrak{B}_{Q,r} \setminus \{0\})$, with the estimates

$$|D^l(\Psi(z, w) - (z, 0))| \leq C_0 C_i |z|^{1+\alpha-l} \quad \text{for } l = 0, \dots, 3, z \neq 0, \quad (2.5)$$

$$[D^3\Psi]_{\alpha, B_r(z,w)} \leq C_0 C_i |z|^{-2} \quad \text{for } z \neq 0 \text{ and } r = |z|/2; \quad (2.6)$$

- (iii) Ψ is a conformal map with conformal factor λ , namely, if we denote by e the ambient euclidean metric in \mathbb{R}^{2+n} and by e_Q the canonical euclidean metric of $\mathfrak{B}_{Q,r}$,

$$g := \Psi^\# e = \lambda e_Q \quad \text{on } \mathfrak{B}_{Q,r} \setminus \{0\}. \quad (2.7)$$

- (iv) The conformal factor λ satisfies

$$|D^l(\lambda - 1)(z, w)| \leq C_0 C_i |z|^{2\alpha-l} \quad \text{for } l = 0, 1, \dots, 2 \quad (2.8)$$

$$[D^2\lambda]_{\alpha, B_r(z,w)} \leq C_0 C_i |z|^{\alpha-2} \quad \text{for } z \neq 0 \text{ and } r = |z|/2. \quad (2.9)$$

A proof of Proposition 2.4 is given in Appendix B.

Definition 2.5. A map Ψ as in Proposition 2.4 will be called a *conformal parametrization* of an admissible Q -branching.

2.4. The center manifold and the approximation. We are finally ready to state the main theorem of this note.

Theorem 2.6 (Center Manifold Approximation). *Let T be as in Assumptions 1.7 and 2.2 and assume in addition that the conclusions of Lemma 2.3 apply (in particular we might need to replace T by $T_{0,r}$ for r sufficiently small). Then there exist $\eta_0, \gamma_0, r_0, C > 0$, $b > 1$, an admissible b -separated γ_0 -smooth \bar{Q} -branching \mathcal{M} , a corresponding conformal parametrization $\Psi: \mathfrak{B}_{\bar{Q},2} \rightarrow \mathcal{M}$ and a Q -valued map $\mathcal{X}: \mathfrak{B}_{\bar{Q},2} \rightarrow \mathcal{A}_Q(\mathbb{R}^{2+n})$ with the following properties:*

- (i) $\bar{Q}Q = \Theta(T, 0)$ and

$$|D(\Psi(z, w) - (z, 0))| \leq C \mathbf{m}_0^{1/2} |z|^{\gamma_0} \quad (2.10)$$

$$|D^2\Psi(z, w)| + |z| |D^3\Psi(z, w)| \leq C \mathbf{m}_0^{1/2} |z|^{\gamma_0-1}; \quad (2.11)$$

in particular, if we denote by $A_{\mathcal{M}}$ the second fundamental form of $\mathcal{M} \setminus \{0\}$,

$$|A_{\mathcal{M}}(\Psi(z, w))| + |z| |D_{\mathcal{M}} A_{\mathcal{M}}(\Psi(z, w))| \leq C \mathbf{m}_0^{1/2} |z|^{\gamma_0-1}.$$

- (ii) $\mathcal{X}_i(z, w)$ is orthogonal to the tangent plane, at $\Psi(z, w)$, to \mathcal{M} .
- (iii) If we define $S := T_{0,r_0}$, then $\text{spt}(S) \cap \mathbf{C}_1 \setminus \{0\}$ is contained in a suitable horned neighborhood of the \bar{Q} -branching \mathcal{M} , where the orthogonal projection \mathbf{P} onto it is well-defined. Moreover, for every $r \in]0, 1[$ we have

$$\|\mathcal{X}|_{B_r}\|_0 + \sup_{p \in \text{spt}(S) \cap \mathbf{P}^{-1}(\Psi(B_r))} |p - \mathbf{P}(p)| \leq C \mathbf{m}_0^{1/4} r^{1+\gamma_0/2}. \quad (2.12)$$

(iv) *If we define*

$$\mathbf{D}(r) := \int_{B_r} |D\mathcal{N}|^2 \quad \text{and} \quad \mathbf{H}(r) := \int_{\partial B_r} |\mathcal{N}|^2,$$

$$\mathbf{F}(r) := \int_0^r \frac{\mathbf{H}(t)}{t^{2-\gamma_0}} dt \quad \text{and} \quad \mathbf{\Lambda}(r) := \mathbf{D}(r) + \mathbf{F}(r),$$

then the following estimates hold for every $r \in]0, 1[$:

$$\text{Lip}(\mathcal{N}|_{B_r}) \leq C \min\{\mathbf{\Lambda}^{\eta_0}(r), \mathbf{m}_0^{\eta_0} r^{\eta_0}\} \quad (2.13)$$

$$\mathbf{m}_0^{\eta_0} \int_{B_r} |z|^{\gamma_0-1} |\boldsymbol{\eta} \circ \mathcal{N}(z, w)| \leq C \mathbf{\Lambda}^{\eta_0}(r) \mathbf{D}(r) + C \mathbf{F}(r). \quad (2.14)$$

(v) *Finally, if we set*

$$\mathcal{F}(z, w) := \sum_i \llbracket \Psi(z, w) + \mathcal{N}_i(z, w) \rrbracket,$$

then

$$\|S - \mathbf{T}_{\mathcal{F}}\|(\mathbf{P}^{-1}(\Psi(B_r))) \leq C \mathbf{\Lambda}^{\eta_0}(r) \mathbf{D}(r) + C \mathbf{F}(r). \quad (2.15)$$

The rest of this note is dedicated to prove the above theorem. We first outline how the center manifold is constructed. We then construct an approximating map N taking values on its normal bundle. Finally we change coordinates using a conformal parametrization Ψ and prove the above theorem for the map $\mathcal{N} = N \circ \Psi$.

3. CENTER MANIFOLD: THE CONSTRUCTION ALGORITHM

3.1. Choice of some parameters and smallness of some other constants. As in [9] the construction of the center manifold involves several parameters. We start by choosing three of them which will appear as exponents of (two) lengthscales in several estimates.

Assumption 3.1. Let T be as in Assumptions 1.7 and 2.2, assume in addition that the conclusions of Lemma 2.3 apply (we might therefore need to replace T with $T_{0,r}$ for a sufficiently small r) and in particular recall the exponents $\varepsilon_0, \alpha, b, a$ and γ defined therein. We choose the positive exponents γ_0, β_2 and δ_1 (in the given order) so that

$$\gamma_0 < \min\{\gamma, \alpha, a - b, b - \frac{b+1}{2}, \log_2 \frac{6}{5}\} \quad (3.1)$$

$$\beta_2 < \min\{\varepsilon_0, \frac{\gamma_0}{4}, \frac{a}{b} - 1, \frac{\alpha}{2}, \frac{\beta_0 \gamma_0}{2}\} \quad b > \frac{1+b}{2}(1 + \beta_2) \quad (3.2)$$

$$\beta_2 - 2\delta_1 \geq \frac{\beta_2}{3} \quad \beta_0(2 - 2\delta_1) - 2\delta_1 \geq 2\beta_2 \quad (3.3)$$

(where β_0 is the constant of [11, Theorem 5.2] and in this paper we assume it is smaller than $1/2$)

Having fixed γ_0, β_2 and δ_1 we introduce five further parameters: M_0, N_0, C_e, C_h and ε_2 . We will impose several inequalities upon them, but following a very precise hierarchy, which ensures that all the conditions required in the remaining statements can be met. We will use the term “geometric” when such conditions depend only upon $\bar{n}, n, Q, \bar{Q}, \gamma_0, \beta_2$

and δ_1 , whereas we keep track of their dependence on M_0, N_0, C_e and C_h using the notation $C = C(M_0), C(M_0, N_0)$ and so on. ε_2 is always the last parameter to be chosen: it will be small depending upon all the other constants, but constants will never depend upon it.

Assumption 3.2 (Hierarchy of the parameters). In all the statements of the paper

- $M_0 \geq 4$ is larger than a geometric constant and N_0 is a natural number larger than $C(M_0)$; one such condition is recurrent and we state it here:

$$\sqrt{2}M_02^{10-N_0} \leq 1; \quad (3.4)$$

- C_e is larger than $C(M_0, N_0)$;
- C_h is larger than $C(M_0, N_0, C_e)$;
- $\varepsilon_2 > 0$ is smaller than $c(M_0, N_0, C_e, C_h) > 0$.

3.2. Whitney decomposition of $\mathfrak{B}_{\bar{Q}, 2}$. From now on we will use \mathfrak{B} for $\mathfrak{B}_{\bar{Q}, 2}$, since the positive natural number \bar{Q} is fixed for the rest of the paper. In this section we decompose $\mathfrak{B} \setminus \{0\}$ in a suitable way. More precisely, a closed subset L of \mathfrak{B} will be called a dyadic square if it is a connected component of $\mathfrak{B} \cap (H \times \mathbb{C})$ for some euclidean dyadic square $H = [a_1, a_1 + 2\ell] \times [a_2, a_2 + 2\ell] \subset \mathbb{R}^2 = \mathbb{C}$ with

- $\ell = 2^{-j}$, $j \in \mathbb{N}$, $j \geq 3$, and $a \in 2^{1-j}\mathbb{Z}^2$;
- $H \subset [-1, 1]^2$ and $0 \notin H$.

Observe that L is truly a square, both from the topological and the metric point of view. 2ℓ is the sidelength of both H and L . Note that $\mathfrak{B} \cap (H \times \mathbb{C})$ consists then of \bar{Q} distinct squares $L_1, \dots, L_{\bar{Q}}$. $z_H := a + (\ell, \ell)$ is the center of the square H . Each L lying over H will then contain a point (z_H, w_L) , which is the center of L . Depending upon the context we will then use z_L rather than z_H for the first (complex) component of the center of L .

The family of all dyadic squares of \mathfrak{B} defined above will be denoted by \mathcal{C} . We next consider, for $j \in \mathbb{N}$, the dyadic closed annuli

$$\mathcal{A}_j := \mathfrak{B} \cap (([-2^{-j}, 2^{-j}]^2 \setminus]-2^{-j-1}, 2^{-j-1}[^2) \times \mathbb{C}).$$

Each dyadic square L of \mathfrak{B} is then contained in exactly one annulus \mathcal{A}_j and we define $d(L) := 2^{-j-1}$. Moreover $\ell(L) = 2^{-j-k}$ for some $k \geq 2$. We then denote by $\mathcal{C}^{k,j}$ the family of those dyadic squares L such that $L \subset \mathcal{A}_j$ and $\ell(L) = 2^{-j-k}$. Observe that, for each $j \geq 1, k \geq 2$, $\mathcal{C}^{k,j}$ is a covering of \mathcal{A}_j and that two elements of $\mathcal{C}^{k,j}$ can only intersect at their boundaries. Moreover, any element of $\mathcal{C}^{k,j}$ can intersect at most 8 other elements of $\mathcal{C}^{k,j}$. Finally, we set $\mathcal{C}^k := \bigcup_{j \geq 2} \mathcal{C}^{k,j}$. Observe now that \mathcal{C}^k covers a punctured neighborhood of 0 and that if $L \in \mathcal{C}^k$, then

- L intersects at most 9 other elements $J \in \mathcal{C}^k$;
- If $L \cap J \neq \emptyset$, then $\ell(J)/2 \leq \ell(L) \leq 2\ell(L)$ and $L \cap J$ is either a vertex or a side of the smallest among the two.

More in general if the intersection of two distinct elements L and J in $\mathcal{C} = \bigcup_k \mathcal{C}^k$ has nonempty interior, then one is contained in the other: if $L \subset J$ we then say that L is a descendant of J and J an ancestor of L . If in addition $\ell(L) = \ell(J)/2$, then we say that L

is a son of J and J is the father of L . When L and J intersect only at their boundaries, we then say that L and J are adjacent.

Next, for each dyadic square L we set $r_L := \sqrt{2}M_0\ell(L)$. Note that, by our choice of N_0 , we have that:

$$\text{if } L \in \mathcal{C}^{k,j} \text{ and } k \geq N_0, \text{ then } \mathbf{C}_{64r_L}(z_L) \subset \mathbf{C}_{2^{1-j}} \setminus \mathbf{C}_{2^{-2-j}}. \quad (3.5)$$

In particular $\mathbf{V}_{u,a} \cap \mathbf{C}_{64r_L}(z_L)$ consists of \bar{Q} connected components and we can select the one containing $(z_L, u(z_L, w_L))$, which we will denote by \mathbf{V}_L . We will then denote by T_L the current $T \llcorner \mathbf{V}_L$. According to Lemma 2.1, $\mathbf{V}_L \cap \{z_L\} \times \mathbb{R}^n$ contains at least one point of $\text{spt}(T)$: we select any such point and denote it by $p_L = (z_L, y_L)$. Correspondingly we will denote by \mathbf{B}_L the ball $\mathbf{B}_{64r_L}(p_L)$.

Definition 3.3. The height of a current S in a set E with respect to a plane π is given by

$$\mathbf{h}(S, E, \pi) := \sup\{|\mathbf{p}_\pi^\perp(p - q)| : p, q \in \text{spt}(S) \cap E\}. \quad (3.6)$$

If $E = \mathbf{C}_r(p, \pi)$ we will then set $\mathbf{h}(S, \mathbf{C}_r(p, \pi)) := \mathbf{h}(S, \mathbf{C}_r(p, \pi), \pi)$. If $E = \mathbf{B}_r(p)$, T is as in Assumption 1.1 and $p \in \Sigma$ (in the cases (a) and (c) of Definition 0.1), then $\mathbf{h}(T, \mathbf{B}_r(p)) := \mathbf{h}(T, \mathbf{B}_r(p), \pi)$ where π gives the minimal height among all π for which $\mathbf{E}(T, \mathbf{B}_r(p), \pi) = \mathbf{E}(T, \mathbf{B}_r(p))$ (and such that $\pi \subset T_p\Sigma$ in case (a) and (c) of Definition 0.1). Moreover, for such π we say that it optimizes the excess and the height in $\mathbf{B}_r(p)$.

We are now ready to define the dyadic decomposition of $\mathfrak{B} \setminus 0$.

Definition 3.4 (Refining procedure). We build inductively the families of squares $\mathcal{S}, \mathcal{W} = \mathcal{W}_e \cup \mathcal{W}_h \cup \mathcal{W}_n$ and their subfamilies $\mathcal{S}^k = \mathcal{S} \cap \mathcal{C}^k$, $\mathcal{S}^{k,j} = \mathcal{S} \cap \mathcal{C}^{k,j}$ and so on. First of all, we set $\mathcal{S}^k = \mathcal{W}^k = \emptyset$ for $k < N_0$. For $k \geq N_0$ we use a double induction. Having defined $\mathcal{S}^{k'}, \mathcal{W}^{k'}$ for all $k' < k$ and $\mathcal{S}^{k,j'}, \mathcal{W}^{k,j'}$ for all $j' < j$, we pick all squares L of $\mathcal{C}^{k,j}$ which do not have any ancestor already assigned to \mathcal{W} and we proceed as follows.

(EX) We assign L to $\mathcal{W}_e^{k,j}$ if

$$\mathbf{h}(T_L, \mathbf{B}_L) > C_e \mathbf{m}_0 \text{d}(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1}; \quad (3.7)$$

(HT) We assign L to $\mathcal{W}_h^{k,j}$ if we have not assigned it to \mathcal{W}_e and

$$\mathbf{h}(T_L, \mathbf{B}_L) > C_h \mathbf{m}_0^{1/4} \text{d}(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2}; \quad (3.8)$$

(NN) We assign L to $\mathcal{W}_n^{k,j}$ if we have not assigned it to $\mathcal{W}_e \cup \mathcal{W}_h$ and it intersects a square J already assigned to \mathcal{W} with $\ell(J) = 2\ell(L)$.

(S) We assign L to $\mathcal{S}^{k,j}$ if none of the above occurs.

We finally set

$$\Gamma := ([-1, 1]^2 \times \mathbb{R}^2) \cap \mathfrak{B} \setminus \bigcup_{L \in \mathcal{W}} L = \{0\} \cup \bigcap_{k \geq N_0} \bigcup_{L \in \mathcal{S}^k} L. \quad (3.9)$$

Proposition 3.5 (Whitney decomposition). *Let T , γ_0 , β_2 and δ_1 be as in the Assumptions 1.7, 2.2 and 3.1. If $M_0 \geq C$, $N_0 \geq C(M_0)$, $C_e, C_h \geq C(M_0, N_0)$ (for suitably large constants) and ε_2 is sufficiently small then:*

- (i) $\ell(L) \leq 2^{-N_0+1}|z_L| \forall L \in \mathcal{S} \cup \mathcal{W}$;

(ii) $\mathscr{W}^k = \emptyset$ for all $k \leq N_0 + 6$;

(iii) $\mathbf{\Gamma}$ is a closed set and $\text{sep}(\mathbf{\Gamma}, L) := \inf\{|x - x'| : x \in \mathbf{\Gamma}, x' \in L\} \geq 2\ell(L) \forall L \in \mathscr{W}$.

Moreover, the following estimates hold with $C = C(M_0, N_0, C_e, C_h)$:

$$\mathbf{E}(T_J, \mathbf{B}_J) \leq C_e \mathbf{m}_0 d(J)^{2\gamma_0 - 2 + 2\delta_1} \ell(J)^{2 - 2\delta_1} \quad \forall J \in \mathscr{S}, \quad (3.10)$$

$$\mathbf{h}(T_J, \mathbf{B}_J) \leq C_h \mathbf{m}_0^{1/4} d(J)^{\gamma_0/2 - \beta_2} \ell(J)^{1 + \beta_2} \quad \forall J \in \mathscr{S}, \quad (3.11)$$

$$\mathbf{E}(T_H, \mathbf{B}_H) \leq C \mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_1} \ell(H)^{2 - 2\delta_1} \quad \forall H \in \mathscr{W}, \quad (3.12)$$

$$\mathbf{h}(T_H, \mathbf{B}_H) \leq C \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2 - \beta_2} \ell(H)^{1 + \beta_2} \quad \forall H \in \mathscr{W}. \quad (3.13)$$

3.3. Approximating functions and construction algorithm. We will see below that in (a suitable portion of) each \mathbf{B}_L the current T_L can be approximated efficiently with a graph of a Lipschitz multiple-valued map. The average of the sheets of this approximating map will then be used as a local model for the center manifold.

Definition 3.6 (π -approximations). Let $L \in \mathscr{S} \cup \mathscr{W}$ and π be a 2-dimensional plane. If $T_L \lfloor \mathbf{C}_{32r_L}(p_L, \pi)$ fulfills the assumptions of [11, Theorem 1.5] in the cylinder $\mathbf{C}_{32r_L}(p_L, \pi)$, then the resulting map $f : B_{8r_L}(p_L, \pi) \rightarrow \mathcal{A}_Q(\pi^\perp)$ given by [11, Theorem 1.5] is a π -approximation of T_L in $\mathbf{C}_{8r_L}(p_L, \pi)$.

As in [9], we wish to find a suitable smoothing of the average of the π -approximation $\eta \circ f$. However the smoothing procedure is more complicated in the case (b) of Definition 0.1: rather than smoothing by convolution, we need to solve a suitable elliptic system of partial differential equations. This approach can in fact be used in cases (a) and (c) as well. In several instances regarding case (a) and (c) we will have to manipulate maps defined on some affine space $q + \pi$ and taking value on π^\perp , where $q \in \Sigma$ and $\pi \subset T_q \Sigma$. In such cases it is convenient to introduce the following conventions: the maps will be regarded as maps defined on π (requiring a simple translation by q), the space π^\perp will be decomposed into $\varkappa := \pi^\perp \cap T_q \Sigma$ and its orthogonal complement $T_q \Sigma^\perp$ and we will regard Ψ_q as a map defined on $\pi \times \varkappa$ and taking values in $T_q \Sigma^\perp$. Similarly, elements of π^\perp will be decomposed as $(\xi, \eta) \in \varkappa \times T_q \Sigma^\perp$.

Lemma 3.7. *Let the assumptions of Proposition 3.5 hold and assume $C_e \geq C^*$ and $C_h \geq C^* C_e$ for a suitably large $C^*(M_0, N_0)$. For each $L \in \mathscr{W} \cup \mathscr{S}$ we choose a plane π_L in \mathbf{B}_L which optimizes the excess and which, among all the ones optimizing the excess, also optimizes the height in \mathbf{B}_L . For any choice of the other parameters, if ε_2 is sufficiently small, then $T_L \lfloor \mathbf{C}_{32r_L}(p_L, \pi_L)$ satisfies the assumptions of [11, Theorem 1.5] for any $L \in \mathscr{W} \cup \mathscr{S}$.*

Indeed Lemma 3.7 is a corollary of the much more general Proposition 6.1 and we will not give a separate proof.

Definition 3.8 (Smoothing). Let L and π_L be as in Lemma 3.7 and denote by f_L the corresponding π_L -approximation. In case of Definition 0.1 (a)&(c) we let $\bar{f}(x) := \sum_i \llbracket \mathbf{p}_{T_{p_L} \Sigma}(f_i) \rrbracket$ be the projection of f_L on the tangent $T_{p_L} \Sigma$, whereas in the other case

(Definition 0.1(b)) we set $\bar{f} = f$. We let \bar{h}_L be a solution (provided it exists) of

$$\begin{cases} \mathcal{L}_L \bar{h}_L = \mathcal{F}_L \\ \bar{h}_L|_{\partial B_{8r_L}(p_L, \pi_L)} = \boldsymbol{\eta} \circ \bar{f}_L, \end{cases} \quad (3.14)$$

where \mathcal{L}_L is a suitable second order linear elliptic operator with constant coefficients and \mathcal{F}_L a suitable affine map: the precise expressions for \mathcal{L}_L and \mathcal{F}_L depend on a careful Taylor expansion of the first variations formulae and are given in Proposition 6.4. We then set $h_L(x) := (\bar{h}_L(x), \Psi_{p_L}(x, \bar{h}_L(x)))$ in case (a) and (c) and $h_L(x) = \bar{h}_L(x)$ in case (b). The map h_L is the *tilted interpolating function* relative to L .

In what follows we will deal with graphs of multivalued functions f in several system of coordinates. These objects can be naturally seen as currents \mathbf{G}_f (see [8]) and in this respect we will use extensively the notation and results of [8] (therefore $\text{Gr}(f)$ will denote the “set-theoretic” graph).

Lemma 3.9. *Let the assumptions of Proposition 3.5 hold and assume $C_e \geq C^*$ and $C_h \geq C^* C_e$ (where C^* is the constant of Lemma 3.7). For any choice of the other parameters, if ε_2 is sufficiently small the following holds. For any $L \in \mathcal{W} \cup \mathcal{S}$, there is a unique solution $\bar{h}_L : B_{8r_L}(p_L, \pi_L) \rightarrow \varkappa_L = \pi_L^\perp \cap T_{p_L} \Sigma$ of (3.14) and there is a smooth $g_L : B_{4r_L}(z_L, \pi_0) \rightarrow \pi_0^\perp$ such that $\mathbf{G}_{g_L} = \mathbf{G}_{\bar{h}_L} \llcorner \mathbf{C}_{4r_L}(p_L, \pi_0)$, where h_L is the tilted interpolating function of Definition 3.8. Using the charts introduced in Definition 1.3, the map g_L will be considered as defined on the ball $B_{4r_L}(z_L, w_L) \subset \mathfrak{B}$.*

The center manifold is defined by gluing together the maps g_L .

Definition 3.10 (Interpolating functions). The map g_L in Lemma 3.7 will be called the *L-interpolating function*. Fix next a $\vartheta \in C_c^\infty([-1, 1]^m, [0, 1])$ which is identically 1 on $[-1, 1]^m$. For each k let $\mathcal{P}^k := \mathcal{S}^k \cup \bigcup_{i=N_0}^k \mathcal{W}^i$ and for $L \in \mathcal{P}^k$ define $\vartheta_L((z, w)) := \vartheta(\frac{z-z_L}{\ell(L)})$. Set

$$\hat{\varphi}_j := \frac{\sum_{L \in \mathcal{P}^j} \vartheta_L g_L}{\sum_{L \in \mathcal{P}^j} \vartheta_L} \quad \text{on } \{(z, w) \in \mathfrak{B} : z \in [-1, 1]^2 \setminus \{0\}\} \quad (3.15)$$

and extend the map to 0 defining $\hat{\varphi}_j(0) = 0$. In case (b) of Definition 0.1 we set $\varphi_j := \hat{\varphi}_j$. In cases (a) and (c) we let $\bar{\varphi}_j(z, w)$ be the first \bar{n} components of $\hat{\varphi}_j(z, w)$ and define $\varphi_j(z, w) = (\bar{\varphi}_j(z, w), \Psi(z, \bar{\varphi}_j(z, w)))$. φ_j will be called the *glued interpolation* at step j .

We now come to the first main theorem, which yields the surface which we call “branched center manifold” (again notice that for $\bar{Q} = 1$ there is certainly no branching, since the surface is a classical $C^{1, \alpha}$ graph, but we keep nonetheless the same terminology). In the statement we will need to “enlarge” slightly dyadic squares: given $L \in \mathcal{C}$ let H be the dyadic square of $\mathbb{R}^2 = \mathbb{C}$ so that L is a connected component of $\mathfrak{B} \cap (H \times \mathbb{C})$. Given $\sqrt{2}\sigma < |z_L| = |z_H|$, we let H' be the closed euclidean square of \mathbb{R}^2 which has the same center as H and sides of length 2σ , parallel to the coordinate axes. The square L' concentric

to L and with sidelength $2\ell(L') = 2\sigma$ is then defined to be that connected component of $\mathfrak{B} \cap (H' \times \mathbb{C})$ which contains L .

Theorem 3.11. *Under the same assumptions of Lemma 3.7, the following holds provided ε_2 is sufficiently small.*

(i) For $\kappa := \beta_2/4$ and $C = C(M_0, N_0, C_e, C_h)$ we have (for all j)

$$|\varphi_j(z, w)| \leq C\mathbf{m}_0^{1/4}|z|^{1+\gamma_0/2} \quad \text{for all } (z, w) \quad (3.16)$$

$$|D^l \varphi_j(z, w)| \leq C\mathbf{m}_0^{1/2}|z|^{1+\gamma_0-l} \quad \text{for } l = 1, \dots, 3 \text{ and } (z, w) \neq 0 \quad (3.17)$$

$$[D^3 \varphi_j]_{\mathcal{A}_j, \kappa} \leq C\mathbf{m}_0^{1/2} 2^{2j}. \quad (3.18)$$

(ii) The sequence φ_j stabilizes on every square $L \in \mathscr{W}$: more precisely, if $L \in \mathscr{W}^i$ and H is the square concentric to L with $\ell(H) = \frac{9}{8}\ell(L)$, then $\varphi_k = \varphi_j$ on H for every $j, k \geq i+2$. Moreover there is an admissible smooth branching $\varphi : \mathfrak{B} \cap ([-1, 1]^2 \times \mathbb{C}) \rightarrow \mathbb{R}^n$ such that $\varphi_k \rightarrow \varphi$ uniformly on $\mathfrak{B} \cap ([-1, 1]^2 \times \mathbb{C})$ and in $C^3(\mathcal{A}_j)$ for every $j \geq 0$. Note in particular that φ coincides with g_L on a nonempty open subset of each $L \in \mathscr{W}$.

(iii) For some constant $C = C(M_0, N_0, C_e, C_h)$ and for $a' := b + \gamma_0 > b$ we have

$$|u(z, w) - \varphi(z, w)| \leq C\mathbf{m}_0^{1/2}|z|^{a'}. \quad (3.19)$$

Definition 3.12 (Center manifold, Whitney regions). The manifold $\mathcal{M} := \text{Gr}(\varphi)$, where φ is as in Theorem 3.11, is called a *branched center manifold for T relative to \mathbf{G}_u* . It is convenient to introduce the map $\Phi : \mathfrak{B} \cap ([-1, 1]^2 \times \mathbb{C}) \rightarrow \mathbb{R}^{2+n}$ given by $\Phi(z, w) = (z, \varphi(z, w))$. If we neglect the origin, Φ is then a classical (C^3) parametrization of \mathcal{M} . $\Phi(\Gamma)$ will be called the contact set. Moreover, to each $L \in \mathscr{W}$ we associate a *Whitney region* \mathcal{L} on \mathcal{M} as follows:

(WR) $\mathcal{L} := \Phi(H \cap ([-1, 1]^2 \times \mathbb{C}))$, where H is the square concentric to L with $\ell(H) = \frac{17}{16}\ell(L)$.

4. THE NORMAL APPROXIMATION

In what follows we assume that the conclusions of Theorem 3.11 apply and denote by \mathcal{M} the corresponding center manifold. For any Borel set $\mathcal{V} \subset \mathcal{M}$ we will denote by $|\mathcal{V}|$ its \mathcal{H}^2 -measure and will write $\int_{\mathcal{V}} f$ for the integral of f with respect to \mathcal{H}^2 . $\mathcal{B}_r(q)$ denotes the geodesic balls in \mathcal{M} . Moreover, we refer to [8] for all the relevant notation pertaining to the differentiation of (multiple valued) maps defined on \mathcal{M} , induced currents, differential geometric tensors and so on.

We next define the open set

$$(V) \mathbf{V} := \{(x, y) \in \mathbb{R}^2 \times \mathbb{R}^n : x \in [-1, 1]^2 \text{ and } |\varphi(x, w) - y| < c_s|x|^b/2\}.$$

\mathbf{V} is clearly a horned neighborhood of the graph of φ . By (1.3), Assumption 1.7 and Theorem 3.11 it is clear that the following corollary holds

Corollary 4.1. *Under the hypotheses of Theorem 3.11, there is $r > 0$ such that*

- (i) For every $x \in \mathbb{R}^2$ with $0 < |x| = 2\rho < 2r$, the set $\mathbf{C}_\rho(x) \cap \mathbf{V}$ consists of \bar{Q} distinct connected components and $\text{spt}(T) \cap \mathbf{C}_{3r} \subset \mathbf{V}$.
- (ii) There is a well-defined nearest point projection $\mathbf{p} : \mathbf{V} \cap \mathbf{C}_{4r} \rightarrow \text{Gr}(\varphi)$, which is a $C^{2,\kappa}$ map.
- (iii) For every $L \in \mathscr{W}$ with $d(L) \leq 2r$ and every $q \in L$ we have

$$\text{spt}(\langle T, \mathbf{p}, \Phi(q) \rangle) \subset \{y \in \mathbb{R}^{2+n} : |\Phi(q) - y| \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1+\beta_2}\}.$$
- (iv) $\langle T, \mathbf{p}, p \rangle = Q \llbracket p \rrbracket$ for every $p \in \Phi(\Gamma) \cap \mathbf{C}_{2r} \setminus \{0\}$.

The main goal of this paper is to couple the branched center manifold of Theorem 3.11 with a good map defined on \mathcal{M} and taking values in its normal bundle, which approximates accurately T in a neighborhood of the origin.

Definition 4.2 (\mathcal{M} -normal approximation). Let r be as in Corollary 4.1 and define

$$(U) \quad \mathbf{U} := \mathbf{p}^{-1}(\mathbf{C}_{2r} \cap \mathcal{M}).$$

An \mathcal{M} -normal approximation of T is given by a pair (\mathcal{K}, F) such that

- (A1) $F : \mathbf{C}_{2r} \cap \mathcal{M} \rightarrow \mathcal{A}_Q(\mathbf{U})$ is Lipschitz and takes the form $F(x) = \sum_i \llbracket x + N_i(x) \rrbracket$, with $N_i(x) \perp T_x \mathcal{M}$ and $x + N_i(x) \in \Sigma$ for every x and i .
- (A2) $\mathcal{K} \subset \mathcal{M}$ is closed, contains $\Phi(\Gamma \cap \mathbf{C}_{2r})$ and $\mathbf{T}_F \llcorner \mathbf{p}^{-1}(\mathcal{K}) = T \llcorner \mathbf{p}^{-1}(\mathcal{K})$.

The map $N = \sum_i \llbracket N_i \rrbracket : \mathcal{M} \cap \mathbf{C}_{2r} \rightarrow \mathcal{A}_Q(\mathbb{R}^{2+n})$ is the normal part of F .

In the definition above it is not required that the map F approximates efficiently the current outside the set $\Phi(\Gamma)$. However, all the maps constructed in this paper and used in the subsequent note [10] will approximate T with a high degree of accuracy in each Whitney region: such estimates are detailed in the next theorem. In order to simplify the notation, we will use $\|N|_{\mathcal{V}}\|_{C^0}$ (or $\|N|_{\mathcal{V}}\|_0$) to denote the number $\sup_{x \in \mathcal{V}} \mathcal{G}(N(x), Q \llbracket 0 \rrbracket) = \sup_{x \in \mathcal{V}} |N(x)|$.

Theorem 4.3 (Local estimates for the \mathcal{M} -normal approximation). *Let r be as in Corollary 4.1 and \mathbf{U} as in Definition 4.2. Then there is an \mathcal{M} -normal approximation (\mathcal{K}, F) such that the following estimates hold on every Whitney region \mathcal{L} associated to $L \in \mathscr{W}$ with $d(L) \leq r$:*

$$\text{Lip}(N|_{\mathcal{L}}) \leq C\mathbf{m}_0^{\beta_0} d(L)^{\beta_0 \gamma_0} \ell(L)^{\beta_0 \gamma_0} \quad \text{and} \quad \|N|_{\mathcal{L}}\|_{C^0} \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1+\beta_2}, \quad (4.1)$$

$$|\mathcal{L} \setminus \mathcal{K}| + \|\mathbf{T}_F - T\|(\mathbf{p}^{-1}(\mathcal{L})) \leq C\mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell(L)^{2+(1+\beta_0)(2-2\delta_1)}, \quad (4.2)$$

$$\int_{\mathcal{L}} |DN|^2 \leq C\mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{4-2\delta_1}. \quad (4.3)$$

Moreover, for every Borel $\mathcal{V} \subset \mathcal{L}$, we have

$$\begin{aligned} \int_{\mathcal{V}} |\eta \circ N| &\leq C\mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0 - 2 - \beta_2} \ell(L)^{5+\beta_2/4} \\ &\quad + C\mathbf{m}_0^{1/2+\beta_0} d(L)^{2\beta_0\gamma_0 + \gamma_0 - 1 - \beta_2} \ell(L)^{1+\beta_2} \int_{\mathcal{V}} \mathcal{G}(N, Q \llbracket \eta \circ N \rrbracket). \end{aligned} \quad (4.4)$$

The constant $C = C(M_0, N_0, C_e, C_h)$ does not depend on ε_2 .

4.1. Separation and splitting. We conclude this section with two theorems which allow us to estimate the sidelengths of the squares of type \mathscr{W}_h and \mathscr{W}_e . The squares in \mathscr{W}_n do not enjoy similar bounds, but they can be partitioned in families, each of which consists of squares sufficiently close to an element of \mathscr{W}_e .

Proposition 4.4 (Separation). *There is a dimensional constant $C^\sharp > 0$ with the following property. Assume the hypotheses of Theorem 4.3, and in addition $C_h^4 \geq C^\sharp C_e$. If ε_2 is sufficiently small, then the following conclusions hold for every $L \in \mathscr{W}_h$ with $d(L) \leq r$:*

- (S1) $\Theta(T_L, p) \leq Q - 1$ for every $p \in \mathbf{B}_{16r_L}(p_L)$.
- (S2) $L \cap H = \emptyset$ for every $H \in \mathscr{W}_n$ with $\ell(H) \leq \frac{1}{2}\ell(L)$.
- (S3) $\mathcal{G}(N(x), Q[\boldsymbol{\eta} \circ N(x)]) \geq \frac{1}{4}C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2} \quad \forall x \in \Phi(B_{8\ell(L)}(z_L, w_L))$.

A simple corollary of the previous proposition is the following.

Corollary 4.5 (Domains of influence). *For any $H \in \mathscr{W}_n$ there is a chain $L = L_0, \dots, L_r = H$ such that*

- (a) $L_0 \in \mathscr{W}_e$ and $L_k \in \mathscr{W}_n$ for all $k > 0$;
- (b) $L_k \cap L_{k-1} \neq \emptyset$ and $\ell(L_k) = \frac{\ell(L_{k-1})}{2}$ for all $k > 0$.

In particular $H \subset B_{3\sqrt{2}\ell(L)}(z_L, w_L)$.

We use this last corollary to partition \mathscr{W}_n .

Definition 4.6 (Domains of influence). We first fix an ordering of the squares in \mathscr{W}_e as $\{J_i\}_{i \in \mathbb{N}}$ so that their sidelengths do not increase. Then $H \in \mathscr{W}_n$ belongs to $\mathscr{W}_n(J_0)$ (the domain of influence of J_0) if there is a chain as in Corollary 4.5 with $L_0 = J_0$. Inductively, $\mathscr{W}_n(J_r)$ is the set of squares $H \in \mathscr{W}_n \setminus \cup_{i < r} \mathscr{W}_n(J_i)$ for which there is a chain as in Corollary 4.5 with $L_0 = J_r$.

Proposition 4.7 (Splitting). *There are positive constants $C_1, C_2(M_0), \bar{r}(M_0, N_0, C_e)$ such that, if $M_0 \geq C_1$, $C_e \geq C_2(M_0)$, if the hypotheses of Theorem 4.3 hold and ε_2 is chosen sufficiently small, then the following holds. If $L \in \mathscr{W}_e$ with $d(L) \leq \bar{r}$, $q \in \mathfrak{B}$ with $\text{dist}(L, q) \leq 4\sqrt{2}\ell(L)$ and $\Omega := \Phi(B_{\ell(L)/8}(q))$, then:*

$$C_e \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{4 - 2\delta_1} \leq \ell(L)^2 \mathbf{E}(T_L, \mathbf{B}_L) \leq C \int_{\Omega} |DN|^2, \quad (4.5)$$

$$\int_{\mathcal{L}} |DN|^2 \leq C \ell(L)^2 \mathbf{E}(T_L, \mathbf{B}_L) \leq C \ell(L)^{-2} \int_{\Omega} |N|^2, \quad (4.6)$$

where $C = C(M_0, N_0, C_e, C_h)$.

5. CENTER MANIFOLD CONSTRUCTION

5.1. Technical preliminaries. In this section we prove the two technical Lemmas 2.1 and 2.3.

Proof of Lemma 2.1. Consider $x_0 \in \pi_0$ with $2\rho = |x_0|$, a smooth C^2 function $\phi : B_\rho(x_0) \rightarrow \mathbb{R}^n$ and the open set $\mathbf{V}_\varrho := \{(x, y) : x \in B_{\rho/2}(x_0), |y - \phi(x)| < \varrho\}$. Recall that there

is a geometric constant C such that, if $\varrho \leq C/\|D^2\phi\|_{B_\rho(x_0)}$, then for each $p \in \mathbf{V}_\varrho$ there is a unique nearest point $\mathbf{P}(p) \in \text{Gr}(\phi)$ (which defines a C^1 map $\mathbf{P} : \mathbf{V}_\varrho \rightarrow \text{Gr}(\phi)$). In particular, if $\|D^2\phi\|_{B_\rho(x_0)} \leq C\rho^{\alpha-1}$, the existence of such point is guaranteed under the assumption that $\varrho \leq c\rho^{1-\alpha}$ (where c is a, possibly small but positive, constant). Consider now an admissible smooth branching $u : \mathfrak{B}_{\bar{Q}} \rightarrow \mathbb{R}^n$. If $\bar{Q} = 1$, the above discussion shows easily the existence of a well defined C^1 map $\mathbf{P} : \mathbf{V}_{u,a} \cap \mathbf{C}_{2r} \rightarrow \text{Gr}(u)$, provided r is sufficiently small. If $\bar{Q} > 1$, the same conclusion holds under the assumption that u is b -separated and $a > b > 1$. Indeed consider $p = (z, y) \in \mathbf{V}_{u,a}$ and $(z, w_i) \in \mathfrak{B}_{\bar{Q}}$ such that $|y - u(z, w_i)| \leq c_s|z|^a$. The assumptions of being well-separated implies easily that $|p - u(\zeta, \omega)| \geq c_s|z|^b$ whenever $\zeta \notin B_{|z|/2}(z, w_i)$ and thus we can argue locally on the sheet $\text{Gr}(u|_{B_{|z|/2}(z, w_i)})$.

Next, up to rescaling we can assume that \mathbf{P} is well-defined on $\mathbf{V}_{u,a} \cap \mathbf{C}_2$. The discussion before Lemma 2.1 applies now verbatim and we conclude that the unique tangent cone at 0 is $Q\bar{Q} \llbracket \pi_0 \rrbracket$.

To reach the other two conclusions of the Lemma we argue by contradiction: if they were wrong, then we would find a sequence of points $\{x_k\} \subset B_2(0) \setminus \{0\}$ converging to 0 for which one of the following two conditions hold:

- either $\{x_k\} \times \mathbb{R}^n$ contains a point $p_k \in \text{spt}(T)$ with $\Theta(p_k, T) \geq Q + 1$ (recall that the density of T is an integer at every point, cf. [13]);
- or one connected component Ω_k of $(\{x_k\} \times \mathbb{R}^n) \cap \mathbf{V}_{u,a}$ does not intersect $\text{spt}(T)$.

Set $2r_k := |x_k|$ and consider the connected component \mathbf{V}_k of $\mathbf{V}_{u,a} \cap \mathbf{C}_{r_k}(x_k)$ which contains p_k (in the first case) or Ω_k (in the second). Let $S_k := T_k \llcorner \mathbf{V}_k$ and let $q_k = (x_k, u(x_k, w_k))$ be such that $q_k \in \mathbf{V}_k$. Finally set $Z_k := (S_k)_{q_k, r_k}$. Observe that $\text{spt}(Z_k)$ is contained in a neighborhood of height Cr_k^{a-1} of π_0 and we therefore conclude that Z_k converges to a current Z which is an integer multiple of $\llbracket B_1(0) \rrbracket$. On the other hand, since

$$(\mathbf{P}_\# S_k) \llcorner \mathbf{C}_{r_k/2}(x_k) = Q\mathbf{G}_u \llcorner \mathbf{C}_{r_k/2}(x_k) \cap \mathbf{V}_k$$

for k large enough, we conclude that $Z = Q \llbracket B_1(0) \rrbracket$. Now, either $\text{spt}(Z_k) \cap (\{0\} \times \mathbb{R}^n)$ contains a point \bar{q}_k of multiplicity $Q+1$ or it is empty. By the constancy theorem $(\mathbf{p}_{\pi_0})_\# Z_k = Q_k \llbracket B_1(0) \rrbracket$ for some integer Q_k and, since $(\mathbf{p}_{\pi_0})_\# Z_k \rightarrow (\mathbf{p}_{\pi_0})_\# Z$, for k large enough we would have $(\mathbf{p}_{\pi_0})_\# Z_k = Q \llbracket B_1(0) \rrbracket$. This is then incompatible with the emptiness of $\text{spt}(Z_k) \cap (\{0\} \times \mathbb{R}^n) = \emptyset$ because $Q \geq 1$. As for the other alternative, we must have, by the almost minimality of Z_k (see [13])

$$\limsup_{k \rightarrow \infty} \|Z_k\|(\mathbf{B}_{1/2-|\bar{q}_k|}(\bar{q}_k)) \leq \lim_{k \rightarrow \infty} \|Z_k\|(\mathbf{B}_{1/2}(0)) = \frac{Q}{4}\omega_2.$$

Since $\bar{q}_k \rightarrow 0$, the almost monotonicity formula (see [13]) would imply $\Theta(\bar{q}_k, Z_k) \leq Q + o(1)$. \square

Proof of Lemma 2.3. Since $Q\bar{Q} \llbracket \pi_0 \rrbracket$ is tangent to T at 0, we obviously must have $T_0\Sigma \supset \pi_0$ and thus $T_0\Sigma = \mathbb{R}^{2+\bar{n}} \times \{0\}$ can be achieved suitably rotating the coordinates. To achieve the other two conclusions we scale Σ and intersect it with $\mathbf{C}_4(0, T_0\Sigma)$ to reach that $\Sigma \cap \mathbf{C}_4(0, T_0\Sigma)$ is the graph of some Ψ with very small C^{3, ε_0} norm. We can then extend Ψ outside $B_4(0, T_0\Sigma)$ without increasing the C^{3, ε_0} norm by more than a factor: this gives

(i) and (ii) and also shows that \mathbf{c} can be assumed smaller than ε_2 in case (a) and (c) of Definition 0.1. For the details we refer the reader to the proof of [9, Lemma 1.5]. The rest of the Lemma is a simple scaling argument. \square

5.2. Proof of Proposition 3.5. In this section we prove several estimates on the excess, height and tilting of planes π_L in the cubes $L \in \mathcal{W} \cup \mathcal{S}$. Proposition 3.5 will then be a simple corollary of these more general statements.

Proposition 5.1 (Tilting of optimal planes). *Let T be as in Assumptions 1.7 and 2.2 and assume the various parameters satisfy Assumption 3.1. If $C_e, C_h \geq C(M_0, N_0)$ and ε_2 is sufficiently small then:*

- (i) *The conclusions (i), (ii) and (iii) of Proposition 3.5 hold.*
- (ii) $\mathbf{B}_H \subset \mathbf{B}_L \subset \mathbf{B}_{d(L)/10}(p_L)$ and $T_H = T_L \llcorner \mathbf{V}_H$ for all $H, L \in \mathcal{W} \cup \mathcal{S}$ with $H \subset L$;

Moreover, if $H, L \in \mathcal{W} \cup \mathcal{S}$ and either $H \subset L$ or $H \cap L \neq \emptyset$ with $\frac{\ell(L)}{2} \leq \ell(H) \leq \ell(L)$, then the following holds, for $\bar{C} = \bar{C}(M_0, N_0, C_e)$ and $C = C(M_0, N_0, C_e, C_h)$:

- (iii) $d(L)/2 \leq d(H) \leq 2d(L)$ (and $d(L) = d(H)$ when $H \subset L$);
- (iv) $|\pi_H - \pi_L| \leq \bar{C} \mathbf{m}_0^{1/2} d(L)^{\gamma_0 - 1 + \delta_1} \ell(L)^{1 - \delta_1}$;
- (v) $|\pi_H - \pi_0| \leq \bar{C} \mathbf{m}_0^{1/2} d(H)^{\gamma_0}$;
- (vi) $\mathbf{h}(T_H, \mathbf{C}_{36r_H}(p_H, \pi_0)) \leq C \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2} \ell(H)$ and $\text{spt}(T_H) \cap \mathbf{C}_{36r_H}(p_H, \pi_0) \subset \mathbf{B}_H$;
- (vii) $\mathbf{h}(T_L, \mathbf{C}_{36r_L}(p_L, \pi_H)) \leq C \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2}$ and $\text{spt}(T_L) \cap \mathbf{C}_{36r_L}(p_L, \pi_H) \subset \mathbf{B}_L$.

In particular, the estimates (3.12) and (3.13) hold.

The proof of the proposition will use repeatedly a few elementary observations concerning the excess and the height, which we collect in the following lemma.

Lemma 5.2. *If T is as in Proposition 5.1 there is a geometric constant C_0 with the following properties. Assume the points p, q belong to $\text{spt}(T) \cap \mathbf{C}_{\sqrt{2}}$, $\mathbf{B}_r(p) \subset \mathbf{B}_\rho(q) \subset \mathbf{C}_2$ and $r \geq \rho/4$. Then, if $\varepsilon_2 \leq C_0^{-1}$*

- (i) $\mathbf{E}(T, \mathbf{B}_\rho(q)) \leq C_0 \min_\tau \mathbf{E}(T, \mathbf{B}_\rho(q), \tau) + C_0 \mathbf{m}_0 \rho^2$;
- (ii) $\mathbf{E}(T, \mathbf{B}_r(p)) \leq C_0 \mathbf{E}(T, \mathbf{B}_\rho(q)) + C_0 \mathbf{m}_0 r^2$;
- (iii) $|\pi - \tau|^2 \leq C_0 [\mathbf{E}(T, \mathbf{B}_r(p), \pi) + \mathbf{E}(T, \mathbf{B}_\rho(q), \tau)]$;
- (iv) $\mathbf{h}(T, F, \pi) \leq \mathbf{h}(T, F, \tau) + C_0 |\pi - \tau| \text{diam}(\text{spt}(T) \cap F)$ for any set F ;
- (v) $\mathbf{h}(T, \mathbf{C}_r(0, \pi)) \leq C_0 \mathbf{m}_0^{1/2} r^{1 + \gamma_0} + C_0 |\pi - \pi_0| r$ whenever $|\pi - \pi_0| \leq C_0^{-1}$ and $r < 7/4$.

Proof. Recall that, by Lemma A.1 and Allard's monotonicity formula (which can be applied by [13, Proposition 1.2]), we have

$$\frac{3\omega_2}{4} \rho^2 \leq \|T\|(\mathbf{B}_\rho(p)) \leq C_0 \rho^2. \quad (5.1)$$

(i) is trivial in (b) of Definition 0.1, since $\mathbf{E}(T, \mathbf{B}_\rho(q)) = \min_\tau \mathbf{E}(T, \mathbf{B}_\rho(q), \tau)$. In the cases (a) and (c) recall that

$$\mathbf{E}(T, \mathbf{B}_\rho(q)) = \min_{\tau \subset T_q \Sigma} \mathbf{E}(T, \mathbf{B}_\rho(q), \tau).$$

Let now π be such that $\mathbf{E}(T, \mathbf{B}_\rho(q), \pi) = \min_\tau \mathbf{E}(T, \mathbf{B}_\rho(q), \tau) =: E$. Then, by the Chebyhev inequality there is a point $q' \in \mathbf{B}_\rho(q) \cap \text{spt}(T)$ such that

$$|\vec{T}(q') - \vec{\pi}|^2 \leq \frac{\omega_2 \rho^2}{\|T\|(\mathbf{B}_\rho(q))} E \leq C_0 E.$$

Observe that $\vec{T}(q')$ is the orienting 2-vector of some space $\xi \subset T_{q'}\Sigma$ and that

$$|T_{q'}\Sigma - T_q\Sigma|^2 \leq C_0 \|A_\Sigma\|_{C^0}^2 \rho^2 \leq C_0 \mathbf{m}_0 \rho^2.$$

Thus there is a 2-plane $\tau \subset T_q\Sigma$ such that $|\tau - \pi|^2 \leq C_0 E + C_0 \mathbf{m}_0 \rho^2$. Hence

$$\mathbf{E}(T, \mathbf{B}_\rho(p)) \leq \mathbf{E}(T, \mathbf{B}_\rho(q), \tau) \leq C_0 (E + C_0 \mathbf{m}_0 \rho^2) \|T\|(\mathbf{B}_\rho(q)) / (\omega_2 \rho^2) \leq C_0 E + C_0 \mathbf{m}_0 \rho^2.$$

Keeping the notation of the argument above, in the case (b) of Definition 0.1 statement (ii) follows from the simple observation

$$\mathbf{E}(T, \mathbf{B}_r(p)) \leq \mathbf{E}(T, \mathbf{B}_r(p), \pi) \leq 4^2 \mathbf{E}(T, \mathbf{B}_\rho(q), \pi) = 16 \mathbf{E}(T, \mathbf{B}_\rho(q)).$$

In the cases (a) and (c) of Definition 0.1 we combine the same idea with (i).

(iii) is a simple consequence of

$$\begin{aligned} |\pi - \tau|^2 &\leq \frac{2}{\|T\|(\mathbf{B}_\rho(q))} \int_{\mathbf{B}_\rho(q)} (|\vec{T} - \vec{\pi}|^2 + |\vec{\tau} - \vec{T}|^2) d\|T\| \\ &\stackrel{(5.1)}{\leq} C_0 (\mathbf{E}(T, \mathbf{B}_\rho(q), \pi) + \mathbf{E}(T, \mathbf{B}_\rho(q), \tau)), \end{aligned} \quad (5.2)$$

and $\mathbf{E}(T, \mathbf{B}_\rho(q), \pi) \leq 16 \mathbf{E}(T, \mathbf{B}_r(p), \pi)$. Next, for $p, q \in \text{spt}(T) \cap F$ we compute

$$|\mathbf{p}_\pi^\perp(p - q)| \leq |\mathbf{p}_\tau^\perp(p - q)| + |(\mathbf{p}_\tau^\perp - \mathbf{p}_\pi^\perp)(p - q)| \leq \mathbf{h}(T, F, \tau) + C|\pi - \tau||p - q|.$$

Taking the supremum over $p, q \in F \cap \text{spt}(T)$ we reach (iv).

We finally argue for (v). Fix $r < 7/8$, π with $|\pi - \pi_0| \leq C_0^{-1}$ and the cylinder $\mathbf{C} := \mathbf{C}_r(0, \pi)$. Observe that, by Assumption 1.7, for every $p = (x, y) \in \text{spt}(T) \cap (\mathbb{R}^2 \times \mathbb{R}^n)$ we have $|y| \leq \varepsilon_2^{1/2} |x|^{1+\alpha} \leq \varepsilon_2^{1/2} |x|^{1+\gamma_0}$. It follows easily that, for C_0 sufficiently large and ε_2 sufficiently small, this implies that $\text{spt}(T) \cap \mathbf{C} \subset \mathbf{C}_{8r/7}(0, \pi_0)$. Hence, $\mathbf{h}(T, \mathbf{C}, \pi_0) \leq \mathbf{h}(T, \mathbf{C}_{8r/7}(0, \pi_0)) \leq C_0 \mathbf{m}_0^{1/2} r^{1+\gamma_0}$. As a consequence $\text{diam}(T \cap \mathbf{C}) \leq C_0 r$ and (v) follows from (iv). \square

Proof of Proposition 5.1. In this proof we will use the following convention: geometric constants will be denoted by C_0 or c_0 , constants depending upon M_0, N_0, C_e will be denoted by \bar{C} or \bar{c} and constants depending upon M_0, N_0, C_e and C_h will be denoted by C or c . Next observe that the second inclusion in (ii) is in fact correct for any cube $L \in \mathcal{C}^j$ with $j \geq N_0$, provided N_0 is chosen sufficiently large compared to M_0 . (iii) is instead an obvious consequence of the construction.

Proof of (i), (ii) and (iii) in Proposition 3.5. The conclusion (i) is obvious since indeed it also holds for every $L \in \mathcal{C}^{N_0}$. (iii) is a simple consequence of the fact that, because of (NN) in the refining procedure, given any pair $H, L \in \mathcal{W}$ with nonempty intersection, $\frac{1}{2}\ell(H) \leq \ell(L) \leq 2\ell(H)$. Consider now any $L \in \mathcal{C}^j$ with $N_0 \leq j \leq N_0 + 6$. Observe first that $2^{-N_0-10}d(L) \leq \ell(L) \leq 2^{-N_0}d(L)$. Consider now the point $p \in \text{Gr}(u)$ which has the

same projection onto π_0 as p_L (namely z_L) and which is closest to p_L . Recall that $\pi(p)$ is the tangent to $\text{Gr}(u)$ in p . We thus can use (1.9) to estimate

$$\mathbf{E}(T_L, \mathbf{B}_L, \pi(p)) \leq \mathbf{E}(T, \mathbf{B}_{|z_L|/4}(p)) \leq C(M_0, N_0) \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1}. \quad (5.3)$$

In order to derive the latter inequality we need that $\mathbf{B}_L \subset \mathbf{B}_{|z_L|/4}(p)$. Since $|z_L|$ is comparable, up to a geometric constant, to $d(L)$, whereas the radius r_L equals $64\sqrt{2}M_0\ell(L)$ and is comparable, up to a geometric constant, to $M_02^{-N_0}d(L)$, we just need to choose N_0 sufficiently large compared to M_0 .

By Lemma 5.2(i), from (5.3) we conclude

$$\mathbf{E}(T_L, \mathbf{B}_L) \leq C(M_0, N_0) \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1} + C(M_0) \mathbf{m}_0 \ell(L)^2.$$

Hence, for C_e sufficiently large, condition (EX) of Definition 3.4 cannot be a reason to stop the refining procedure of any cube $L \in \mathcal{C}^j$ when $N_0 \leq j \leq N_0 + 6$.

Recall next the chosen plane π_L such that $\mathbf{E}(T_L, \mathbf{B}_L, \pi_L) = \mathbf{E}(T_L, \mathbf{B}_L)$ and $\mathbf{h}(T_L, \mathbf{B}_L) = \mathbf{h}(T_L, \mathbf{B}_L, \pi_L)$. By Lemma 5.2(iii) we easily conclude that

$$|\pi_L - \pi(p)| \leq C(M_0, N_0) C_e^{1/2} \mathbf{m}_0^{1/2} d(L)^{\gamma_0}.$$

On the other hand $|\pi(p) - \pi_0| \leq C_0 [Du]_{0, \alpha, B_{C_0 d(L)}} d(L)^\alpha \leq C_0 \mathbf{m}_0^{1/2} d(L)^{\gamma_0}$ and thus

$$|\pi_L - \pi_0| \leq C(M_0, N_0) C_e^{1/2} \mathbf{m}_0^{1/2} d(L)^{\gamma_0} \quad \forall L \in \mathcal{C}^{N_0}. \quad (5.4)$$

Setting $\rho := (2\sqrt{2} + 1/10)d(L)$ we have

$$\mathbf{B}_L \subset \mathbf{C}_{d(L)/10}(p_L, \pi_0) \subset \mathbf{C}_\rho(0, \pi_0).$$

Note that $\rho \leq (2\sqrt{2} + \frac{1}{10})\frac{1}{2} \leq \frac{3}{2}$ and we can apply Lemma 5.2(v) to conclude

$$\mathbf{h}(T, \mathbf{B}_L, \pi_0) \leq \mathbf{h}(T, \mathbf{C}_\rho(0, \pi_0), \pi_0) \leq C_0 \mathbf{m}_0^{1/2} d(L)^{1 + \gamma_0}. \quad (5.5)$$

In particular $\text{diam spt}(T) \cap \mathbf{B}_L \leq d(L)$, provided ε_2 is small enough. We can therefore apply Lemma 5.2(iv) and use (5.4) and (5.5) to infer

$$\mathbf{h}(T_L, \mathbf{B}_L) \leq \bar{C} \mathbf{m}_0^{1/2} d(L)^{1 + \gamma_0} \leq \bar{C} \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2}.$$

Thus, choosing C_h large depending upon M_0, N_0 and C_e , we conclude that condition (HT) in Definition 3.4 cannot be a reason to stop the refining procedure of a cube $L \in \mathcal{C}^j$ when $N_0 \leq j \leq N_0 + 6$.

This means that: for $k = N_0$ and $j = 0$ all cubes of $\mathcal{C}^{N_0, 0}$ are assigned to \mathcal{S} and refined at the subsequent step (the condition (NN) is empty here). But then the same happens for $k = N_0$ and $j = 1$, since $\mathcal{W}^{N_0, 0}$ is empty. Proceeding inductively we conclude this for every j and thus obtain that \mathcal{W}^{N_0} is empty. We now repeat the argument with $\mathcal{W}^{N_0+1, j}$ to conclude that \mathcal{W}^{N_0+1} is also empty. Proceeding for other 5 steps we conclude then that (ii) holds.

Proof of (ii)-(iv)-(v)-(vi)-(vii) when $H \subset L$. The proof is by induction over i , where $H \in \mathcal{C}^i$. We thus prove first the claims when $i = N_0$. Under this assumption $H = L$ and hence (iv) is trivial. The second inclusion in (ii) has already been proved above and the remaining assertions of (ii) are obvious because $H = L$. (v) has been shown above, cf. (5.4).

The first conclusion in (vi) follows easily, since $\mathbf{h}(T_H, \mathbf{C}_{36r_H}(p_H, \pi_0)) \leq C_0 \mathbf{m}_0^{1/2} d(H)^{1+\gamma_0}$ by Lemma 5.2(v) and $\ell(H) \geq d(H)/C(N_0)$. The inclusion in (vi) follows then trivially from this bound when $\mathbf{m}_0 \leq \varepsilon_2$ is small enough, because $p_H \in \text{spt}(T_H)$. As for (vii), recall that $L = H$ in our case. First observe that $|\pi_H - \pi_0| \leq C_0 C_e d(L)^{\gamma_0}$, simply by (5.4) (assuming $C_e \geq C(M_0, N_0)$). Thus we can apply Lemma 5.2(iv)&(v): since $d(L)$ and $\ell(L)$ are comparable up to a constant $C(N_0)$, we conclude that $\mathbf{h}(T_L, \mathbf{C}_{36r_L}(p_L, \pi_H)) \leq C \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1+\beta_2}$. As we already argued for (vi), the inclusion is a consequence of the bound.

We now pass to the inductive step. Thus fix some $H_{i+1} \in \mathcal{S}^{i+1} \cup \mathcal{W}^{i+1}$ and consider a chain $H_{i+1} \subset H_i \subset \dots \subset H_{N_0}$ with $H_l \in \mathcal{S}^l$ for $l \leq i$. We wish to prove all the conclusions (ii)-(iv)-(v)-(vi)-(vii) when $H = H_{i+1}$ and $L = H_j$ for some $j \leq i+1$, recalling that, by inductive assumption, all the statements hold when $H = H_k$ and $L = H_l$ for $l \leq k \leq i$. Note also that $d(H_k) = d(H_{i+1})$ for all k .

With regard to (ii), it is enough to prove that $\mathbf{B}_{H_{i+1}} \subset \mathbf{B}_{H_i}$ and $\mathbf{V}_{H_{i+1}} \subset \mathbf{V}_{H_i}$. Note that $|z_{H_i} - z_{H_{i+1}}| \leq 2\sqrt{2}\ell(H_i)$ (recall the notation $p_H = (z_H, y_H)$). In particular notice that $\mathbf{C}_{r_{H_{i+1}}}(p_{H_{i+1}}, \pi_0) \subset \mathbf{C}_{r_{H_i}}(p_{H_i}, \pi_0)$. Recall the open sets \mathbf{V}_{H_i} and $\mathbf{V}_{H_{i+1}}$ defined in Section 3.2. Since H_i and H_{i+1} are nearby cubes in \mathfrak{B} , it is clear that the points $(z_{H_{i+1}}, u(z_{H_{i+1}}, w_{H_{i+1}}))$ and $(z_{H_i}, u(z_{H_i}, w_{H_i}))$ must be in the same connected component of $\mathbf{V}_{u,a} \cap \mathbf{C}_{r_{H_i}}(p_{H_i}, \pi_0)$. It then follows that $\mathbf{V}_{H_{i+1}} \subset \mathbf{V}_{H_i}$. In particular $p_{H_{i+1}} \in \text{spt}(T_{H_i})$ and (vi) applied to $H = H_i$ implies then that $|p_{H_{i+1}} - p_{H_i}| \leq 2(\sqrt{2} + C \mathbf{m}_0^{1/4})\ell(H_i)$. In particular, assuming that $\varepsilon_2 \leq c$ for some positive constant $c = c(M_0, N_0, C_e, C_h)$, we conclude $|p_{H_{i+1}} - p_{H_i}| \leq 3\sqrt{2}\ell(H_i)$ and $\mathbf{B}_{H_{i+1}} \subset \mathbf{B}_{H_i}$ follows from the fact that M_0 is assumed larger than a suitable geometric constant.

We now come to (iv). Recall that H_i belongs to \mathcal{S} (indeed H_{i+1} is a son of H_i). Hence, from the inclusion $\mathbf{B}_{H_{i+1}} \subset \mathbf{B}_{H_i}$, from the identity $T_{H_{i+1}} = T_{H_i} \lfloor \mathbf{B}_{H_{i+1}}$ and from Lemma 5.2(ii) we easily infer that

$$\mathbf{E}(T_{H_{i+1}}, \mathbf{B}_{H_{i+1}}) \leq C_0 \mathbf{E}(T_{H_i}, \mathbf{B}_{H_i}) + C_0 \mathbf{m}_0 \ell(H_{i+1})^2 \leq \bar{C} \mathbf{m}_0 d(H_{i+1})^{2\gamma_0 - 2 + 2\delta_1} \ell(H_{i+1})^{2-2\delta_1}.$$

We thus have, from Lemma 5.2(iii),

$$|\pi_{H_i} - \pi_{H_{i+1}}| \leq \bar{C} \mathbf{m}_0^{1/2} d(H_{i+1})^{\gamma_0 - 1 + \delta_1} \ell(H_{i+1})^{1-\delta_1}.$$

On the other hand, since $d(H_l) = d(H_j)$ for every $l \geq j$, by the same argument with l in place of i we also get

$$|\pi_{H_l} - \pi_{H_{l+1}}| \leq \bar{C} \mathbf{m}_0^{1/2} d(H_{l+1})^{\gamma_0 - 1 + \delta_1} \ell(H_{l+1})^{1-\delta_1}.$$

Summing the latter estimates for l between i and j , we easily reach (iv) for $H = H_{i+1}$ and $L = H_j$.

As for (v), note that it holds for H_{N_0} and moreover we just proved (iv) for $H = H_{i+1}$ and $L = H_{N_0}$, and thus, by triangular inequality, we get (v) (with a constant independent of the index i !).

As for (vi), note first that $\text{spt}(T_{H_{i+1}}) \cap \mathbf{C}_{36r_{H_{i+1}}}(p_{H_{i+1}}, \pi_0) \subset \text{spt}(T_{H_i}) \cap \mathbf{C}_{36r_{H_i}}(p_{H_i}, \pi_0) \subset \mathbf{B}_{H_i}$ (the latter because (vi) holds for $H = H_i$ by inductive hypothesis). Thus we can apply

Lemma 5.2(iv) to conclude

$$\mathbf{h}(T_{H_{i+1}}, \mathbf{C}_{36r_{H_{i+1}}}(p_{H_{i+1}}, \pi_0)) \leq C\mathbf{h}(T_{H_i}, \mathbf{B}_{H_i}) + C_0|\pi_{H_i} - \pi_0| \text{diam}(\text{spt}(T_{H_i}) \cap \mathbf{B}_{H_i}).$$

On the other hand we already noticed that $H_i \in \mathcal{S}$. Taking into account (v) we then conclude the inequality of (vi) for $H = H_{i+1}$ and, as already noticed in other cases, the inclusion follows from the estimate and $p_{H_{i+1}} \in \mathbf{B}_{H_{i+1}} \cap \text{spt}(T_{H_{i+1}})$.

We finally come to (vii). Fix $H = H_{i+1}$. First we prove it for $L = H_{N_0}$. Observe that by the bound from (iv) on $|\pi_H - \pi_0|$, we can bound $\mathbf{h}(T_{H_{N_0}}, \mathbf{C}_{36r_{H_{N_0}}}(p_{H_{N_0}}, \pi_H))$ with the same argument used for $\mathbf{h}(T_{H_{N_0}}, \mathbf{C}_{36r_{H_{N_0}}}(p_{H_{N_0}}, \pi_{H_{N_0}}))$. As already argued several times, we then conclude the inclusion $\text{spt}(T_{H_{N_0}}) \cap \mathbf{C}_{36r_{H_{N_0}}}(p_{H_{N_0}}, \pi_H) \subset \mathbf{B}_{H_{N_0}}$. We now argue inductively on j : assuming that we know (vii) for H and $L = H_j$, we now wish to conclude it for $L = H_{j+1}$. Notice that $\mathbf{C}_{36r_{H_{j+1}}}(p_{H_{j+1}}, \pi_H) \subset \mathbf{C}_{36r_{H_j}}(p_{H_j}, \pi_H)$. Then the inductive assumption gives $\text{spt}(T_{H_j}) \cap \mathbf{C}_{36r_{H_{j+1}}}(p_{H_{j+1}}, \pi_H) \subset \mathbf{B}_{H_j}$ and recalling that $T_{H_{j+1}} = T_{H_j} \lfloor \mathbf{B}_{H_{j+1}}$ and that $H_j \in \mathcal{S}$, we can use Lemma 5.2(iv) to bound

$$\mathbf{h}(T_{H_{j+1}}, \mathbf{C}_{36r_{H_{j+1}}}(p_{H_{j+1}}, \pi_H)) \leq \mathbf{h}(T_{H_j}, \mathbf{B}_{H_j}) + C_0|\pi_H - \pi_{H_j}| \text{diam}(\text{spt}(T_{H_j}) \cap \mathbf{B}_{H_j}).$$

However, having already shown (iv), this easily shows the bound in (vii). The inclusion then follows with the usual argument used above.

Proof of (3.12) and (3.13). Fix $H \in \mathcal{W}$ and let L be its father (recall Proposition 3.5(ii)). Having shown (ii), we know that $\mathbf{B}_H \subset \mathbf{B}_L$. We then use $d(L) = d(H)$, $\ell(L) = 2\ell(H)$, and $L \in \mathcal{S}$ to estimate

$$\mathbf{E}(T_L, \mathbf{B}_L) \leq C_e \mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_1} \ell(H)^{2 - 2\delta_1}$$

and Lemma 5.2(i) to conclude (3.12) as follows

$$\begin{aligned} \mathbf{E}(T_H, \mathbf{B}_H) &\leq C_0 \mathbf{E}(T_H, \mathbf{B}_H, \pi_L) + \bar{C} \mathbf{m}_0 r_L^2 \leq \bar{C} \mathbf{E}(T_L, \mathbf{B}_L) + \bar{C} \mathbf{m}_0 \ell(H)^2 \\ &\leq \bar{C} \mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1} \end{aligned}$$

Next, we use Lemma 5.2, (iv) and

$$\mathbf{h}(T_L, \mathbf{B}_L) \leq C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2}$$

to conclude (3.13).

Proof of (iv) and (vii) when H and L are neighbors. Without loss of generality assume $\ell(L) \geq \ell(H)$. If $L \notin \mathcal{C}^{N_0}$, then let J be the father of L (and observe that it belongs to \mathcal{S}). Observe that $|z_H - z_J|, |z_L - z_J| \leq 2\sqrt{2}\ell(J)$. On the other hand, observe that p_H, p_L are both elements of $\mathbf{C}_{36r_J}(p_J, \pi_0)$ (provided M_0 is larger than a geometric constant). Thus, by (vi) (applied to J), for ε_2 sufficiently small we easily conclude $|p_H - p_J|, |p_L - p_J| \leq 3\sqrt{2}\ell(J)$. Since $\ell(L), \ell(H) \leq \ell(J)/2$, again assuming that M_0 is larger than a geometric constant we have the inclusion $\mathbf{B}_H \cup \mathbf{B}_L \subset \mathbf{B}_J$. It is also easy to see that $\mathbf{V}_H \cup \mathbf{V}_L \subset \mathbf{V}_J$. Now, we can use (3.10), (3.12) and (iii) to achieve

$$|\pi_H - \pi_J|, |\pi_L - \pi_J| \leq \bar{C} \mathbf{m}_0^{1/2} d(J)^{\gamma_0 - 1 + \delta_1} \ell(J)^{1 - \delta_1}.$$

Next we use again (iii), the triangle inequality and $\ell(H) \leq \ell(L) \leq \ell(J) \leq 4\ell(H)$ to show (iv). The case $L \in \mathcal{C}^{N_0}$ can be handled similarly, just using a ball concentric to \mathbf{B}_L and slightly larger so to include \mathbf{B}_H : the excess and the height in this ball is then estimated with the same argument used for estimating them in \mathbf{B}_L .

As for (vii) we fix a chain of ancestors $L = L_j, L_{j-1}, \dots, L_i, \dots, L_{N_0}$ and, as in the proof of (vii) for the case $H \subset L$, we argue inductively over i . The argument is precisely the same and can be applied because, using (iv) for H and L and for L_i and L_{i+1} , we can sum the corresponding estimate to show that

$$|\pi_H - \pi_{L_i}| \leq \bar{C} \mathbf{m}_0^{1/2} d(L_i)^{\gamma_0 - 1 + \delta_1} \ell(L_i)^{1 - \delta_1}. \quad \square$$

6. π -APPROXIMATIONS AND ELLIPTIC REGULARIZATIONS

In this section we introduce the π -approximations and define the corresponding elliptic regularizations of their averages, which in turn will be the building blocks of the center manifold. We begin with the following:

Proposition 6.1. *Assume the hypotheses and the conclusions of Proposition 5.1 apply and let ε_2 be sufficiently small. If $H, L \in \mathcal{W} \cup \mathcal{S}$ and either $H \subset L$ or $H \cap L \neq \emptyset$ with $\frac{\ell(L)}{2} \leq \ell(H) \leq \ell(L)$, then*

$$(\mathbf{p}_{\pi_H})_{\sharp}(T_L \llcorner \mathbf{C}_{32r_L}(p_L, \pi_H)) = Q \llbracket B_{32r_L}(\mathbf{p}_{\pi_H}(p_L), \pi_H) \rrbracket, \quad (6.1)$$

$$\partial T_L \llcorner \mathbf{C}_{32r_L}(p_L, \pi_H) = 0. \quad (6.2)$$

Moreover

$$\mathbf{E}(T_L, \mathbf{C}_{32r_L}(p_L, \pi_H)) \leq \bar{C} \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1} \quad (6.3)$$

and hence [11, Theorem 1.5] applies to the current $T_L \llcorner \mathbf{C}_{32r_L}(p_L, \pi_H)$ in $\mathbf{C}_{32r_L}(p_L, \pi_H)$.

Proof. (6.2) is rather straightforward: by the height estimate in Proposition 5.1(vii) we conclude easily $\text{spt}(T_L) \cap \mathbf{C}_{32r_L}(p_L, \pi_H) \subset \mathbf{C}_{36r_L}(p_L, \pi_0)$. On the other hand by definition of $T_L = T \llcorner \mathbf{V}_L$ and by Assumption 1.7(Hor), we have $\text{spt}(\partial T_L) \subset \partial \mathbf{C}_{64r_L}(p_L, \pi_0)$, implying $\text{spt}(\partial T_L) \cap \mathbf{C}_{36r_L}(p_L, \pi_0) = \emptyset$ and thus also $\text{spt}(\partial T_L) \cap \mathbf{C}_{32r_L}(p_L, \pi_H) = \emptyset$.

In order to prove (6.1) we argue as follows. First consider the chain of ancestors of $L := L = L_j \subset L_{j-1} \subset \dots \subset L_{N_0} =: J$, where $J \in \mathcal{S}^{N_0}$. We first show that $(\mathbf{p}_{\pi_0})_{\sharp}(T_J \llcorner \mathbf{C}_{36r_J}(p_J, \pi_0)) = Q \llbracket B_{36r_J}(z_J, \pi_0) \rrbracket$. This is done in the following way: consider that $\text{Gr}(u) \cap \mathbf{C}_{64r_J}(p_J, \pi_0)$ is the graph of a $C^{1,\alpha}$ function v with $\|v\|_{C^{1,\alpha}} \leq C_0 \mathbf{m}_0^{1/2}$. Define the function $v_t(x) := tv(x)$ and let \mathbf{p}_t be the orthogonal projection onto $\text{Gr}(v_t)$, which is well-defined on \mathbf{V}_J provided \mathbf{m}_0 is sufficiently small (the smallness being independent of J). The currents $S_t := (\mathbf{p}_t)_{\sharp}(T_J \llcorner \mathbf{C}_{64r_J}(p_J, \pi_0))$ are easily seen to coincide with $Q_t \mathbf{G}_v \llcorner \mathbf{C}_{36r_J}(z_J, \pi_0)$ for some integers Q_t in the cylinder $\mathbf{C}_{36r_J}(p_J, \pi_0)$ by the constancy theorem. On the other hand such currents vary continuously and thus the integer Q_t must be constant. This implies that $Q_0 = Q_1 = Q$. On the other hand $\mathbf{p}_0 = \mathbf{p}_{\pi_0}$ and we have thus proved our claim.

Observe that $(\mathbf{p}_{\pi_0})_{\sharp}(T_L \llcorner \mathbf{C}_{36r_L}(p_L, \pi_0)) = Q \llbracket B_{36r_L}(z_L, \pi_0) \rrbracket$ because $T_L \llcorner \mathbf{C}_{36r_L}(p_L, \pi_0) = T_J \llcorner \mathbf{C}_{36r_L}(p_L, \pi_0)$. Choose next a continuous path of planes π_t which connects π_0 and π_H and satisfies the bound $|\pi_t - \pi_0| \leq C_0 |\pi_H - \pi_0|$ for some geometric constant C_0 . We then

look at $Z_t = (\mathbf{p}_{\pi_t})_{\sharp}(T_L \sqcup \mathbf{C}_{36r_L}(p_L, \pi_0))$ and conclude, similarly to the previous paragraph, that $((\mathbf{p}_{\pi_H})_{\sharp}(T_L \sqcup \mathbf{C}_{36r_L}(p_L, \pi_0))) \sqcup \mathbf{C}_{32r_L}(p_L, \pi_H) = Q[[B_{32r_L}(\mathbf{p}_{\pi_H}(p_L), \pi_H)]]$. On the other hand since $(T_L \sqcup \mathbf{C}_{36r_L}(p_L, \pi_0)) \sqcup \mathbf{C}_{32r_L}(p_L, \pi_H) = T_L \sqcup \mathbf{C}_{32r_L}(p_L, \pi_H)$, this concludes the proof of (6.1).

Now, by Proposition 5.1(iv)&(vii)

$$\mathbf{E}(T_L, \mathbf{C}_{32r_L}(p_L, \pi_H)) \leq \bar{C}\mathbf{E}(T_L, \mathbf{B}_L) + \bar{C}|\pi_L - \pi_H|^2 \leq \bar{C}\mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1} \leq \bar{C}\mathbf{m}_0$$

and in order to apply [11, Theorem 1.5] we just need to choose ε_2 sufficiently small. \square

We next generalize slightly the terminology of Section 3.2.

Definition 6.2. Let H and L be as in Proposition 6.1. After applying [11, Theorem 1.5] to $T_L \sqcup \mathbf{C}_{32r_L}(p_L, \pi_H)$ in the cylinder $\mathbf{C}_{32r_L}(p_L, \pi_H)$ we denote by f_{HL} the corresponding π_H -approximation. However, rather than defining f_{HL} on the disk $B_{8r_L}(p_L, \pi_H)$, by applying a translation we assume that the domain of f_{HL} is the disk $B_{8r_L}(p_{HL}, \pi_H)$ where $p_{HL} = p_H + \mathbf{p}_{\pi_H}(p_L - p_H)$. Note in particular that $\mathbf{C}_r(p_{HL}, \pi_H)$ equals $\mathbf{C}_r(p_L, \pi_H)$, whereas $B_{8r_L}(p_{HL}, \pi_H) \subset p_H + \pi_H$ and $p_H \in \mathbf{B}_{8r_L}(p_{HL}, \pi_H)$.

Observe that $f_{LL} = f_L$.

6.1. First variations. The next proposition is the core in the construction of the center manifold and it is the main reason behind the C^{3,γ_0} estimate for the glued interpolation. It is also the place where our proof differs most from that of [9].

Definition 6.3. Let H and L be as in Proposition 6.1. In the cases (a) and (c) of Definition 0.1 we denote by \varkappa_H the orthogonal complement in $T_{p_H}\Sigma$ of π_H and we denote by \tilde{f}_{HL} the map $\mathbf{p}_{\varkappa_H} \circ f_{HL}$.

In what follows we will consider elliptic systems of the following form. Given a vector valued map $v : p_H + \pi_H \supset \Omega \rightarrow \varkappa_H$ and after introducing an orthonormal system of coordinates x^1, x^2 on π_H and $y^1, \dots, y^{\bar{n}}$ on \varkappa_H , the system is given by the \bar{n} equations

$$\Delta v^k + \underbrace{(\mathbf{L}_1)_{ij}^k \partial_j v^i + (\mathbf{L}_2)_i^k v^i}_{=: \mathcal{E}^k(v)} = \underbrace{(\mathbf{L}_3)_i^k (x - x_H)^i + (\mathbf{L}_4)^k}_{=: \mathcal{F}^k}, \quad (6.4)$$

where we follow Einstein's summation convention and the tensors \mathbf{L}_i have constant coefficients. After introducing the operator $\mathcal{L}(v) = \Delta v + \mathcal{E}(v)$ we summarize the corresponding elliptic system (6.4) as

$$\mathcal{L}(v) = \mathcal{F}. \quad (6.5)$$

We then have a corresponding weak formulation for $W^{1,2}$ solutions of (6.5), namely v is a weak solution in a domain D if the integral

$$\mathcal{I}(v, \zeta) := \int (Dv : D\zeta + (\mathcal{F} - \mathcal{E}(v)) \cdot \zeta) \quad (6.6)$$

vanishes for smooth test functions ζ with compact support in D .

Proposition 6.4. *Let H and L be as in Proposition 6.1 (including the possibility that $H = L$) and let f_{HL} , \bar{f}_{HL} and \varkappa_H be as in Definition 6.2 and Definition 6.3. Then, there exist tensors with constant coefficients $\mathbf{L}_1, \dots, \mathbf{L}_4$ and a constant $C = C(M_0, N_0, C_e, C_h)$, with the following properties:*

- (i) *The tensors depend upon H and Σ (in the cases (a) and (c) of Definition 0.1) or ω (in case (b) of Definition 0.1) and $|\mathbf{L}_1| + |\mathbf{L}_2| + |\mathbf{L}_3| + |\mathbf{L}_4| \leq C\mathbf{m}_0^{1/2}$.*
- (ii) *If \mathcal{L}_H , \mathcal{I}_H , and \mathcal{F}_H are defined through (6.4), (6.5) and (6.6), then*

$$\mathcal{I}_H(\boldsymbol{\eta} \circ \bar{f}_{HL}, \zeta) \leq C\mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r_L^{4+\beta_2} \|D\zeta\|_0 \quad (6.7)$$

for all $\zeta \in C_c^\infty(B_{8r_L}(p_{HL}, \pi_H), \varkappa_H)$.

Proof. Set for simplicity $\pi = \pi_H$, $\varkappa := \varkappa_H$, $r = r_L$, $p = p_{HL}$, $f = f_{HL}$, $B = B_{8r}(p, \pi)$ and $T = T_L$.

Cases (a) and (b) of Definition 0.1. The proof is very similar to the one of [9, Proposition 5.2]. Nevertheless, for the sake of completeness, we give here all the details. We fix a system of coordinates $(x, y, w) \in \pi \times \varkappa \times (T_{p_H}\Sigma)^\perp$ so that $p_H = (0, 0, 0)$. We drop the subscript p_H for the map Ψ_{p_H} . Recall that, by Lemma 2.3,

$$\Psi(0, 0) = 0, \quad D\Psi(0, 0) = 0 \quad \text{and} \quad \|D\Psi\|_{C^{2,\varepsilon_0}} \leq C\mathbf{m}_0^{1/2}.$$

Let $\zeta \in C_c(B_{8r}(p, \pi), \varkappa)$ be a test function. We consider the vector field $\chi : \Sigma \rightarrow \mathbb{R}^{2+n}$ given by $\chi(q) = (0, \zeta(x), D_y\Psi(x, y) \cdot \zeta(x))$ for every $q = (x, y, \Psi(x, y)) \in \Sigma$. Note that χ is tangent to Σ . Therefore we infer that $\delta T(\chi) = 0$ and

$$|\delta \mathbf{G}_f(\chi)| = |\delta \mathbf{G}_f(\chi) - \delta T(\chi)| \leq C \int_{\mathbf{C}_{8r}(p, \pi)} |D\chi| d\|\mathbf{G}_f - T\|. \quad (6.8)$$

Observe also that $|\chi| \leq C|\zeta|$ and $|D\chi| \leq C|\zeta| + C|D\zeta| \leq C|D\zeta|$. Set $E := \mathbf{E}(T, \mathbf{C}_{32r}(p, \pi))$. Thus, by (6.3) and Proposition 5.1(vii) we have

$$E \leq C\mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell(L)^{2-2\delta_1}, \mathbf{h}(T, \mathbf{C}_{32r}(p, \pi)) \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}. \quad (6.9)$$

Recall that, by [11, Theorem 1.5] we have

$$|Df| \leq CE^{\beta_0} + C\mathbf{m}_0^{1/2} r \leq C\mathbf{m}_0^{\beta_0} d(L)^{(2\gamma_0-2+2\delta_1)\beta_0} r^{\beta_0(2-2\delta_1)} \quad (6.10)$$

$$|f| \leq C\mathbf{h}(T, \mathbf{C}_{32r}(p, \pi)) + (E^{1/2} + r\mathbf{m}_0^{1/2})r \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} r^{1+\beta_2}, \quad (6.11)$$

$$\int_B |Df|^2 \leq C r^2 E \leq C\mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} r^{4-2\delta_1}, \quad (6.12)$$

(although (6.12) is not explicitly stated in [11, Theorem 1.5] it follows from the estimates therein as in [7, Remark 4.5]) and

$$|B \setminus K| \leq C\mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} r^{2+(1+\beta_0)(2-2\delta_1)}, \quad (6.13)$$

$$\left| \|T\|(\mathbf{C}_{8r}(p, \pi)) - |B| - \frac{1}{2} \int_B |Df|^2 \right| \leq C\mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} r^{2+(1+\beta_0)(2-2\delta_1)}, \quad (6.14)$$

where $K \subset B$ is the set

$$B \setminus K = \mathbf{p}_\pi \left((\text{spt}(T) \Delta \text{spt}(\mathbf{G}_f)) \cap \mathbf{C}_{8r_L}(p_L, \pi) \right). \quad (6.15)$$

Writing $f = \sum_i \llbracket f_i \rrbracket$ and $\bar{f} = \sum_i \llbracket \bar{f}_i \rrbracket$, since $\text{Gr}(f) \subset \Sigma$, we have $f = \sum_i \llbracket (\bar{f}_i, \Psi(x, \bar{f}_i)) \rrbracket$. From [8, Theorem 4.1] we can infer that

$$\begin{aligned} \delta \mathbf{G}_f(\chi) &= \int_B \sum_i \left(\underbrace{D_{xy} \Psi(x, \bar{f}_i) \cdot \zeta}_{(A)} + \underbrace{(D_{yy} \Psi(x, \bar{f}_i) \cdot D \bar{f}_i) \cdot \zeta}_{(B)} + \underbrace{D_y \Psi(x, \bar{f}_i) \cdot D_x \zeta}_{(C)} \right) \\ &\quad : \left(\underbrace{D_x \Psi(x, \bar{f}_i)}_{(D)} + \underbrace{D_y \Psi(x, \bar{f}_i) \cdot D \bar{f}_i}_{(E)} \right) + \underbrace{\int_B \sum_i D \zeta : D \bar{f}_i}_{(F)} + \text{Err}, \end{aligned} \quad (6.16)$$

where the error term Err in (6.16) satisfies the inequality

$$\begin{aligned} |\text{Err}| &\leq C \int |D \chi| |D f|^3 \leq \|D \zeta\|_{L^\infty} \|D f\|_{L^\infty} \int |D f|^2 \\ &\leq C \|D \zeta\|_0 \mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} r^{4-2\delta_1+\beta_0(2-2\delta_1)}. \end{aligned} \quad (6.17)$$

The integral (F) in (6.16) is

$$(F) = Q \int_B D \zeta : D(\boldsymbol{\eta} \circ \bar{f}). \quad (6.18)$$

We therefore expand the product in the other integral and estimate all terms separately, using the Taylor expansion

$$D \Psi(x, y) = D_x D \Psi(0, 0) \cdot x + D_y D \Psi(0, 0) \cdot y + O(\mathbf{m}_0^{1/2}(|x|^2 + |y|^2))$$

so that

$$\begin{aligned} |D \Psi(x, \bar{f}_i)| &\leq C \mathbf{m}_0^{1/2} r \\ D \Psi(x, \bar{f}_i) &= D_x D \Psi(0, 0) \cdot x + O(\mathbf{m}_0^{1/2+1/4} d(L)^{\gamma_0/2-\beta_2} r^{1+\beta_2}), \\ |D^2 \Psi(x, \bar{f}_i)| &\leq C \mathbf{m}_0^{1/2} \quad \text{and} \quad D^2 \Psi(x, \bar{f}_i) = D^2 \Psi(0, 0) + O(\mathbf{m}_0^{1/2} r). \end{aligned}$$

We compute as follows:

$$\begin{aligned} \int \sum_i (A) : (D) &= \int \sum_i (D_{xy} \Psi(0, 0) \cdot \zeta) : D_x \Psi(x, \bar{f}_i) + O(\mathbf{m}_0 r^2 \int |\zeta|) \\ &= \int Q(D_{xy} \Psi(0, 0) \cdot \zeta) : (D_{xx} \Psi(0, 0) \cdot x) \\ &\quad + O(\mathbf{m}_0 d(L)^{\gamma_0/2-\beta_2} r^{1+\beta_2} \int |\zeta|). \end{aligned} \quad (6.19)$$

The integral in (6.19) has the form $\int \mathbf{L}_{AD} x \cdot \zeta$. Next, we estimate

$$\begin{aligned} \int \sum_i ((A) : (E) + (B) : (D) + (B) : (E)) \\ = O\left(\mathbf{m}_0^{1+\beta_0} \mathfrak{d}(L)^{\beta_0(2\gamma_0-2+2\delta_1)} r^{1+\beta_0(2-2\delta_1)} \int |\zeta|\right) \end{aligned} \quad (6.20)$$

and

$$\int \sum_i (C) : (E) = O\left(\mathbf{m}_0^{1+\beta_0} \mathfrak{d}(L)^{\beta_0(2\gamma_0-2+2\delta_1)} r^{2+\beta_0(2-2\delta_1)} \int |D\zeta|\right). \quad (6.21)$$

Finally we compute

$$\begin{aligned} \int \sum_i (C) : (D) &= \int \sum_i ((D_{xy}\Psi(0,0) \cdot x) \cdot D_x\zeta) : D_x\Psi(x, \bar{f}_i) \\ &\quad + O\left(\mathbf{m}_0 \mathfrak{d}(L)^{\gamma_0/2-\beta_2} r^{2+\beta_2} \int |D\zeta|\right) \\ &= Q \int (D_{xy}\Psi(0,0) \cdot x) \cdot D_x\zeta : (D_{xx}\Psi(0,0) \cdot x) \\ &\quad + O\left(\mathbf{m}_0 \mathfrak{d}(L)^{\gamma_0/2-\beta_2} r^{2+\beta_2} \int |D\zeta|\right). \end{aligned}$$

Integrating by parts in the last integral we reach

$$\int \sum_i (C) : (D) = \int \mathbf{L}_{CD} x \cdot \zeta + O\left(\mathbf{m}_0 \mathfrak{d}(L)^{\gamma_0/2-\beta_2} r^{2+\beta_2} \int |D\zeta|\right). \quad (6.22)$$

Set next $\mathbf{L}_3 := \mathbf{L}_{AD} + \mathbf{L}_{CD}$. Clearly \mathbf{L}_3 is a quadratic function of $D^2\Psi(0,0)$, i.e. a quadratic function of the tensor A_Σ at the point p_H . From (6.8), (6.17), (6.19) – (6.22), we infer (6.7) and (i). Indeed we have to compare the following three types of errors

$$\mathcal{E}_1 := \mathbf{m}_0^{1+\beta_0} \mathfrak{d}(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} r^{4-2\delta_1+\beta_0(2-2\delta_1)} \quad (6.23)$$

$$\mathcal{E}_2 := \mathbf{m}_0^{1+\beta_0} \mathfrak{d}(L)^{\beta_0(2\gamma_0-2+2\delta_1)} r^{4+\beta_0(2-2\delta_1)} \quad (6.24)$$

$$\mathcal{E}_3 := \mathbf{m}_0 \mathfrak{d}(L)^{\gamma_0/2-\beta_2} r^{4+\beta_2} \quad (6.25)$$

with $\mathbf{m}_0 \mathfrak{d}(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r^{4+\beta_2}$. It is easy to see that if

$$-2\delta_1 + \beta_0(2 - 2\delta_1) - \beta_2 > 0 \quad (6.26)$$

then

$$\begin{aligned} \mathcal{E}_2 \leq \mathcal{E}_1 &\leq \mathbf{m}_0^{1+\beta_0} \mathfrak{d}(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)-2\delta_1+\beta_0(2-2\delta_1)-\beta_2} r^{4+\beta_2} \\ &\leq \mathbf{m}_0^{1+\beta_0} \mathfrak{d}(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r^{4+\beta_2} \end{aligned} \quad (6.27)$$

Therefore

$$\mathcal{E}_1, \mathcal{E}_2, \mathcal{E}_3 \leq \mathbf{m}_0 \mathfrak{d}(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r^{4+\beta_2}. \quad (6.28)$$

To conclude the proof we observe that, by the bound (6.12) and [11, Theorem 5.2]

$$\begin{aligned} \int_{\mathbf{C}_{8r}(p,\pi)} |D\chi| d\|\mathbf{G}_f - T\| &\leq C \|D\zeta\|_0 \mathbf{M}(T \lrcorner \mathbf{C}_{8r}(p,\pi) - \mathbf{G}_f) \\ &\leq C_0 \|D\zeta\|_0 r^2 E^{\beta_0} (E + \mathbf{m}_0 r^2) \leq C \mathcal{E}_2. \end{aligned}$$

Case (b) of Definition 0.1. Fix coordinates $(x, y) \in \mathbb{R}^2 \times \mathbb{R}^n$ such that $p_H = (0, 0)$. Consider the vector field $\chi(x, y) := (0, \zeta(x))$ for some ζ as in the statement. Recalling [13, Proposition 1.2] we infer

$$\delta \mathbf{G}_f(\chi) = \delta T(\chi) + \text{Err}_0 = T(d\omega \lrcorner \chi) + \text{Err}_0 = \mathbf{G}_f(d\omega \lrcorner \chi) + \text{Err}_0 + \text{Err}_1$$

with

$$\begin{aligned} |\text{Err}_0| + |\text{Err}_1| &= |\delta T(\chi) - \delta \mathbf{G}_f(\chi)| + |T(d\omega \lrcorner \chi) - \mathbf{G}_f(d\omega \lrcorner \chi)| \\ &\leq C (\|D\zeta\|_0 + \|d\omega \lrcorner \chi\|_0) \|T - \mathbf{G}_f\|(\mathbf{C}_{8r}(p,\pi)) \\ &\leq C (\|D\zeta\|_0 + \|\zeta\|_0) E^{\beta_0} (E + r^2 \mathbf{m}_0) r^2 \\ &\leq C \|D\zeta\|_0 \mathbf{m}_0^{1+\beta_0} d(H)^{(2\gamma_0-2+2\delta_1)(1+\beta_0)} r^{2+(2-2\delta_1)(1+\beta_0)}. \end{aligned} \quad (6.29)$$

From [8, Theorem 4.1]

$$\delta \mathbf{G}_f(\chi) = Q \int D(\boldsymbol{\eta} \circ f): D\zeta + \text{Err}_2$$

with

$$\begin{aligned} |\text{Err}_2| &\leq C \int |D\zeta| |Df|^3 \leq C \|D\zeta\|_0 E^{1+\beta_0} r^2 \\ &\stackrel{(6.12)}{\leq} C \|D\zeta\|_0 \mathbf{m}_0^{1+\beta_0} d(H)^{(2\gamma_0-2+2\delta_1)(1+\beta_0)} r^{2+(2-2\delta_1)(1+\beta_0)}. \end{aligned}$$

Next we proceed to expand $\mathbf{G}_f(d\omega \lrcorner \chi)$. To this aim we write

$$\begin{aligned} d\omega(x, y) &= \sum_{l=1}^n a_l(x, y) dy^l \wedge dx^1 \wedge dx^2 + \sum_{j=1,2} \sum_{l < k} b_{lk,j}(x, y) dy^l \wedge dy^k \wedge dx^j \\ &\quad + \sum_{l < k < j} c_{lkj}(x, y) dy^l \wedge dy^k \wedge dy^j \end{aligned} \quad (6.30)$$

and get

$$d\omega \lrcorner \chi = \underbrace{\sum_{l=1}^n a_l \zeta^l dx^1 \wedge dx^2}_{\omega^{(1)}} + \underbrace{\sum_{j=1,2} \sum_{l < k} b_{lk,j} \zeta^l dy^k \wedge dx^j}_{\omega^{(2)}} + \underbrace{\sum_{l < k < j} c_{lkj} \zeta^l dy^k \wedge dy^j}_{\omega^{(3)}}. \quad (6.31)$$

We consider separately $\mathbf{G}_f(\omega^{(1)})$, $\mathbf{G}_f(\omega^{(2)})$, $\mathbf{G}_f(\omega^{(3)})$. We start with the latter

$$\mathbf{G}_f(\omega^{(3)}) \leq C \|d\omega\|_0 \|\zeta\|_0 \int_B |Df|^2 \stackrel{(6.12)}{\leq} C \mathbf{m}_0^2 d(H)^{2\gamma_0-2+2\delta_1} r^{5-2\delta_1} \|D\zeta\|_0. \quad (6.32)$$

Next

$$\begin{aligned}
\mathbf{G}_f(\omega^{(2)}) &= \sum_{l < k} \sum_{i=1}^Q \int \zeta^l(x) \left(b_{lk,2}(x, f_i(x)) \frac{\partial f_i^k}{\partial x^1} - b_{lk,1}(x, f_i(x)) \frac{\partial f_i^k}{\partial x^2} \right) dx \\
&= Q \sum_{l < k} \int \zeta^l(x) \left(b_{lk,2}(0,0) \frac{\partial(\boldsymbol{\eta} \circ f)^k}{\partial x^1} - b_{lk,1}(0,0) \frac{\partial(\boldsymbol{\eta} \circ f)^k}{\partial x^2} \right) dx + \text{Err}_3, \\
&= \int \mathbf{L}_1 D(\boldsymbol{\eta} \circ f) \cdot \zeta + \text{Err}_3
\end{aligned} \tag{6.33}$$

with

$$\begin{aligned}
|\text{Err}_3| &\leq C \|\zeta\|_0 \|D(d\omega)\|_0 \int_B (r |Df| + |f| |Df|) dx \\
&\stackrel{(6.10)\&(6.11)}{\leq} C \|D\zeta\|_0 \mathbf{m}_0^{1+\beta_0} r^{4+(2-2\delta_1)\beta_0} d(H)^{(2\gamma_0-2+2\delta_1)\beta_0}
\end{aligned} \tag{6.34}$$

and $\mathbf{L}_1 : \mathbb{R}^{n \times 2} \rightarrow \mathbb{R}^n$ given by

$$\mathbf{L}_1 A \cdot e_l := Q \sum_{k=1}^n (b_{lk,2}(0,0) A_{k1} - b_{lk,1}(0,0) A_{k2}) \quad \forall A = (A_{kj})_{k=1, \dots, n}^{j=1,2} \in \mathbb{R}^{n \times 2}.$$

Finally

$$\begin{aligned}
\mathbf{G}_f(\omega^{(1)}) &= \sum_l \sum_{i=1}^Q \int \zeta^l(x) a_l(x, f_i(x)) dx \\
&= Q \sum_l \int \zeta^l(x) (a_l(0,0) + D_x a_l(0,0) \cdot x + D_y a_l(0,0) \cdot (\boldsymbol{\eta} \circ f)) dx + \text{Err}_4, \\
&= \int (\mathbf{L}_2(\boldsymbol{\eta} \circ f) + \mathbf{L}_3 x + \mathbf{L}_4) \cdot \zeta + \text{Err}_4
\end{aligned} \tag{6.35}$$

where $\mathbf{L}_2 : \mathbb{R}^n \rightarrow \mathbb{R}^n$, $\mathbf{L}_3 : \mathbb{R}^2 \rightarrow \mathbb{R}^n$, $\mathbf{L}_4 \in \mathbb{R}^n$ are given by

$$\mathbf{L}_2 v \cdot e_l := \sum_{k=1}^n \frac{\partial a_l}{\partial y^k}(0,0) v^k \quad \forall v \in \mathbb{R}^n, \forall l = 1, \dots, n \tag{6.36}$$

$$\mathbf{L}_3 w \cdot e_l := \sum_{j=1}^2 \frac{\partial a_l}{\partial x^j}(0,0) w^j \quad \forall w \in \mathbb{R}^n, \forall l = 1, \dots, n \tag{6.37}$$

$$\mathbf{L}_4 \cdot e_l := a_l(0,0) \quad \forall l = 1, \dots, n \tag{6.38}$$

and arguing as above

$$|\text{Err}_4| \leq C \|\zeta\|_0 [D(d\omega)]_{\varepsilon_0} \int_B (r^{1+\varepsilon_0} + |f|^{1+\varepsilon_0}) dx \leq C \|D\zeta\|_0 \mathbf{m}_0 r^{4+\varepsilon_0}. \tag{6.39}$$

In order to deduce (6.7) we need to compare, using (6.24) and (6.28),

$$\begin{aligned} |\text{Err}_0 + \text{Err}_1 + \text{Err}_2| &\leq \|D\zeta\|_0 \mathcal{E}_1 \leq \|D\zeta\|_0 \mathbf{m}_0 \mathbf{d}(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r^{4+\beta_2} \\ \mathcal{E}_2 &= C \mathbf{m}_0^{1+\beta_0} \mathbf{d}(H)^{(2\gamma_0-2+2\delta_1)\beta_0} r^{4+(2-2\delta_1)\beta_0} \\ \mathcal{E}_{2.5} &= C \mathbf{m}_0^2 \mathbf{d}(H)^{2\gamma_0-2+2\delta_1} r^{5-2\delta_1} \\ \mathcal{E}_4 &= C \mathbf{m}_0 r^{4+\varepsilon_0} \end{aligned}$$

with $\mathbf{m}_0 \mathbf{d}(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r^{4+\beta_2}$. As before, if (6.26) holds, then $\mathcal{E}_2 \leq \mathcal{E}_1$. Moreover, since $\mathcal{E}_4 \leq r^{4+\beta_2}$, to conclude (6.7) it is enough to observe that if

$$1 \geq \beta_0(2 - 2\delta_1) \quad (6.40)$$

then $0 > 2\gamma_0 - 2 + 2\delta_1 > (2\gamma_0 - 2 + 2\delta_1)(1 + \beta_0)$ and $5 - 2\delta_1 > 2 + (2 - 2\delta_1)(1 + \beta_0)$, so that

$$\mathbf{d}(H)^{2\gamma_0-2+2\delta_1} r^{5-2\delta_1} \leq \mathbf{d}(H)^{(2\gamma_0-2+2\delta_1)(1+\beta_0)} r^{2+(2-2\delta_1)(1+\beta_0)},$$

that is $\mathcal{E}_{2.5\&4} \leq \mathcal{E}_1$. \square

6.2. Tilted interpolating functions, L^1 and L^∞ estimates. In this subsection we generalize the definition of the tilted interpolating functions h_L . More precisely we consider

Definition 6.5. Let H and L be as in Proposition 6.1, assume that the conclusions of Proposition 6.4 applies and let \mathcal{L}_H and \mathcal{F}_H be the corresponding operator and map as given by Proposition 6.4 in combination with (6.4), (6.5) and (6.6). Let f_{HL} be as in Definition 6.2, \varkappa_H and \bar{f}_{HL} be as in Definition 6.3 and fix coordinates $(x, y, z) \in \pi_H \times \varkappa_H \times T_{p_H} \Sigma^\perp$ as in the proof of Proposition 6.4. We then let \bar{h}_{HL} be the solution of

$$\begin{cases} \mathcal{L}_H \bar{h}_{HL} = \mathcal{F}_H \\ \bar{h}_{HL}|_{\partial B_{8r_L}(p_{HL}, \pi_H)} = \eta \circ \bar{f}_{HL}. \end{cases} \quad (6.41)$$

In case (b) of Definition 0.1 we then define $h_{HL} = \bar{h}_{HL}$, whereas in the other cases we define $h_{HL}(x) = (\bar{h}_{HL}(x), \Psi_{p_H}(x, \bar{h}_{HL}(x)))$.

In order to show that the maps \bar{h}_{HL} are well defined, we need to show that there is a solution of the system (6.41).

Lemma 6.6. *Under the assumptions of Definition 6.5, if ε_2 is sufficiently small, then the elliptic system*

$$\begin{cases} \mathcal{L}_H v = F \\ v|_{\partial B_{8r_L}(p_{HL}, \pi_H)} = g. \end{cases} \quad (6.42)$$

has a unique solution for every $F \in W^{-1,2}$ (the latter being the usual space of distributions which can be represented as first partial derivatives of L^2 functions) and every $g \in W^{1,2}(B_{8r_L}(p_{HL}, \pi_H))$. Observe moreover that $\|Dv\|_{L^2} \leq C_0 r_L (\|F\|_{L^2} + \mathbf{m}_0^{1/2} \|g\|_{L^2}) + C_0 \|Dg\|_{L^2}$ whenever $F \in L^2$.

Proof. As for the first assertion, it suffices to show the Lemma for $g = 0$, since we can define $w = v - g$ and solve $\mathcal{L}_H(w) = F + \mathcal{L}_H(g)$. Setting $B = B_{8r_L}(p_{HL}, \pi_H)$, the existence and uniqueness for the latter case reduces, by Lax-Milgram, to the coercivity of the suitable quadratic form $\mathcal{Q}(v, v)$ on $W_0^{1,2}(B)$. The latter follows easily from

$$\begin{aligned} \mathcal{Q}(w, w) &:= \int (|Dw|^2 - \mathbf{L}_1 Dw \cdot w - \mathbf{L}_2 w \cdot w) \\ &\geq \|Dw\|_{L^2(B)}^2 - \frac{|\mathbf{L}_1|}{2} \|Dw\|_{L^2(B)}^2 - \left(\frac{|\mathbf{L}_1|}{2} + |\mathbf{L}_2| \right) \|w\|_{L^2(B)}^2. \end{aligned}$$

Since $r_L \leq 1$, by the Poincaré inequality $\|w\|_{L^2}^2 \leq C_0 \|Dw\|_{L^2}^2$ for every $w \in W_0^{1,2}(B)$. The coercivity follows then from $|\mathbf{L}_1| + |\mathbf{L}_2| \leq C \mathbf{m}_0^{1/2} \leq C \varepsilon_2$, where the constant C depends only upon M_0, N_0, C_e and C_h . In particular we can assume the coercivity factor to be $\frac{1}{2}$.

On the other hand, multiplying the equation by w and integrating by parts we easily see (using the coercivity) that

$$\begin{aligned} \frac{1}{2} \int |Dw|^2 &\leq \int (|Dw||Dg| + |F||w|) + C \mathbf{m}_0^{1/2} \int (|g||w| + |w||Dg|) \\ &\leq \frac{1}{4} \int |Dw|^2 + \frac{r_L^2}{\gamma} \int |F|^2 + \frac{2\gamma}{r_L^2} \int |w|^2 + C \int (|Dg|^2 + \frac{m_0}{\gamma} r_L^2 |g|^2), \end{aligned}$$

where γ is any fixed positive number and C does not depend upon it.

We choose γ smaller than a geometric constant, so that we can use the Poincaré inequality to absorb the terms $\int |w|^2$ on the right hand side. We then conclude the desired estimate $\|Dw\|_{L^2} \leq C(\|Dg\|_{L^2} + \mathbf{m}_0^{1/2} r_L \|g\|_{L^2} + r_L \|F_L\|_{L^2})$. Since $v = w + g$, we then conclude $\|Dv\|_{L^2} \leq C(\|Dg\|_{L^2} + \mathbf{m}_0^{1/2} r_L \|g\|_{L^2} + C r_L \|F_L\|_{L^2})$. \square

Observe that $h_{HH} = h_H$. We next record three fundamental estimates, which regard, respectively, the L^∞ norms of derivatives of solutions of $\mathcal{L}_H(v) = F$, the L^∞ norm of $\bar{h}_{HL} - \boldsymbol{\eta} \circ \bar{f}_{HL}$ and the L^1 norm of $\bar{h}_{HL} - \boldsymbol{\eta} \circ \bar{f}_{HL}$.

Proposition 6.7. *Let H and L be as in Proposition 6.4 and assume the conclusions in there apply. Then the following estimates hold for a constant $C = C(m_0, N_0, C_e, C_h)$ for $\hat{B} := B_{8r_L}(p_{HL}, \pi_H)$ and $\tilde{B} := B_{6r_L}(p_{HL}, \pi_H)$:*

$$\|\bar{h}_{HL} - \boldsymbol{\eta} \circ \bar{f}_{HL}\|_{L^1(\hat{B})} \leq C \mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(L)^{5+\beta_2} \quad (6.43)$$

$$\|\bar{h}_{HL} - \boldsymbol{\eta} \circ \bar{f}_{HL}\|_{L^\infty(\tilde{B})} \leq C \mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(L)^{3+\beta_2} + C \mathbf{m}_0^{1/2} \ell(L)^2. \quad (6.44)$$

Moreover, if \mathcal{L}_H is the operator of Proposition 6.4, r a positive number no larger than 1 and v a solution of $\mathcal{L}_H(v) = F$ in $B_{8r}(q, \pi_H)$ for some smooth F , then

$$\|v\|_{L^\infty(B_{6r}(q, \pi_H))} \leq \frac{C_0}{r^2} \|v\|_{L^1(B_{8r}(q, \pi_H))} + C r^2 \|F\|_{L^\infty(B_{8r}(q, \pi_H))} \quad (6.45)$$

and, for $l \in \mathbb{N}$

$$\|D^l v\|_{L^\infty(B_{6r}(q, \pi_H))} \leq \frac{C_0}{r^{2+l}} \|v\|_{L^1(B_{8r}(q, \pi_H))} + Cr^2 \sum_{j=0}^l r^{j-l} \|D^j F\|_{L^\infty(B_{8r}(q, \pi_H))}, \quad (6.46)$$

where the latter constants depend also upon l .

Proof. Proof of (6.45). The estimate will be proved for a linear constant coefficient operator of the form $\mathcal{L} = \Delta + \mathbf{L}_1 \cdot D + \mathbf{L}_2$ when \mathbf{L}_1 and \mathbf{L}_2 are sufficiently small. We can then assume $\pi_H = \mathbb{R}^2$ and $q = 0$. Besides, if we define $u(x) := v(rx)$ we see that u just satisfies $\Delta u + r\mathbf{L}_1 \cdot Du + r^2\mathbf{L}_2 \cdot u = 0$ and thus, without loss of generality, we can assume $r = 1$. We thus set $B = B_8(0) \subset \mathbb{R}^2$.

We recall the following interpolation estimate on the ball of radius 1, see [14, Theorem 1]. For $0 \leq j \leq m$ and $\frac{j}{m} \leq a \leq 1$ we have, for a constant $C_0 = C_0(m, j, q, s)$,

$$\|D^j u\|_{L^p(B_1)} \leq C \|D^m u\|_{L^s(B_1)}^a \|u\|_{L^q(B_1)}^{1-a} + C \|u\|_{L^q(B_1)}, \quad (6.47)$$

where

$$\frac{1}{p} = \frac{j}{2} + a\left(\frac{1}{s} - \frac{m}{2}\right) + (1-a)\frac{1}{q}.$$

We apply the estimate (6.47) for $j = 1$, $m = 2$, $q = 1$ and $p = s = 2$, $a = 2/3$ and use Young's inequality and a simple scaling argument to achieve the inequality

$$\|Du\|_{L^2(B_\rho(x))} \leq C_0 \rho \|D^2 u\|_{L^2(B_\rho(x))} + C_0 \rho^{-2} \|u\|_{L^1(B_\rho(x))}. \quad (6.48)$$

Moreover, by the Poincaré inequality:

$$\|u\|_{L^2(B_\rho(x))} \leq C_0 \rho \|Du\|_{L^2(B_\rho(x))} + C_0 \rho^{-1} \|u\|_{L^1(B_\rho(x))}. \quad (6.49)$$

Next, recall the standard L^2 estimates for second order derivatives of solutions of the Laplace equations: if $B_{2\rho}(x) \subset B$, then

$$\|D^2 u\|_{L^2(B_\rho(x))} \leq C_0 \|\Delta u\|_{L^2(B_{2\rho}(x))} + C_0 \rho^{-3} \|u\|_{L^1(B_{2\rho}(x))}. \quad (6.50)$$

Now, recall that $\Delta u = -\mathbf{L}_1 \cdot Du - \mathbf{L}_2 \cdot u + F$. Using the fact that $|\mathbf{L}_1| + |\mathbf{L}_2| \leq C_0 \mathbf{m}_0^{1/2}$, we can combine all the inequalities above to conclude

$$\rho^6 \|D^2 u\|_{L^2(B_\rho(x))}^2 \leq C_0 \rho^6 \mathbf{m}_0 \|D^2 u\|_{L^2(B_{2\rho}(x))}^2 + C_0 \|u\|_{L^1(B_8)}^2 + C_0 \|F\|_{L^\infty(B_8)}^2. \quad (6.51)$$

Define next

$$S := \sup\{\rho^3 \|D^2 u\|_{L^2(B_\rho(x))} : B_{2\rho}(x) \subset B_8\} \quad (6.52)$$

and let ϱ and ξ be such that $B_{2\varrho}(\xi) \subset B_8$ and

$$\varrho^3 \|D^2 u\|_{L^2(B_\varrho(\xi))} \geq \frac{S}{2}. \quad (6.53)$$

We can cover $B_\varrho(\xi)$ with \bar{N}_0 balls $B_{\varrho/2}(x_i)$ with $x_i \in B_\varrho(\xi)$, where \bar{N}_0 is only a geometric constant. We then can apply (6.51) to conclude that

$$\frac{S}{2} \leq C_0 \bar{N}_0 \mathbf{m}_0^{1/2} S + C_0 \bar{N}_0 \|u\|_{L^1(B_8)} + C_0 \bar{N}_0 \|F\|_{L^\infty(B_8)}.$$

Therefore, when $\mathbf{m}_0^{1/2}$ is smaller than a geometric constant we conclude $S \leq C_0 \|u\|_{L^1(B_8)} + C_0 \|F\|_{L^\infty(B_8)}$. By definition of S , we have reached the estimate

$$\rho^3 \|D^2 u\|_{L^2(B_\rho(x))} \leq C_0 \|u\|_{L^1(B_8)} + C_0 \|F\|_{L^\infty(B_8)} \quad \text{whenever } B_{2\rho}(x) \subset B_8.$$

Of course, with a simple covering argument, this implies

$$\|D^2 u\|_{L^2(B_6)} \leq C_0 \|u\|_{L^1(B_8)} + C_0 \|F\|_{L^\infty(B_8)}. \quad (6.54)$$

Next, again using the interpolation inequality (6.48) we get

$$\|Du\|_{L^2(B_6)} \leq C_0 \|u\|_{L^1(B_8)} + C_0 \|F\|_{L^\infty(B_8)}.$$

So, by Sobolev embedding

$$\|Du\|_{L^4(B_6)} \leq C_0 \|Du\|_{W^{1,2}(B_6)} \leq C_0 \|u\|_{L^1(B_8)} + C_0 \|F\|_{L^\infty(B_8)}.$$

Again using interpolation and Sobolev we finally achieve

$$\|u\|_{L^\infty(B_6)} \leq C_0 \|u\|_{W^{1,4}(B_6)} \leq C_0 \|u\|_{L^1(B_8)} + C_0 \|F\|_{L^\infty(B_8)}.$$

Proof of (6.46). As in the previous step, we can, without loss of generality, assume $r = 1$. Note that a byproduct of the argument given above is also the estimate

$$\|Du\|_{L^1(B_6)} \leq C_0 \|u\|_{L^1(B_8)} + C_0 \|F\|_{L^\infty(B_8)}.$$

In fact, by a simple covering and scaling argument one can easily see that

$$\|Du\|_{L^1(B_\tau)} \leq C_0(\tau) \|u\|_{L^1(B_8)} + C_0(\tau) \|F\|_{L^\infty(B_8)} \quad \text{for every } \tau < 8.$$

We can then differentiate the equation and use the proof of the previous paragraph to show

$$\|Du\|_{L^\infty(B_\sigma)} \leq C_0(\sigma, \tau) \|Du\|_{L^1(B_\tau)} + C_0(\sigma, \tau) \|DF\|_{L^\infty(B_\tau)}.$$

Again, arguing as above, a byproduct of the proof is also the estimate

$$\|D^2 u\|_{L^1(B_\sigma)} \leq C_0(\sigma, \tau) \|Du\|_{L^1(B_\tau)} + C_0(\sigma, \tau) \|DF\|_{L^\infty(B_\tau)}.$$

This can be applied inductively to get estimates for all higher derivatives.

Proof of (6.43). Let $B := B_{8r_L}(p_{HL}, \pi_H)$. We use the coordinates introduced in the proof of Proposition 6.4. We set $w := \bar{h}_{HL} - \boldsymbol{\eta} \circ \bar{f}_{HL}$ and observe that

$$\begin{cases} \mathcal{L}w = \bar{\mathcal{F}}_H - \mathcal{L}_H(\boldsymbol{\eta} \circ \bar{f}_{HL}) \\ w|_{\partial B} = 0 \end{cases}$$

Next, for $1 < p < \infty$, we define the continuous (by Calderon-Zygmund theory) linear operator $T : L^p(B) \rightarrow W_0^{1,p}(B) \cap W^{2,p}(B)$ by $T(g) = \psi$ where

$$\begin{cases} -\Delta\psi = g & \text{in } B \\ \psi = 0 & \text{on } \partial B. \end{cases}$$

Applying the Sobolev embedding $W^{1,3}(B) \hookrightarrow C^0(B)$ to the derivative of $\zeta \in W^{2,3} \cap W_0^{1,3}$ we conclude that

$$\|D\zeta - fD\zeta\|_0 \leq C_0 r_L^{1-\frac{2}{3}} \|D^2\zeta\|_{L^3}.$$

On the other hand, by interpolation and Poincaré we conclude

$$\|D\zeta\|_{L^3} \leq \|\zeta\|_{L^3}^{1/2} \|D^2\zeta\|_{L^3}^{1/2} \leq \frac{\varepsilon}{2r_L} \|\zeta\|_{L^3} + \frac{r_L}{2\varepsilon} \|D^2\zeta\|_{L^3} \leq C_0 \varepsilon \|D\zeta\|_{L^3} + \frac{r_L}{2\varepsilon} \|D^2\zeta\|_{L^3},$$

for every positive ε . Choosing the latter accordingly we achieve $\|D\zeta\|_{L^3} \leq C_0 r_L \|D^2\zeta\|_{L^3}$ and thus $\|D\zeta\|_0 \leq C_0 r_L \|D^2\zeta\|_{L^3}$.

We now use these bounds in (6.7) to get

$$\left| \int_B (Dw : D\zeta - \mathbf{L}_1 Dw \cdot \zeta - \mathbf{L}_2 w \cdot \zeta) \right| \leq C \mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r_L^{4+\beta_2} r_L^{1-\frac{2}{3}} \|D^2\zeta\|_{L^3}.$$

Then, we can estimate the $L^{3/2}$ -norm of w as follows:

$$\begin{aligned} \|w\|_{L^{3/2}(B)} &= \sup_{\|h\|_{L^3(B)}=1} \int_B w h = - \sup_{\|h\|_{L^3(B)}=1} \int_B w \Delta T(h) \\ &\leq \sup_{\|h\|_{L^3(B)}=1} \int_B D w \cdot DT(h) \\ &\leq C \mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r_L^{5+\beta_2-2/3} \sup_{\|h\|_{L^3(B)}=1} \|D^2 T(h)\|_{L^3} \\ &\quad + \sup_{\|h\|_{L^3(B)}=1} \int_B (-\mathbf{L}_1 Dw \cdot T(h) - \mathbf{L}_2 w \cdot T(h)). \end{aligned}$$

Recalling the Calderon-Zygmund estimates we have

$$\begin{aligned} \|D^2 T(h)\|_{L^3} &\leq C_0 \|h\|_{L^3} \\ \|DT(h)\|_{L^3} &\leq C_0 r_L \|h\|_{L^3} \\ \|T(h)\|_{L^3} &\leq C_0 r_L^2 \|h\|_{L^3}. \end{aligned}$$

Integrating by parts we then achieve

$$\begin{aligned} \|w\|_{L^{3/2}(B)} &\leq C \mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r_L^{5+\beta_2-2/3} + \sup_{\|h\|_{L^3(B)}=1} \int_B w \cdot (\mathbf{L}_1 DT(h) - \mathbf{L}_2 T(h)) \\ &\leq C \mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} r_L^{5+\beta_2-2/3} + C \mathbf{m}_0^{1/2} \|w\|_{L^{3/2}(B)}. \end{aligned}$$

Therefore, if $\mathbf{m}_0^{1/2}$ is sufficiently small, that is ε_2 is sufficiently small, we deduce that

$$\|w\|_{L^1} \leq C r_L^{2/3} \|w\|_{L^{3/2}(B)} \leq C \mathbf{m}_0 \text{dist}(H)^{2(1+\beta_0)\gamma_0-2-\beta_2} r_L^{5+\beta_2}.$$

Proof of (6.44). The estimate follows easily from (6.43) and (6.45), recalling that $\|\mathcal{F}_H\|_0 \leq C \mathbf{m}_0^{1/2}$. \square

7. MAIN ESTIMATES ON THE INTERPOLATING FUNCTIONS

In this section we adopt the terminology of the previous subsection and we show that

Proposition 7.1. *Assume the conclusions of Proposition 6.1 applies, let $\kappa := \beta_2/4$ and assume ε_2 is sufficiently small, depending upon the other parameters. Then there exists a constant $C = C(M_0, N_0, C_e, C_h)$ such that for any cube $H \in \mathcal{W} \cup \mathcal{S}$, the following conclusions hold.*

- (i) *Lemma 3.9 applies and thus g_H is well-defined.*
- (ii) *The following estimates hold:*

$$\|h_H - \mathbf{p}_{\pi_H}^\perp(p_H)\|_{C^0(B_{6r_H}(p_H, \pi_H))} \leq C \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2 - \beta_2} \ell(H)^{1 + \beta_2} \quad (7.1)$$

$$\|g_H\|_{C^0} \leq C \mathbf{m}_0^{1/4} d(H)^{1 + \gamma_0/2} \quad (7.2)$$

$$\|Dg_H\|_{C^0} + d(H) \|D^2g_H\|_{C^0} + d(H)^2 \|D^3g_H\|_{C^\kappa} \leq C \mathbf{m}_0^{1/2} d(H)^{\gamma_0} \quad (7.3)$$

$$\|g_H - u(z_H, w_H)\|_{C^0} \leq C \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2} \ell(H) + c_s d(H)^a \quad (7.4)$$

$$|\pi_H - T_{(x, g_H(x))} \mathbf{G}_{g_H}| \leq C \mathbf{m}_0^{1/2} d(H)^{\gamma_0 - 1 + \delta_1} \ell(H)^{1 - \delta_1} \quad \forall x \in B_{4r_H}(z_H, w_H). \quad (7.5)$$

- (iii) *If $L \in \mathcal{W} \cup \mathcal{S}$, $L \cap H \neq \emptyset$ and $\ell(H) \leq \ell(L) \leq 2\ell(H)$, then*

$$\|D^l g_L - D^l g_H\|_{C^0(B_{r_L}(z_L, w_L))} \leq C \mathbf{m}_0^{1/2} d(H)^{2(1 + \beta_0)\gamma_0 - \beta_2 - 2} \ell(H)^{3 + \kappa - l} \quad \forall l = 0, \dots, 3. \quad (7.6)$$

- (iv) *If $L \in \mathcal{S} \cup \mathcal{W}$ and $d(H) \leq d(L) \leq 2d(H)$, then*

$$|D^3 g_H(z_H, w_H) - D^3 g_L(z_L, w_L)| \leq C \mathbf{m}_0^{1/2} d(H)^{2(1 + \beta_0)\gamma_0 - \beta_2 - 2} d((z_H, w_H), (z_L, w_L))^\kappa, \quad (7.7)$$

where $d(\cdot, \cdot)$ denotes the distance in \mathfrak{B} .

7.1. Proof of (i) and (ii) in Proposition 7.1. If $H \in \mathcal{C}^{N_0}$, then the estimates follow from the standard elliptic theory for the system of equations defining the interpolating functions. We start by fixing H, L, J so that $H \in \mathcal{S} \cup \mathcal{W}$, L is an ancestor of H (possibly H itself) and J is the father of L . We denote by B' the ball $B_{8r_J}(p_{HJ}, \pi_H)$, by B the ball $B_{8r_L}(p_{HL}, \pi_H)$, by \mathbf{C}' the cylinder $\mathbf{C}_{8r_J}(p_J, \pi_H)$ and by \mathbf{C} the cylinder $\mathbf{C}_{8r_L}(p_L, \pi_H)$. Observe that $B \subset B'$ (this just requires M_0 sufficiently large, given the estimate $|p_J - p_L| \leq 2\sqrt{2}\ell(J)$) and thus $\mathbf{C} \subset \mathbf{C}'$. Next, set $E := \mathbf{E}(T_L, \mathbf{C}_{32r_L}(p_L, \pi_H))$ and $E' := \mathbf{E}(T_J, \mathbf{C}_{32r_J}(p_J, \pi_H))$ and recalling Proposition 5.1(vii) and (6.3) we record

$$E \leq C \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1} \leq C \mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_1} \ell(J)^{2 - 2\delta_1} \quad (7.8)$$

$$E' \leq C \mathbf{m}_0 d(J)^{2\gamma_0 - 2 + 2\delta_1} \ell(J)^{2 - 2\delta_1} \leq C \mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_1} \ell(J)^{2 - 2\delta_1} \quad (7.9)$$

$$\mathbf{h}(T_L, \mathbf{C}) \leq C \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2} \leq C \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2 - \beta_2} \ell(J)^{1 + \beta_2} \quad (7.10)$$

$$\mathbf{h}(T_J, \mathbf{C}') \leq C \mathbf{m}_0^{1/4} d(J)^{\gamma_0/2 - \beta_2} \ell(J)^{1 + \beta_2} \leq C \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2 - \beta_2} \ell(J)^{1 + \beta_2}. \quad (7.11)$$

Next let \bar{K} be the projection of $\text{Gr}(f_{HL}) \cap \text{Gr}(f_{HJ})$ onto $p_{HL} + \pi_H$. Since $T_J \perp \mathbf{B}_L = T_L$, we can estimate

$$|B \setminus \bar{K}| \leq \mathcal{H}^2(\text{Gr}(f_{HL}) \setminus \text{spt}(T_L)) + \mathcal{H}^2(\text{Gr}(f_{HJ}) \setminus \text{spt}(T_J))$$

and recalling the estimates of [11, Theorem 1.5] we achieve

$$|B \setminus \bar{K}| \leq C_0 r_J^2 (E^{\beta_0} (E + C_0 \mathbf{m}_0 r_J^2) + E'^{\beta_0} (E' + C_0 \mathbf{m}_0 r_J^2)) \leq C \mathbf{m}_0^{1+\beta_0} d(H)^{2(1+\beta_0)\gamma_0-2} \ell(J)^4.$$

In particular \bar{K} is certainly nonempty, provided ε_2 is small enough. Using the estimates of [11, Theorem 1.5] on the oscillation of f_{HL} and f_{HJ} we conclude that

$$\|\boldsymbol{\eta} \circ f_{HL} - \boldsymbol{\eta} \circ f_{HJ}\|_{L^\infty(B)} \leq C \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(J)^{1+\beta_2}.$$

Set therefore $\zeta := \boldsymbol{\eta} \circ \bar{f}_{HL} - \boldsymbol{\eta} \circ \bar{f}_{HJ}$ and conclude that

$$\|\zeta\|_{L^1(B)} \leq \|\boldsymbol{\eta} \circ f_{HL} - \boldsymbol{\eta} \circ f_{HJ}\|_{L^\infty(B)} |B \setminus \bar{K}| \leq C \mathbf{m}_0^{1+\beta_0+1/4} d(H)^{\gamma_0/2-\beta_2+2(1+\beta_0)\gamma_0-2} \ell(J)^{5+\beta_2}.$$

If we define $\xi := \bar{h}_{HL} - \bar{h}_{HJ}$ we can use (6.43) of Proposition 6.7 and the triangular inequality to infer

$$\|\xi\|_{L^1(B)} \leq C \mathbf{m}_0 d(H)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(J)^{5+\beta_2}.$$

In turn, again by Proposition 6.7, this time using the fact that $\mathcal{L}_H \xi = 0$ and (6.46), we infer

$$\begin{aligned} \|D^l(\bar{h}_{HL} - \bar{h}_{HJ})\|_{C^0(\hat{B})} &\leq C \mathbf{m}_0 d(H)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(J)^{3+\beta_2-l} \\ &\leq C \mathbf{m}_0 d(H)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(J)^{3+2\kappa-l} \quad \text{for } l = 0, 1, 2, 3, 4, \end{aligned} \quad (7.12)$$

where $\hat{B} = B_{6r_L}(p_{HL}, \pi_H)$. Interpolating we also get easily

$$[D^3(\bar{h}_{HL} - \bar{h}_{HJ})]_{0,\kappa,\hat{B}} \leq C \mathbf{m}_0 d(H)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(J)^\kappa. \quad (7.13)$$

In case (b) of Definition 0.1 we have $h_{HL} = \bar{h}_{HL}$ and $h_{HJ} = \bar{h}_{HJ}$. In case (a) and (c), using the system of coordinates introduced in the proof of Proposition 6.7 we have

$$\begin{aligned} h_{HL}(x) &= (\bar{h}_{HL}(x), \Psi_{p_H}(x, \bar{h}_{HL}(x))) \\ h_{HJ}(x) &= (\bar{h}_{HJ}(x), \Psi_{p_H}(x, \bar{h}_{HJ}(x))) \end{aligned}$$

and we use the chain rule and the regularity of Ψ_{p_H} to achieve the corresponding estimates

$$\|D^l(h_{HL} - h_{HJ})\|_{C^0(\hat{B})} \leq C \mathbf{m}_0 d(H)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(J)^{3+2\kappa-l} \quad \text{for } l = 0, 1, 2, 3. \quad (7.14)$$

$$[D^3(h_{HL} - h_{HJ})]_{0,\kappa,\hat{B}} \leq C \mathbf{m}_0 d(H)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(J)^\kappa. \quad (7.15)$$

Fix now a chain of cubes $H = H_j \subset H_{j-1} \subset \dots \subset H_N =: L$, where each H_{i-1} is the father of H_i . Summing the estimates above and using the fact that $\ell(H_j) = 2^{-j} d(H)$ and $\ell(H) \leq d(H) = d(H_{N_0})$, we infer

$$\|D^l(h_{HL} - h_H)\|_{C^0(\tilde{B})} \leq C d(H)^{2(1+\beta_0)\gamma_0+1-l} \quad \text{for } l = 0, 1, 2, 3 \quad (7.16)$$

$$[D^3(h_{HL} - h_H)]_{0,\kappa,\tilde{B}} \leq C d(H)^{2(1+\beta_0)\gamma_0-\beta_2+\kappa-2}, \quad (7.17)$$

where $\tilde{B} = B_{6r_H}(p_H, \pi_H)$. Observe that, assuming that we have fixed coordinates so that $p_H = (0, 0, 0)$ we also know, arguing as in the proof of Proposition 6.4, that, if we set $\bar{B} := B_{8r_L}(p_{HL}, \pi_H)$, then

$$\|\boldsymbol{\eta} \circ \bar{f}_{HL}\|_{L^\infty(\bar{B})} \leq C \mathbf{m}_0^{1/4} d(H)^{1+\gamma_0/2}.$$

In particular, applying (6.44) of Proposition 6.7, we conclude

$$\|\bar{h}_{HL}\|_{C^0(\bar{B})} \leq C\mathbf{m}_0^{1/4} d(H)^{1+\gamma_0/2}.$$

Recalling the height estimate Proposition 5.1(vii) (taking into account that $p_H = 0 \in \text{spt}(T)$) we have

$$\|\boldsymbol{\eta} \circ \bar{f}_H\|_{C^0} \leq C\mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(H)^{1+\beta_2}$$

and thus

$$\|\boldsymbol{\eta} \circ \bar{f}_H\|_{L^1(B_{8r_H}(p_H, \pi_H))} \leq C\mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(H)^{3+\beta_2}$$

Using (6.43) we conclude

$$\|\bar{h}_H\|_{L^1(B_{8r_H}(p_H, \pi_H))} \leq C\mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(H)^{3+\beta_2}$$

and with the help of (6.45) we achieve

$$\|\bar{h}_H\|_{L^\infty(B_{6r_H}(p_H, \pi_H))} \leq C\mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(H)^{1+\beta_2}. \quad (7.18)$$

Using the estimates upon Ψ_{p_H} and the fact that $\Psi_{p_H}(0) = 0$, $D\Psi_{p_H}(0) = 0$ we easily conclude

$$\|h_H\|_{L^\infty(B_{6r_H}(p_H, \pi_H))} \leq C\mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(H)^{1+\beta_2}, \quad (7.19)$$

which in fact is (7.1).

We next estimate the derivatives of h_{HL} . Let $E := \mathbf{E}(T_L, \mathbf{C}_{32r_L}(p_L, \pi_H))$ and recall the discussion above and the estimates of [11, Theorem 1.5] to conclude that

$$\int_{\bar{B}} |Df_{HL}|^2 \leq C_0 r_L^2 E \leq C\mathbf{m}_0 d(H)^{2\gamma_0-2+2\delta_1} \ell(L)^{4-2\delta_1}. \quad (7.20)$$

We thus conclude that $\|D\boldsymbol{\eta} \circ \bar{f}_{HL}\|_{L^2(\bar{B})} \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0-1+\delta_1} \ell(H)^{2-\delta_1}$. An analogous estimate can be derived for $\|\boldsymbol{\eta} \circ \bar{f}_{HL}\|_{L^2(\bar{B})}$ using the L^∞ bound already derived. We can now use Lemma 6.6 to estimate $\|D\bar{h}_{HL}\|_{L^2} \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0-1+\delta_1} \ell(H)^{2-\delta_1}$ (recall the estimate on \mathcal{F}_H derived in the previous section) and thus $\|D\bar{h}_{HL}\|_{L^1(\bar{B})} \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0-1+\delta_1} \ell(H)^{3-\delta_1}$. If we differentiate the equation defining \bar{h}_{HL} we then find

$$\mathcal{L}_H \partial_j \bar{h}_{HL}^i = (\mathbf{L}_3)_j^i$$

and we can thus apply (6.45) of Proposition 6.7, with $v = D\bar{h}_{HL}$, to conclude that

$$\|D^l \bar{h}_{HL}\|_{L^\infty(B_{6r_L})} \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0-1+\delta_1} \ell(L)^{2-\delta_1-l} \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0+1-l} \quad \text{for } l = 1, 2, 3, 4, \quad (7.21)$$

where we used that, for the starting cubes $L = H_{N_0}$, $d(H) = d(L) \leq C(M_0)\ell(L)$.

Arguing as above we achieve a similar estimate for h_{HL} . We observe however that the condition $D\Psi_{p_H}(0, 0) = 0$ plays an important role (assuming to have moved the origin so that it coincides with p_H). For instance we have

$$Dh_{HL} = (D\bar{h}_{HL}, D_x \Psi_{p_H}(x, \bar{h}_{HL}(x)) + D_y \Psi_{p_H}(x, \bar{h}_{HL}(x)) D\bar{h}_{HL}(x)).$$

Thus we can easily estimate

$$|Dh_{HL}(x)| \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0} + |D\Psi_{p_H}(x, \bar{h}_{HL}(x))|. \quad (7.22)$$

Now, the second summand in (7.22) is estimated with $\|D^2\Psi_{p_H}\|\ell(H) \leq C\mathbf{m}_0^{1/2}d(H)$, precisely because $D\Psi_{p_H}(0,0) = 0$.

It follows by (7.14), (7.15), (7.21) and the triangular inequality that we have the uniform estimates

$$\|Dh_H\|_{C^0(B)} + d(H)\|D^2h_H\|_{C^0(B)} + d(H)^2\|D^3h_H\|_{C^\kappa(B)} \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0} \quad (7.23)$$

Recall now that, by Proposition 5.1 we have $|\pi_H - \pi_0| \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0}$. We can therefore apply [9, Lemma B.1] to the rescaling $k_H(x) := d(H)^{-1}h_H(d(H)x)$ and conclude the existence of the interpolating functions g_H and that the estimates (7.3) hold. Moreover, combining (7.1) with [9, Lemma B.1] we also get

$$\|g_H - \mathbf{p}_{\pi_0}^\perp(p_H)\|_{C^0} \leq C\mathbf{m}_0^{1/4}d(H)^{\gamma_0/2}\ell(H). \quad (7.24)$$

On the other hand $\mathbf{p}_{\pi_0}(p_H) = z_H$ and since $p_H \in \text{spt}(T_H) \cup \mathbf{V}_{u,a}$, we conclude immediately $|\mathbf{p}_{\pi_0}^\perp(p_H) - u(z_H, w_H)| \leq c_s d(H)^a$. Combining this last estimate with (7.24) we conclude (7.4).

Finally, recall that, if $E := \mathbf{E}(T, \mathbf{C}_{32r_H}(p_H, \pi_H))$, then

$$\int_{B_{8r_H}(p_H, \pi_H)} |Df_H|^2 \leq C\mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_2} \ell(H)^{4 - 2\delta_1},$$

from which clearly we get

$$\int_{B_{8r_H}(p_H, \pi_H)} |D\boldsymbol{\eta} \circ f_H|^2 \leq C\mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_1} \ell(H)^{4 - 2\delta_1}.$$

By the last estimate in Lemma 6.6 (recalling again the bounds on \mathcal{F}_H and $\boldsymbol{\eta} \circ f_H$), we deduce

$$\int_{B_{8r_H}(p_H, \pi_H)} |D\bar{h}_H|^2 \leq C\mathbf{m}_0 d(H)^{2\gamma_0 - 2 + 2\delta_1} \ell(H)^{4 - 2\delta_1}.$$

Thus we conclude the existence of a point $p \in B_{8r_H}(p_H, \pi_H)$ such that

$$|D\bar{h}_H(p)| \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0 - 1 + \delta_1} \ell(H)^{1 - \delta_1}. \quad (7.25)$$

Assume now to be in the case (a) or (c) of Definition 0.1 and shift the origin so that it coincides with p_H . Given the bound (7.23) on $D^2\bar{h}_H$ we then conclude

$$|D\bar{h}_H(0)| \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0 - 1 + \delta_1} \ell(H)^{1 - \delta_1}$$

and, since $D\Psi_{p_H}(0) = 0$, we also have $|Dh_H(0)| \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0 - 1 + \delta_1} \ell(H)^{1 - \delta_1}$. Hence using the bound on $\|D^2h_H\|_0$, we finally conclude $|D\bar{h}_H(q)| \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0 - 1 + \delta_1} \ell(H)^{1 - \delta_1}$ for all q 's in the domain of \bar{h}_H . This implies the estimate

$$|T_p \mathbf{G}_{h_H} - \pi_H| \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0 - 1 + \delta_1} \ell(H)^{1 - \delta_1} \quad \forall p \in \text{Gr}(h_H) \cap \mathbf{C}_{6r_H}(p_H, \pi_H).$$

Since however $\text{Gr}(g_H) \subset \text{Gr}(h_H) \cap \mathbf{C}_{6r_H}(p_H, \pi_H)$, we then conclude (7.5). The same conclusion for case (b) in Definition 0.1 follows directly from (7.25).

7.2. Proof of (iii) and (iv). We observe first that (iv) is a rather simple consequence of (iii). Indeed fix H and L as in the statements and consider $H = H_i \subset H_{i-1} \subset \dots \subset H_{N_0} \in \mathcal{C}^{N_0}$ and $L = L_j \subset L_{j-1} \subset \dots \subset L_{N_0} \in \mathcal{C}^{N_0}$ so that H_l is the father of H_{l+1} and L_l is the father of L_{l+1} . We distinguish two cases:

- (A) If $H_{N_0} \cap L_{N_0} \neq \emptyset$, we let i_0 be the smallest index so that $H_{i_0} \cap L_{i_0} \neq \emptyset$;
- (B) $H_{N_0} \cap L_{N_0} = \emptyset$.

In case (A) observe that $\max\{\ell(H_{i_0}), \ell(L_{i_0})\} \leq d((z_H, w_H), (z_L, w_L)) := d$. On the other hand, recalling that $d(H_l) = d(H)$, $d(L_i) = d(L)$ and $d(L) \leq 2d(H)$, by (iii) with $l = 3$ we have

$$\begin{aligned} & |D^3 g_H(z_H, w_H) - D^3 g_{H_{i_0}}(z_{H_{i_0}}, w_{H_{i_0}})| \leq \sum_{l=i_0}^{i-1} |D^3 g_{H_l}(z_{H_l}, w_{H_l}) - D^3 g_{H_{l+1}}(z_{H_{l+1}}, w_{H_{l+1}})| \\ & \leq C \mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} \ell(H_{i_0})^\kappa \sum_{l=i_0}^{i-1} 2^{(i_0-l)\kappa} \leq C \mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} d^\kappa \\ & |D^3 g_L(z_L, w_L) - D^3 g_{L_{i_0}}(z_{L_{i_0}}, w_{L_{i_0}})| \leq \sum_{l=i_0}^{j-1} |D^3 g_{L_l}(z_{L_l}, w_{L_l}) - D^3 g_{L_{l+1}}(z_{L_{l+1}}, w_{L_{l+1}})| \\ & \leq C \mathbf{m}_0^{1/2} d(L)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} \ell(L_{i_0})^\kappa \sum_{l=i_0}^{j-1} 2^{(i_0-l)\kappa} \leq C \mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} d^\kappa \\ & |D^3 g_{L_{i_0}}(z_{L_{i_0}}, w_{L_{i_0}}) - D^3 g_{H_{i_0}}(z_{H_{i_0}}, w_{H_{i_0}})| \leq C \mathbf{m}_0^{1/2} d(H_{i_0})^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} \ell(H_{i_0})^\kappa \\ & \leq \mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} d^\kappa. \end{aligned}$$

The triangle inequality implies then the desired estimate.

In case (B) we first notice that by the very same argument we have the estimates

$$\begin{aligned} |D^3 g_H(z_H, w_H) - D^3 g_{H_{N_0}}(z_{H_{N_0}}, w_{H_{N_0}})| & \leq C \mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} d^\kappa \\ |D^3 g_L(z_L, w_L) - D^3 g_{L_{N_0}}(z_{L_{N_0}}, w_{L_{N_0}})| & \leq C \mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} d^\kappa. \end{aligned}$$

Next we find a chain of cubes $H_{N_0} = J_0, J_1, \dots, J_N = L_{N_0}$, all distinct and belonging to \mathcal{S}^{N_0} , so that

- $d(H) \leq d(J_l) \leq d(L) \leq 2d(H)$;
- $J_l \cap J_{l+1} \neq \emptyset$ and thus $\ell(H_{N_0}) \leq \ell(J_l) \leq \ell(L_{N_0})$;
- N is smaller than a constant $C(N_0, Q)$.

Using again (iii) and arguing as above we conclude

$$\begin{aligned} & |D^3 g_{H_{N_0}}(z_{H_{N_0}}, w_{H_{N_0}}) - D^3 g_{L_{N_0}}(z_{L_{N_0}}, w_{L_{N_0}})| \\ & \leq \sum_{l=1}^N |D^3 g_{J_l}(z_{J_l}, w_{J_l}) - D^3 g_{J_{l-1}}(z_{J_{l-1}}, w_{J_{l-1}})| \leq CN \mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0 - \beta_2 - 2} d^\kappa. \end{aligned}$$

Again, using the triangular inequality we conclude (iv).

We now come to (iii). Fix therefore two cubes H and L as in the statement and set $r := r_L$. Observe that, by (ii) and [9, Lemma C.2], it suffices to show that $\|g_H - g_L\|_{L^1(B)} \leq C\mathbf{m}_0^{1/2}d(H)^{\gamma_0/2-2}\ell(H)^{5+\kappa}$. where $B = B_r(z_L, \pi_0)$. Consider now the two corresponding tilted interpolating functions, namely h_L and h_H . Given the estimate on the Lipschitz constant and the C^0 norm upon h_L proved in the previous paragraph, we can find a function $\hat{h}_L : B_{7r}(p_{HL}, \pi_H) \rightarrow \pi_H^\perp$ such that $\mathbf{G}_{\hat{h}_L} = \mathbf{G}_{h_L} \lrcorner \mathbf{C}_{6r}(p_L, \pi_H)$ applying [9, Lemma B.1] (in this paragraph $\hat{\cdot}$ will always denote the reparametrization on π_H). By (i) clearly $\mathbf{G}_{\hat{h}_L} \lrcorner \mathbf{C}_r(z_L, \pi_0) = \mathbf{G}_{g_L}$. We can therefore apply [9, Lemma B.1] to conclude that

$$\|g_H - g_L\|_{L^1(B)} \leq C\|h_H - \hat{h}_L\|_{L^1(B_{5r}(p_L, \pi_H))}.$$

Consider next the tilted interpolating function h_{HL} and observe that, by (7.12) and the usual estimates on Ψ , we know

$$\|h_H - h_{HL}\|_{L^1(B_{5r}(p_H, \pi_H))} \leq C\mathbf{m}_0^{1/2}d(H)^{2(1+\beta_0)\gamma_0-\beta_2-2}\ell(H)^{5+\beta_2}.$$

Indeed, by (6.43) and the usual estimates on Ψ , it is enough to see that

$$\begin{aligned} \|\boldsymbol{\eta} \circ f_{HH} - \boldsymbol{\eta} \circ f_{HL}\|_{L^1(B_{5r}(p_H, \pi_H))} &\leq \|\boldsymbol{\eta} \circ f_{HH} - \boldsymbol{\eta} \circ f_{HL}\|_{L^\infty(B_{5r}(p_H, \pi_H))} |B_{5r}(p_H, \pi_H) \setminus \bar{K}| \\ &\leq C\mathbf{m}_0^{1+\beta_0+1/4}d(H)^{\gamma_0/2-\beta_2+2(1+\beta_0)\gamma_0-2}\ell(H)^{5+\beta_2}, \end{aligned}$$

where, as above, we used the estimates of [11, Theorem 1.5] on the oscillation of f_{HH} and f_{HL} (with \bar{K} the projection of $\text{Gr}(f_{HH}) \cap \text{Gr}(f_{HL})$ onto $p_{HL} + \pi_H$) and $B_{5r}(p_H, \pi_H) \subset B_{8r}(p_{HL}, \pi_H)$. Hence, since $\beta_2 \geq \kappa$, we are reduced to show

$$\|h_{HL} - \hat{h}_L\|_{L^1(B_{5r}(p_H, \pi_H))} \leq C\mathbf{m}_0^{1/2}d(H)^{2(1+\beta_0)\gamma_0-\beta_2-2}\ell(H)^{5+\kappa}. \quad (7.26)$$

In turn, consider the π_H -approximating function f_{HL} and the π_L -approximating function $f_{LL} = f_L$. In the $\pi_H \times \varkappa_H \times T_{p_H}\Sigma^\perp$ coordinates we set

$$\mathbf{f}_{HL}(x) = (\mathbf{p}_{\varkappa_H}(\boldsymbol{\eta} \circ f_{HL}(x)), \Psi_{p_H}(x, \mathbf{p}_{\varkappa_H}(\boldsymbol{\eta} \circ f_{HL}(x))))$$

and recall that, by Proposition 6.7, we have

$$\|h_{HL} - \mathbf{f}_{HL}\|_{L^1(B_{8r_L}(p_{HL}, \pi_H))} \leq C\mathbf{m}_0^{1/2}d(L)^{2(1+\beta_0)\gamma_0-\beta_2-2}\ell(L)^{5+\beta_2}. \quad (7.27)$$

Similarly, in the $\pi_L \times \varkappa_L \times T_{p_L}\Sigma^\perp$ coordinates we set

$$\mathbf{f}_L(x) = (\mathbf{p}_{\varkappa_L}(\boldsymbol{\eta} \circ f_L(x)), \Psi_{p_L}(x, \mathbf{p}_{\varkappa_L}(\boldsymbol{\eta} \circ f_L(x))))$$

and get

$$\|h_L - \mathbf{f}_L\|_{L^1(B_{8r_L}(p_L, \pi_L))} \leq C\mathbf{m}_0^{1/2}d(L)^{2(1+\beta_0)\gamma_0-\beta_2-2}\ell(L)^{5+\beta_2}.$$

Next we denote by $\hat{\mathbf{f}}_L$ the map $\hat{\mathbf{f}}_L : B_{6r_L}(p_{HL}, \pi_H) \rightarrow \pi_H^\perp$ such that $\mathbf{G}_{\hat{\mathbf{f}}_L} = \mathbf{G}_{\mathbf{f}_L} \lrcorner \mathbf{C}_{6r_L}(p_L, \pi_H)$ and we use again [9, Lemma B.1] to infer

$$\|\hat{h}_L - \hat{\mathbf{f}}_L\|_{L^1(B_{6r_L}(p_{HL}, \pi_H))} \leq C\|h_L - \mathbf{f}_L\|_{L^1(B_{8r_L}(p_L, \pi_L))} \leq C\mathbf{m}_0^{1/2}d(L)^{2(1+\beta_0)\gamma_0-\beta_2-2}\ell(L)^{5+\beta_2}. \quad (7.28)$$

In view of (7.27) and (7.28), (7.26) is then reduced to

$$\|\mathbf{f}_{HL} - \hat{\mathbf{f}}_L\|_{L^1(B_{5r_L}(p_{HL}, \pi_H))} \leq C\mathbf{m}_0^{1/2}d(H)^{2(1+\beta_0)\gamma_0-\beta_2-2}\ell(H)^{5+\kappa}. \quad (7.29)$$

Consider now the map $\hat{f}_L : \mathbf{B}_{6r_L}(p_{HL}, \pi_H) \rightarrow \mathcal{A}_Q(\pi_H^\perp)$ such that $\mathbf{G}_{\hat{f}_L} = \mathbf{G}_{f_L} \llcorner \mathbf{C}_{6r_L}(p_L, \pi_H)$. Let A and \hat{A} be the projections on $p_H + \pi_H = p_{HL} + \pi_H$ of the Borel sets $\text{Gr}(f_{HL}) \setminus \text{spt}(T)$ and $\text{Gr}(\hat{f}_L) \setminus \text{spt}(T) \subset \text{Gr}(f_L) \setminus \text{spt}(T)$. We know that

$$\begin{aligned} |A \cup A'| &\leq \|\mathbf{G}_{f_{HL}} - T\|(\mathbf{C}_{8r_L}(p_L, \pi_H)) + \|\mathbf{G}_{f_L} - T\|(\mathbf{C}_{8r_L}(p_L, \pi_L)) \\ &\leq C\mathbf{m}_0^{1+\beta_0} d(H)^{2(1+\beta_0)\gamma_0-2} \ell(H)^4. \end{aligned}$$

On the other hand, thanks to the height bound Proposition 5.1(vii) and the estimates of [11, Theorem 1.5], that $\|\boldsymbol{\eta} \circ f_{HL} - \boldsymbol{\eta} \circ \hat{f}_L\|_{L^\infty(B_{7r_L}(p_{HL}, \pi_H))} \leq C\mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(H)^{1+\beta_2}$. We thus conclude that

$$\|\boldsymbol{\eta} \circ f_{HL} - \boldsymbol{\eta} \circ \hat{f}_L\|_{L^1(B_{6r_L}(p_{HL}, \pi_H))} \leq C\mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0-\beta_2-2} \ell(H)^{5+\beta_2}.$$

Define in the $\pi_H \times \varkappa_H \times T_{p_H} \Sigma^\perp$ coordinates the function

$$\mathbf{g}(x) := (\mathbf{p}_{\varkappa_H}(\boldsymbol{\eta} \circ \hat{f}_L(x)), \Psi_{p_H}(x, \mathbf{p}_{\varkappa_H}(\boldsymbol{\eta} \circ \hat{f}_L(x)))).$$

We can thus conclude that

$$\|\mathbf{f}_{HL} - \mathbf{g}\|_{L^1(B_{6r_L}(p_{HL}, \pi_L))} \leq C\mathbf{m}_0^{1/2} d(L)^{2(1+\beta_0)\gamma_0-\beta_2-2} \ell(L)^{5+\beta_2}. \quad (7.30)$$

Thus, (7.29) is now reduced to

$$\|\mathbf{g} - \hat{\mathbf{f}}_L\|_{L^1(B_{5r_L}(p_{HL}, \pi_H))} \leq C\mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0-\beta_2-2} \ell(H)^{5+\kappa}. \quad (7.31)$$

Denoting by An the distance $|\pi_H - \pi_L|$, by \hat{B} the ball $B_{6r_L}(p_{HL}, \pi_H)$ and by \tilde{B} the ball $B_{8r_L}(p_L, \pi_L)$, we then have, by [9, Lemma 5.6]

$$\|\mathbf{g} - \hat{\mathbf{f}}_L\|_{L^1(\hat{B})} \leq C_0(\text{osc}(f_L) + r_L \text{An}) \left(\int |Df_L|^2 + r_L^2 (\|D\Psi_{p_L}\|_{C^0(\tilde{B})}^2 + \text{An}^2) \right).$$

Recall that $D\Psi_{p_L}(p_L) = 0$ and thus $\|D\Psi_{p_L}\|_{C^0(\tilde{B})}^2 \leq C_0\mathbf{m}_0 r_L^2$. Recalling the estimate of Proposition 5.1 on $|\pi_H - \pi_L|$ and upon the Dirichlet energy of f_L (namely (6.12)), we then conclude

$$\int |Df_L|^2 + r_L^2 (\|D\Psi_{p_L}\|_{C^0(\tilde{B})}^2 + \text{An}^2) \leq C\mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell(H)^{4-2\delta_1}.$$

On the other hand

$$\text{osc}(f_L) + r_L \text{An} \leq C\mathbf{m}_0^{1/4} d(H)^{\gamma_0/2-\beta_2} \ell(H)^{1+\beta_2}.$$

Thus (7.31) follows by our choice of the various parameters, in particular $\beta_2 - 2\delta_1 \geq \beta_2/4 = \kappa$.

8. PROOF OF THEOREM 3.11

8.1. Proof of (i). As in all the proofs so far, we will use C_0 for geometric constants and C for constants which depend upon M_0, N_0, C_e and C_h . Define $\chi_H := \vartheta_H / (\sum_{L \in \mathcal{P}^j} \vartheta_L)$ for each $H \in \mathcal{P}^j$ (cf. Definition 3.10) and observe that

$$\sum_{H \in \mathcal{P}^j} \chi_H = 1 \quad \text{on } \mathcal{A}_k \quad \forall k \in \mathbb{N} \quad \text{and} \quad \|\chi_H\|_{C^i} \leq C_0 \ell(H)^{-i} \quad \forall i \in \{0, 1, 2, 3, 4\}. \quad (8.1)$$

Fix any $H \in \mathcal{P}^j$ and let k be such that $H \subset \mathcal{A}_k$. Set $\mathcal{P}^j(H) := \{L \in \mathcal{P}^j : L \cap H \neq \emptyset\} \setminus \{H\}$ for each $H \in \mathcal{P}^j$. By construction $\frac{1}{2}\ell(L) \leq \ell(H) \leq 2\ell(L)$ and $2^{-k-1} \leq d(L) \leq 2^{-k+1}$ for every $L \in \mathcal{P}^j(H)$. Moreover the cardinality of $\mathcal{P}^j(H)$ is at most 12. Fix a point $p = (z, w) \in H$ and observe that $C_0^{-1}2^{-k} \leq |z| \leq C_0 2^{-k}$. From (7.2) of Proposition 7.1 we then conclude

$$|\hat{\varphi}_j(z, w)| \leq C\mathbf{m}_0^{1/4}d(H)^{1+\gamma_0/2} \leq C\mathbf{m}_0^{1/4}|z|^{1+\gamma_0/2}.$$

Recall now that $\Psi(0) = 0$, $D\Psi(0) = 0$ and $\|D^2\Psi\|_{C^0} \leq C\mathbf{m}_0^{1/2}$. Considering that

$$\varphi_j(z, w) = (\bar{\varphi}_j(z, w), \Psi(z, \bar{\varphi}_j(z, w))) \quad (8.2)$$

(where $\bar{\varphi}_j(z, w)$ is the vector consisting of the first \bar{n} components of $\hat{\varphi}_j(z, w)$), we easily conclude

$$|\varphi_j(z, w)| \leq C\mathbf{m}_0^{1/4}|z|^{1+\gamma_0/2} + C\|D^2\Psi\|_{C^0}|z|^2 \leq C\mathbf{m}_0^{1/4}|z|^{1+\gamma_0/2}.$$

This gives (3.16) and the continuity of φ_j , since by definition $\varphi_j(0, 0) = 0$.

For $(z, w) \in H$ we next write

$$\hat{\varphi}_j(z, w) = \left(g_H \chi_H + \sum_{L \in \mathcal{P}^j(H)} g_L \chi_L \right) (z, w) = g_H(x) + \sum_{L \in \mathcal{P}^j(H)} (g_L - g_H) \chi_L(z, w), \quad (8.3)$$

because H does not meet the support of ϑ_L for any $L \in \mathcal{P}^j$ which does not meet H . Using the Leibniz rule, (8.1) and the estimates of Proposition 7.1, for $l \in \{1, 2, 3\}$ we get

$$\begin{aligned} & \|D^l \hat{\varphi}_j - D^l g_H\|_{C^0(H)} + C_0 \sum_{0 \leq i \leq l} \sum_{L \in \mathcal{P}^j(H)} \|g_L - g_H\|_{C^i(H)} \ell(L)^{i-l} \\ & \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0+1-l} + C\mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0-\beta_2-2} \sum_{0 \leq i \leq l} \ell(H)^{3+\kappa-i} \ell(H)^{i-l} \\ & \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0+1-l}. \end{aligned}$$

Again using the formula (8.2) and the estimate $\|\Psi\|_{C^{3,\varepsilon_0}} \leq \mathbf{m}_0^{1/2}$ (together with $D\Psi(0) = 0$ and $\Psi(0) = 0$) we easily reach (3.17). In fact we can also see that

$$\|D^l \varphi_j - D^l g_H\|_{C^0(H)} \leq C\mathbf{m}_0^{1/2} d(H)^{2(1+\beta_0)\gamma_0-\beta_2-2} \ell(H)^{3+\kappa-l}. \quad (8.4)$$

With an argument entirely similar we obtain

$$[D^3 \varphi_j]_{\kappa, H} \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0-2}. \quad (8.5)$$

Thus, pick any two points $(z, w), (z', w') \in \mathcal{A}_k$. If they belong to the same cube $H \in \mathcal{P}^j$ with $H \subset \mathcal{A}_k$, then

$$\begin{aligned} |D^3 \varphi_j(z, w) - D^3 \varphi_j(z', w')| & \leq C\mathbf{m}_0^{1/2} d(H)^{-2} d((z', w'), (z, w))^\kappa \\ & \leq C\mathbf{m}_0^{1/2} 2^{2k} d((z', w'), (z, w))^\kappa. \end{aligned} \quad (8.6)$$

If they do not belong to the same cube, then let $H, L \in \mathcal{P}^j$ be two cubes contained in \mathcal{A}_k such that $(z, w) \in H$ and $(z', w') \in L$. Next observe that, by our choice of the cut-off

functions ϑ_J , $\varphi_j = g_H$ in a neighborhood of (z_H, w_H) and $\varphi_j = g_L$ in a neighborhood of (z_L, w_L) . We can then estimate, using Proposition 7.1(iv) and (8.5)

$$\begin{aligned} & |D^3\varphi_j(z, w) - D^3\varphi_j(z', w')| \leq |D^3\varphi_j(z, w) - D^3g_H(z_H, w_H)| \\ & \quad + |D^3g_H(z_H, w_H) - D^3g_L(z_L, w_L)| + |D^3\varphi_j(z_L, w_L) - D^3\varphi_j(z', w')| \\ & \leq C\mathbf{m}_0^{1/2}d(H)^{-2}(\ell(H)^\kappa + d((z_H, w_H), (z_L, w_L))^\kappa + \ell(L)^\kappa) \\ & \leq C\mathbf{m}_0^{1/2}d(H)^{-2}d((z, w), (z', w'))^\kappa \leq C\mathbf{m}_0^{1/2}2^{2k}d((z', w'), (z, w))^\kappa. \end{aligned} \quad (8.7)$$

From (8.6) and (8.7) we conclude (3.18) and thus the proof of Theorem 3.11(i).

8.2. Proof of (ii). The first statement is an obvious consequence of the construction algorithm: indeed note that, if i, j, k, L and H are as in the statement then $\mathcal{P}^j(L) = \mathcal{P}^k(L)$ and moreover $\chi_J = 0$ on H for any $J \in \mathcal{P}^j \setminus \mathcal{P}^j(L)$ and for any $J \in \mathcal{P}^k \setminus \mathcal{P}^k(L)$. Then it turns out that $\hat{\varphi}_j = \hat{\varphi}_k$ on H , which in turn obviously implies that φ_j and φ_k coincide on H .

As for the second statement (ii), if we can show that there is a uniform limit φ for φ_j , the C^3 convergence and the regularity of φ will follow from the estimates of point (i). Fix a point $(z, w) \neq 0$ and let $H \in \mathcal{P}^j$ which contains it. If $H \in \mathcal{W}^i$ and $i \leq j - 2$, then $\hat{\varphi}_{j+1}$ and $\hat{\varphi}_j$ coincide on it. Otherwise we can assume that $H \in \mathcal{C}^{j-1} \cup \mathcal{C}^j$. In this case we can estimate

$$|\varphi_j(z, w) - \varphi_j(z_H, w_H)| \leq C\mathbf{m}_0^{1/2}d(H)^\kappa\ell(H) \leq C2^{-j}.$$

A similar estimate holds for φ_{j+1} : notice that we can choose $L \in \mathcal{P}^{j+1}$ such that $(z, w) \in L$ and L is either H or a son of H . Moreover, we can estimate

$$|\varphi_{j+1}(z, w) - \varphi_{j+1}(z_L, w_L)| \leq C2^{-j}.$$

Next, recall that $\varphi_j(z_H, w_H) = g_H(z_H, w_H)$ and that $\varphi_{j+1}(z_L, w_L) = g_L(z_L, w_L)$. Since moreover $L = H$ or L is a son of H , by Proposition 7.1 we achieve

$$|\varphi_{j+1}(z_L, w_L) - \varphi_j(z_H, w_H)| \leq C_0\|Dg_H\|_{C^0}\ell(H) + C\|g_H - g_L\|_{C^0} \leq C2^{-j}.$$

Summarizing, we conclude that

$$\|\varphi_{j+1} - \varphi_j\|_{C^0} \leq C2^{-j}.$$

The latter estimate gives that φ_j is a Cauchy sequence in C^0 and thus that it converges uniformly to some φ .

We record in particular an important consequence which will be useful later: If $L \in \mathcal{W}$, then

$$\|\varphi - g_L\|_{C^j(L)} \leq C\mathbf{m}_0^{1/2}d(L)^{2(1+\beta_0)\gamma_0 - \beta_2}\ell(L)^{3+\kappa}. \quad (8.8)$$

Indeed we have already shown the estimate (8.4) (which corresponds to (8.8) with φ_j in place of φ) whenever $j \geq k$ and $L \in \mathcal{W}^k$, but on the other hand we know now that $\varphi = \phi_j$ on L for j large enough. Finally, recall that the graph of g_L coincides with the graph of h_L and that the graph of φ coincide with that of g_L in an open subset of L . By the estimates on h_L , this implies that on such set the distance between any tangent π to the graph of

φ and π_L is bounded by $\mathbf{m}_0^{1/2}$. Given the bounds on the second derivative of φ we easily conclude that

$$|\pi - \pi_L| \leq C\mathbf{m}_0^{1/2}d(L)^{\gamma_0/2-1}\ell(L) \quad \forall L \in \mathscr{W} \text{ and any tangent } \pi \text{ to } \text{Gr}(\varphi|_{B_{64\ell(L)}(p_L)}). \quad (8.9)$$

8.3. Proof of (iii). Observe first that, if (z, w) does not belong to some $H \in \mathscr{W}$, then $\Phi(z, w)$ is necessarily a point in the support of T and we can estimate

$$|\varphi(z, w) - u(z, w)| \leq c_s|z|^a. \quad (8.10)$$

To see this note that for every $j \geq N_0$ there is $H_j \in \mathscr{S}^j$ such that $(z, w) \in H_j$. Observe that $\varphi_j(z_{H_j}, w_{H_j}) = g_{H_j}(z_{H_j}, w_{H_j})$ and that

$$\lim_{j \rightarrow \infty} (d((z_{H_j}, w_{H_j}), (z, w)) + |g_{H_j}(z_{H_j}, w_{H_j}) - \varphi(z, w)|) = 0.$$

But we also have, by (7.1),

$$\lim_{j \rightarrow \infty} |(z_{H_j}, g_{H_j}(z_{H_j}, w_{H_j})) - p_{H_j}| = 0.$$

On the other hand, since

$$|p_{H_j} - (z_{H_j}, u(z_{H_j}, w_{H_j}))| \leq c_s|z_{H_j}|^a,$$

we then conclude (8.10) taking the limit in $j \rightarrow \infty$.

From now on we therefore assume that $(z, w) \in H$ for some $H \in \mathscr{W}$.

Step 1. In this step we show that

$$64r_H \leq \frac{1}{2}d(H)^{(b+1)/2}. \quad (8.11)$$

In fact we claim that this is the case for any $H \in \mathscr{W}$. First of all we observe that it suffices to show it for $H \in \mathscr{W}_e \cup \mathscr{W}_h$: given indeed any $H \in \mathscr{W}_n$ we find a chain of cubes $H = H_l, H_{l-1}, \dots, H_i$ with the properties that

- $H_k \cap H_{k+1} \neq \emptyset$;
- $\ell(H_k) = 2\ell(H_{k+1})$;
- $H_l \in \mathscr{W}_n$ for any $l \geq i + 1$ and $H_i \in \mathscr{W}_e \cup \mathscr{W}_h$.

It is easy to see that, provided N_0 is larger than a geometric constant, $\frac{1}{2}d(H) \leq d(H_i) \leq 2d(H)$. Since $\ell(H) \leq \frac{1}{2}\ell(H_i)$, it suffices to show $64r_H \leq \frac{1}{16}d(H_i)^{(b+1)/2}$.

Next, assume $H \in \mathscr{W}_e$. Then we know that

$$\mathbf{E}(T_H, \mathbf{B}_H) > C_e\mathbf{m}_0d(H)^{2\gamma_0-2+2\delta_1}\ell(H)^{2-2\delta_1} \geq C_e\mathbf{m}_0^{1/2}d(H)^{2\gamma_0-2}\ell(H)^2. \quad (8.12)$$

Now recall that $d = |z_H| \leq 2\sqrt{2}d(H)$ and that, for N_0 large enough depending on M_0 , we have $64r_H \leq \frac{d}{2}$. Moreover, if r_H were larger than $\frac{1}{16}d^{(b+1)/2}$, then by (1.9) there would be a π such that (recall that $C_i^2 \leq \mathbf{m}_0$)

$$\mathbf{E}(T_H, \mathbf{B}_H, \pi) \leq \mathbf{m}_0d(H)^{2\gamma-2}r_H^2.$$

By Lemma 5.2(i), we then would have

$$\mathbf{E}(T_H, \mathbf{B}_H) \leq C_0\mathbf{m}_0d(H)^{2\gamma-2}r_H^2 + C_0\mathbf{m}_0r_H^2 \leq C(M_0)\mathbf{m}_0d(H)^{2\gamma_0-2}\ell(H)^2 \quad (8.13)$$

(recall that $\gamma_0 < \gamma$). Thus we conclude that (8.13) contradicts (8.12), provided $C_e \geq C(M_0)$.

It remains to show (8.11) when $H \in \mathscr{W}_h$. Assume therefore that $r_H \geq \frac{1}{2}d^{(b+1)/2}$. Notice that, by (1.9), we know

$$\mathbf{E}(T_H, \mathbf{B}_H, \pi_H) = \mathbf{E}(T_H, \mathbf{B}_H) \leq \bar{C} \mathbf{m}_0 d(H)^{2\gamma-2} \ell(H)^2 \quad (8.14)$$

where the constant \bar{C} does not depend on H . We thus conclude from Lemma 5.2(iii) that

$$|\pi - \pi_H| \leq \bar{C} \mathbf{m}_0^{1/2} d(H)^{\gamma-1} \ell(H). \quad (8.15)$$

We next wish to estimate $\mathbf{h}(T_H, \mathbf{B}_H, \pi)$. π is tangent to \mathbf{G}_u at $q_H := (z_H, u(z_H, w_H))$. Recall that $|p_H - q_H| \leq c_s |d|^\alpha$. Fix a point $p \in \mathbf{B}_H \cap \text{spt}(T_H)$ and recall that there is a point p' in $\text{Gr}(u) \cap \mathbf{V}_H$ such that $|p - p'| \leq 2^a \mathbf{m}_0^{1/2} d^\alpha$, since $|\mathbf{p}_{\pi_0}(p')| \geq \frac{d}{2}$. Obviously $|\mathbf{p}_\pi(p')| \leq 2r_H$ and since π is tangent to $\text{Gr}(u)$ at q_H , we have the estimate

$$|\mathbf{p}_\pi^\perp(p')| \leq C_0 \mathbf{m}_0^{1/2} d^{\alpha-1} |\mathbf{p}_\pi(p')|^2 \leq \bar{C} \mathbf{m}_0^{1/2} d(H)^{\alpha-1} \ell(H)^2.$$

We can therefore estimate

$$|\mathbf{p}_\pi^\perp(p)| \leq \bar{C} \mathbf{m}_0^{1/2} d(H)^{\alpha-1} \ell(H)^2 + \bar{C} \mathbf{m}_0^{1/2} d(H)^a.$$

This implies the estimate

$$\mathbf{h}(T_H, \mathbf{B}_H, \pi) \leq \bar{C} \mathbf{m}_0^{1/2} d(H)^{\alpha-1} \ell(H)^2 + \bar{C} \mathbf{m}_0^{1/2} d(H)^a. \quad (8.16)$$

Using now Lemma 5.2 and (8.15) we then estimate

$$\mathbf{h}(T_H, \mathbf{B}_H) \leq \bar{C} \mathbf{m}_0^{1/2} d(H)^{\alpha-1} \ell(H)^2 + \bar{C} \mathbf{m}_0^{1/2} d(H)^a + \bar{C} \mathbf{m}_0^{1/2} d(H)^{\gamma-1} \ell(H)^2, \quad (8.17)$$

where \bar{C} depends upon M_0, N_0 and C_e , but not upon C_h .

On the other hand, since $H \in \mathscr{W}_h$, we then have

$$\mathbf{h}(T_H, \mathbf{B}_H) > C_h \mathbf{m}_0^{1/4} d(H)^{\gamma_0 - \beta_2} \ell(H)^{1 + \beta_2}. \quad (8.18)$$

By our choice of the exponents it is obvious that the first and third summand in (8.17) are smaller than a fraction (say $\frac{1}{4}$) of $C_h \mathbf{m}_0^{1/4} d(H)^{\gamma_0 - \beta_2} \ell(H)^{1 + \beta_2}$, provided that C_h is chosen large enough. Recalling that we are assuming $\ell(H) \geq \bar{C} d(H)^{(1+b)/2}$, to achieve the same conclusion with the second summand we need

$$\frac{1+b}{2}(1+\beta_2) - \beta_2 + \gamma_0 < a.$$

However, since $a > b$, the latter inequality is implied by (3.2), and we reach a contradiction.

Step 2. Recall that we have fixed $(z, w) \in H$ with $H \in \mathscr{W}$ and that our aim is to establish (3.19). From the previous step we know that $\ell(H) \leq C|z|^{(1+b)/2}$ and that $d(H) \leq C_0|z|$. Assume $H \in \mathscr{W}^j$ and pick any $k \geq j+2$. By Theorem 3.11(ii), we know that $\varphi = \varphi_k$ on H . Recalling the arguments above (in particular (7.6)), we also have

$$\|\varphi_j - g_H\|_{C^0} \leq \sum_{L \in \mathscr{P}^k(H)} \|g_H - g_L\|_{C^0} \leq C \mathbf{m}_0^{1/2} d(H)^{\gamma_0 - 2 - \beta_2} \ell(H)^{3 + \kappa} \leq C \mathbf{m}_0^{1/2} d^{\gamma_0 - 2 + (3 + \kappa)(b+1)/2}$$

Since $\gamma_0 - 2 + (3 + \kappa)(b + 1)/2 > \gamma_0 + 3\frac{b}{2} - \frac{1}{2} > \gamma_0 + b$, it suffices then to show that

$$|u(z, w) - g_H(z, w)| \leq C\mathbf{m}_0^{1/4}|z|^{a'}. \quad (8.19)$$

We next consider both u and g_H as two functions defined on π_0 and having defined the ball $B := B_{r_H}(z_H, \pi_0)$, our goal is indeed to show that

$$\|u - g_H\|_{C^0(B)} \leq C\mathbf{m}_0^{1/4}d(H)^{a'}.$$

Recall next that the graph of g_H is indeed a subset of the graph of the tilted interpolating function h_H . If $v : B_{8r_H}(p_H, \pi_H) \rightarrow \pi_H^\perp$ is the function which gives the graph of u in the system of coordinates $\pi_H \times \pi_H^\perp$ and we set $B' := B_{6r_H}(p_H, \pi_H)$, we then claim that it suffices to show

$$\|v - h_H\|_{C^0(B')} \leq C\mathbf{m}_0^{1/4}d(H)^{a'}. \quad (8.20)$$

In fact let $p = (\zeta, g_H(\zeta)) \in \pi_0 \times \pi_0^\perp$ and let $\omega \in \pi_H$ be such that $p = (\omega, h_H(\omega)) \in \pi_H \times \pi_H^\perp$. Consider also $q = (\zeta, u(\zeta))$ and $q' = (\omega, v(\omega))$ and let $\zeta' \in \pi_0$ such that $q' = (\zeta', u(\zeta'))$. Let \mathcal{T} be the triangle with vertices q, p and q' . The angle θ_p at p can be assumed to be small, because $|\pi_H - \pi_0| \leq C\mathbf{m}_0^{1/2}$. On the other hand the angle θ_q at q is close to $\frac{\pi}{2}$, since the Lipschitz constant of u is small. Thus the angle $\theta_{q'}$ is also close to $\frac{\pi}{2}$. From the Law of Sines applied to the triangle \mathcal{T} we then conclude

$$|u(\zeta) - g_H(\zeta)| = |p - q| = \frac{\sin \theta_{q'}}{\sin \theta_q} |p - q'|. \quad (8.21)$$

By choosing ε_2 small we then reach

$$\|u - g_H\|_{C^0(B)} \leq 2\|v - h_H\|_{C^0(B')}.$$

As usual, we assume now to have shifted the origin so that $p_H = 0$. Recall that $\Psi_{p_H}(0) = 0$ and $D\Psi_{p_H}(0) = 0$, so that we can estimate

$$\|h_H - \boldsymbol{\eta} \circ f_H\|_{C^0(B')} \leq C_0\|\bar{h}_H - \boldsymbol{\eta} \circ \bar{f}_H\|_{C^0} + C\mathbf{m}_0^{1/2}\ell(H)^2.$$

Using now Proposition 6.7 we then conclude

$$\|h_H - \boldsymbol{\eta} \circ f_H\|_{C^0(B')} \leq C\mathbf{m}_0 d(H)^{2\gamma_0 - 2} \ell(H)^3 + C\mathbf{m}_0^{1/2} \ell(H)^2. \quad (8.22)$$

Since $\ell(H) \leq d(H)^{(1+b)/2}$, we again see that (8.20) can be reduced to the estimate

$$\|\boldsymbol{\eta} \circ f_H - v\|_{C^0(B')} \leq C\mathbf{m}_0^{1/4}d(H)^{a'}. \quad (8.23)$$

We will in fact show such estimate in the ball $\hat{B} := B_{8r_H}(p_H, \pi_H)$. Consider a point $p \in \text{spt}(T_H) \cap \mathbf{C}_{8r_H}(p_H, \pi_H)$ and let $p = (\zeta, \eta) \in \pi_0 \times \pi_0^\perp$. We also let q be the point $(\zeta, u(\zeta))$ and $q' = (\omega, v(\omega)) \in \pi_H \times \pi_H^\perp$, where $\omega = \mathbf{p}_H(p)$. The argument above can be applied literally to the triangle \mathcal{T} with vertices p, q and q' to conclude that

$$|p - q'| \leq 2|p - q| \leq C\mathbf{m}_0^{1/2}d(H)^a.$$

Recall that, except for a set of points $\omega \in A$ of measure no larger than $C\mathbf{m}_0 d(H)^{2\gamma_0-2}\ell(H)^4$, the slice $\langle T, \mathbf{p}_{\pi_H}, \omega \rangle$ coincides with the slice $\langle \mathbf{G}_{f_H}, \mathbf{p}_{\pi_H}, \omega \rangle$. Thus on the set A we obviously have

$$|\boldsymbol{\eta} \circ f_H(\omega) - v(\omega)| \leq C\mathbf{m}_0^{1/2} d(H)^a.$$

Now, for any point $\omega \notin A$ there is a point $\omega' \in A$ at distance at most $d(H)^{\gamma_0-1}\ell(H)^2$. Since both $\text{Lip}(v)$ and $\text{Lip}(\boldsymbol{\eta} \circ f_H)$ are controlled by $\mathbf{m}_0^{1/2}$, this gives the estimate

$$\|\boldsymbol{\eta} \circ f_H - v\|_{C^0(B')} \leq C\mathbf{m}_0^{1/2} d(H)^a + Cd(H)^{\gamma_0-1}\ell(H)^2.$$

On the other hand, since $\ell(H) \leq Cd(H)^{(b+1)/2}$ and $a > b + \gamma_0$ (recall (3.1)), we easily see that

$$\|\boldsymbol{\eta} \circ f_H - v\|_{C^0(B')} \leq C\mathbf{m}_0^{1/2} d(H)^{\gamma_0+b}.$$

This completes the proof of (8.23) and hence of (3.19)

9. THE CONSTRUCTION OF THE APPROXIMATING MAP N

In this section we prove Corollary 4.1 and Theorem 4.3.

9.1. Proof of Corollary 4.1. Statement (i) is an obvious consequence of (1.3) and (3.19). As for statement (ii), the argument is the same given in the proof of Lemma 2.1 for the existence of the nearest point projection $\mathbf{p} : \mathbf{V}_{u,a} \cap \mathbf{C}_1 \rightarrow \text{Gr}(u)$.

For what concerns (iii), let $L \in \mathscr{W}$, denote by $p_L = (z_L, w_L)$ its center and set $p := \boldsymbol{\Phi}(q)$. We start by observing that $\text{spt}(\langle T, \mathbf{p}, p \rangle) \subset \text{spt}(T_J)$ for the ancestor $J \in \mathscr{C}^{N_0}$ of L , given estimates on u and the definition of T_J . We next claim that

$$\text{spt}(\langle T, \mathbf{p}, p \rangle) \subset \mathbf{B}_{r_L}(p). \quad (9.1)$$

Assuming this for the moment, recall that, by (8.8),

$$\|\boldsymbol{\varphi} - g_L\|_{C^0(L)} \leq C\mathbf{m}_0^{1/2} d(L)^{2(1+\beta_0)\gamma_0-\beta_2-2} \ell(L)^{3+\kappa} \leq C\mathbf{m}_0^{1/2} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}$$

(where in the last inequality we have used that $\ell(L) \leq d(L)$ and $\frac{\gamma_0}{4} > \beta_2$). Recall also that the graph of g_L coincides with that of h_L and, by (7.1),

$$\|h_L - \eta\|_{C^0(B_{6r_H}(p_H, \pi_H))} \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2},$$

where $(\xi, \eta) \in \pi_L \times \pi_L^\perp$ are the coordinates for p_L , cf. (7.1). Since $\text{spt}(T_J) \cap \mathbf{C}_{8r_L}(p_L, \pi_L) \subset \text{spt}(T_L)$ for every ancestor J of L , we must then have $\text{spt}(\langle T, \mathbf{p}, p \rangle) \subset \text{spt}(\langle T, \mathbf{p}, p \rangle) \cap \mathbf{B}_{r_L}(p) \subset \text{spt}(T_L) \cap \mathbf{C}_{8r_L}(p_L, \pi_L)$. Recalling that $p_L \in \text{spt}(T_L)$ and that, by Proposition 5.1, we have the bound

$$\mathbf{h}(T_L, \mathbf{C}_{8r_L}(p_L, \pi_L)) \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2},$$

we conclude that no point of $\text{spt}(\langle T, \mathbf{p}, p \rangle)$ can be at distance larger than

$$C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}$$

from the graph of h_L . Putting all these estimates together, no point of $\text{spt}(\langle T, \mathbf{p}, p \rangle)$ can be at a distance larger than $C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}$ from $\text{Gr}(\boldsymbol{\varphi})$. Since for every

$p' \in \text{spt}(\langle T, \mathbf{p}, p \rangle)$ the point p is the closest in the graph of φ , this completes the proof of (iii), provided we show (9.1).

If (9.1) is false, there is a $p' \in \text{spt}(\langle T, \mathbf{p}, p \rangle)$ and an ancestor J of L with largest sidelength among those for which $|p' - p| \geq r_J/2$. Let π be the tangent to \mathcal{M} at p and observe that we have the estimates $|\pi - \pi_J| \leq C\mathbf{m}_0^{1/2}$ and $|\pi - \pi_0| \leq C\mathbf{m}_0^{1/2}$. The second bound is a trivial consequence of the estimates on φ , whereas the first is a consequence of (8.9) and $|\pi_L - \pi_J| \leq C\mathbf{m}_0^{1/2}$, which in turn follows from Proposition 5.1. If J were an element of \mathcal{S}^{N_0} , Assumption 1.7(Hor) would imply $|p' - p| \leq C\mathbf{m}_0^{1/4} r_J^{1+\gamma_0}$. If $J \notin \mathcal{S}^{N_0}$ and we let H be the father of J , we then conclude that $q, p, p' \in \mathbf{B}_H$ and thus we have $|p' - p| \leq C_0 \mathbf{h}(T, \mathbf{B}_H) \leq C\mathbf{m}_0^{1/4} \ell(H)^{1+\beta_2}$ by (3.13). In both cases this would be incompatible with $|p' - p| \geq r_J = r_H/2$, provided $\varepsilon_2 \leq c(\beta_2, \delta_2, M_0, N_0, C_e, C_h)$.

We next prove (iv). Fix a point $(z, w) \in \mathfrak{B}$ which belongs to Γ and set $p := (z, \varphi(z, w)) = \Phi(z, w)$. To prove our statement we claim in fact that:

$$Q \llbracket T_p \mathcal{M} \rrbracket \text{ is the unique tangent cone to } T \text{ at } p \quad (9.2)$$

$$\text{spt}(T) \cap \mathbf{p}^{-1}(\{p\}) = \{p\}. \quad (9.3)$$

By construction there is an infinite chain $L_{N_0} \supset L_{N_0+1} \supset \dots \supset L_i \supset \dots$ where $(z, w) \in L_i \in \mathcal{S}^i$ for every i . Set $\pi_i := \pi_{L_i}$. By our construction and the estimates of the previous sections, it is obvious that $\pi_{L_i} \rightarrow \pi = T_p \mathcal{M}$. In fact since $|\pi_{L_i} - \pi_{L_{i+1}}| \leq C\mathbf{m}_0^{1/2} |z|^{\gamma_0+\delta_1-1} \ell(L_i)^{1-\delta_1}$ by Proposition 5.1(iv), we easily infer

$$|\pi - \pi_{L_i}| \leq C\mathbf{m}_0^{1/2} |z|^{\gamma_0+\delta_1-1} \ell(L_i)^{1-\delta_1}. \quad (9.4)$$

On the other hand by the height and excess bounds (3.12) and (3.13), it is also obvious that $T_{p_{L_i}, r_{L_i}}$ converges, in \mathbf{B}_1 , to $Q \llbracket \pi \rrbracket$. Since $r_{L_i}/r_{L_{i+1}} = 2$ and $p_{L_i} \rightarrow p$ (in fact $|\Phi(z, w) - p_{L_i}| \leq C2^{-i}$), (9.2) is then obvious.

Assume now that (9.3) is false and let $p' \in \text{spt}(\langle T, \mathbf{p}, p \rangle)$. Again by the width of \mathbf{V} it turns out that $p' \in \text{spt}(T_{L_{N_0}})$. Let j be the integer such that $2^{-j-1}|z| \leq |p - p'| \leq 2^{-j}|z|$. From Assumption 1.7(Hor) it follows that, if ε_2 is sufficiently small, then certainly $j \geq N_0 + 2$. This means that there is an L_i such that $p' \in \mathbf{B}_{L_i}$ and obviously $\ell(L_i) \leq C|z|2^{-j}$. Recall that $\text{spt}(T_{L_{N_0}}) \cap \mathbf{B}_{L_i} \subset \text{spt}(T_{L_i})$. On the other hand, by (9.4), we have

$$|p - p'| \leq (1 + C|\pi_{L_i} - \pi|) \mathbf{h}(T_{L_i}, \mathbf{B}_{L_i}) \leq C\mathbf{m}_0^{1/4} d(L_i)^{\gamma_0/2-\beta_2} \ell(L_i)^{1+\beta_2} \leq C\mathbf{m}_0^{1/4} |z|^{1+\gamma_0/2} 2^{-j}.$$

Since the constant C depends upon the parameters C_h, C_e, M_0 and N_0 , but not upon ε_2 , the latter bound contradicts $|p - p'| \geq 2^{-j-1}|z|$ provided ε_2 is chosen sufficiently small.

9.2. Proof of Theorem 4.3: Part I. We set $F(p) = Q \llbracket p \rrbracket$ for $p \in \Phi(\Gamma)$. For every $L \in \mathcal{W}^j$ consider the π_L -approximating function $f_L : \mathbf{C}_{8r_L}(p_L, \pi_L) \rightarrow \mathcal{A}_Q(\pi_L^\perp)$ of Definition 3.6 and $K_L \subset B_{8r_L}(p_L, \pi_L)$ the projection on $p_L + \pi_L$ of $\text{spt}(T_L) \cap \text{Gr}(f_L)$. In particular we have $\mathbf{G}_{f_L|_{K_L}} = T_L \llcorner (K_L \times \pi_L^\perp)$. We then denote by $\mathcal{D}(L)$ the portions of the supports of T_L and $\text{Gr}(f_L)$ which differ:

$$\mathcal{D}(L) := (\text{spt}(T_L) \cup \text{Gr}(f_L)) \cap [(B_{8r_L}(p_L, \pi_L) \setminus K_L) \times \pi_L^\perp].$$

Observe that, by [11, Theorem 1.5] and Proposition 6.1 and our choice of the parameters, we have, for $E := \mathbf{E}(T_L, \mathbf{C}_{32r_L}(p_L, \pi_L))$,

$$\begin{aligned} \mathcal{H}^m(\mathcal{D}(L)) &\leq \|T\|(\mathcal{D}(L)) \leq CE^{\beta_0}(E + \ell(L)^2 \mathbf{m}_0) \ell(L)^2 \\ &\leq C\mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} \ell(L)^{2+(1+\beta_0)(2-2\delta_1)}. \end{aligned} \quad (9.5)$$

Let \mathcal{L} be the Whitney region in Definition 3.12 and set $\mathcal{L}' := \Phi(J)$ where J is the cube concentric to L with $\ell(J) = \frac{9}{8}\ell(L)$. Observe that the graphical structure of Φ , our choice of the constants and condition (NN) ensure that

$$L \cap H = \emptyset \iff \mathcal{L}' \cap \mathcal{H}' = \emptyset \quad \forall H, L \in \mathcal{W}, \quad (9.6)$$

$$\Phi(\Gamma) \cap \mathcal{L}' = \emptyset \quad \forall L \in \mathcal{W}. \quad (9.7)$$

We then apply [8, Theorem 5.1] to the map f_L , the plane π_L and the (appropriate portion of the) center manifold \mathcal{M} as a graph over π_L to obtain Lipschitz maps $F_L : \mathcal{L}' \rightarrow \mathcal{A}_Q(\mathbf{U})$, $N_L : \mathcal{L}' \rightarrow \mathcal{A}_Q(\mathbb{R}^{m+n})$ with the following properties:

- $F_L(p) = \sum_i \llbracket p + (N_L)_i(p) \rrbracket$,
- $(N_L)_i(p) \perp T_p \mathcal{M}$ for every $p \in \mathcal{L}'$
- and $\mathbf{G}_{f_L} \llcorner (\mathbf{p}^{-1}(\mathcal{L}')) = \mathbf{T}_{F_L} \llcorner (\mathbf{p}^{-1}(\mathcal{L}'))$.

For each L consider the set $\mathcal{W}(L)$ of elements in \mathcal{W} which have a nonempty intersection with L . We then define the set \mathcal{K} in the following way:

$$\mathcal{K} = (\mathcal{M} \cap \mathbf{C}_{2r}) \setminus \left(\bigcup_{L \in \mathcal{W}} \left(\mathcal{L}' \cap \bigcup_{M \in \mathcal{W}(L)} \mathbf{p}(\mathcal{D}(M)) \right) \right). \quad (9.8)$$

In other words \mathcal{K} is obtained from \mathcal{M} by removing in each \mathcal{L}' those points x for which there is a neighboring cube M such that the slice of \mathbf{T}_{F_M} at x (relative to the projection \mathbf{p}) does not coincide with the slice of T . Observe that, by (9.7), \mathcal{K} contains necessarily Γ . Moreover, recall that $\text{Lip}(\mathbf{p}) \leq C$, that the cardinality of $\mathcal{W}(L)$ is at most 12 and that each element of $\mathcal{W}(L)$ has side-length at most twice that of L . Thus (9.5) implies

$$\begin{aligned} |\mathcal{L} \setminus \mathcal{K}| &\leq |\mathcal{L}' \setminus \mathcal{K}| \leq \sum_{M \in \mathcal{W}(L)} \sum_{H \in \mathcal{W}(M)} \|T_H\|(\mathcal{D}(H)) \\ &\leq C\mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} \ell(L)^{2+(1+\beta_0)(2-2\delta_1)}. \end{aligned} \quad (9.9)$$

By (9.6), if J and L are such that $\mathcal{J}' \cap \mathcal{L}' \neq \emptyset$, then $J \in \mathcal{W}(L)$ and therefore $F_L = F_J$ on $\mathcal{K} \cap (\mathcal{J}' \cap \mathcal{L}')$. We can therefore define a unique map on \mathcal{K} by simply setting $F(p) = F_L(p)$ if $p \in \mathcal{K} \cap \mathcal{L}'$. Notice that $\mathbf{T}_F = T \llcorner \mathbf{p}^{-1}(\mathcal{K})$, which implies two facts. First, by Corollary 4.1(iii) we also have that $N(p) := \sum_i \llbracket F_i(p) - p \rrbracket$ enjoys the bound

$$\|N|_{\mathcal{K} \cap \mathcal{L}}\|_{C^0} \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}.$$

Secondly,

$$\begin{aligned} \|T\|(\mathbf{p}^{-1}(\mathcal{L} \setminus \mathcal{K})) &\leq \sum_{M \in \mathcal{W}(L)} \sum_{H \in \mathcal{W}(M)} \|T_H\|(\mathcal{D}(H)) \\ &\leq C \mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} \ell(L)^{2+(1+\beta_0)(2-2\delta_1)}. \end{aligned} \quad (9.10)$$

Finally, notice that, by the C^2 estimate on φ and (7.5), \mathcal{M} is given on $\mathbf{C}_{r_L}(p_L, \pi_L)$ as the graph of a map $\varphi' : B_{r_L}(p_L, \pi_L) \rightarrow \pi_L^\perp$ with $\|D\varphi'\|_{C^0} \leq C \mathbf{m}_0^{1/2} d(H)^{\gamma_0-1+\delta_1} \ell(H)^{1-\delta_1}$ and $\|D^2\varphi'\|_{C^0} \leq C \mathbf{m}_0^{1/2} d(H)^{\gamma_0-1}$. Hence, the Lipschitz constant of N_L can be estimated using [8, Theorem 5.1] as

$$\text{Lip}(N_L) \leq C (\|D^2\varphi'\|_{C^0} \|N\|_{C^0} + \|D\varphi'\|_{C^0} + \text{Lip}(f_L)) \leq C (\mathbf{m}_0 d(L)^{\gamma_0} \ell(L)^{\gamma_0})^{\beta_0}, \quad (9.11)$$

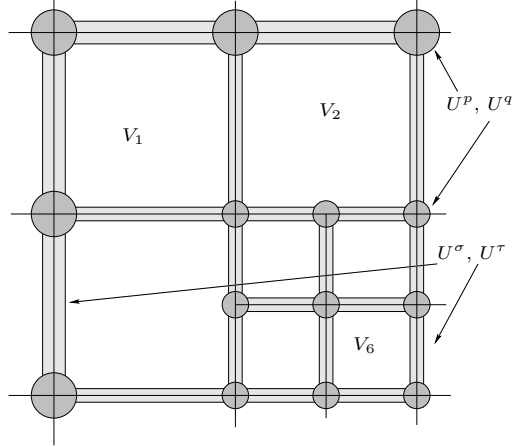
so that our map has the Lipschitz bound of (4.1). We next extend F and N to the whole center manifold and conclude (4.2) from (9.10) and (9.9). The extension is achieved in three steps:

- we first extend the map F to a map \bar{F} taking values in $\mathcal{A}_Q(\mathbf{V})$;
- we then modify \bar{F} to achieve the form $\hat{F}(x) = \sum_i \llbracket x + \hat{N}_i(x) \rrbracket$ with $\hat{N}_i(x) \perp T_x \mathcal{M}$ for every x ;
- in the cases (a) and (c) of Definition 0.1 we finally modify \hat{F} to reach the desired extension $F(x) = \sum_i \llbracket x + N_i(x) \rrbracket$, with $N_i(x) \perp T_x \mathcal{M}$ and $x + N_i(x) \in \Sigma$ for every x .

First extension. We use on \mathcal{M} the coordinates induced by its graphical structure, i.e. we work with variables in flat domains. Note that the domain parameterizing the Whitney region for $L \in \mathcal{W}$ is then the cube concentric to L and with side-length $\frac{17}{16}\ell(L)$. The multivalued map N is extended to a multivalued \bar{N} inductively to appropriate neighborhoods of the skeleta of the Whitney decomposition (a similar argument has been used in [6, Section 1.2.2]). The extension of F will obviously be $\bar{F}(x) = \sum_i \llbracket x + \bar{N}_i(x) \rrbracket$. The neighborhoods of the skeleta are defined in this way:

- (1) if p belongs to the 0-skeleton, we let $L \in \mathcal{W}$ be (one of) the smallest cubes containing it and define $U^p := B_{\ell(L)/16}(p)$;
- (2) if $\sigma = [p, q] \subset L$ is the edge of a cube and $L \in \mathcal{W}$ is (one of) the smallest cube intersecting σ , we then define U^σ to be the neighborhood of size $\frac{1}{4} \frac{\ell(L)}{16}$ of σ minus the closure of the unions of the U^r 's, where r runs in the 0-skeleton.

Denote by \bar{U} the closure of the union of all these neighborhoods and let $\{V_i\}$ be the connected components of the complement. For each V_i there is a $L_i \in \mathcal{W}$ such that $V_i \subset L_i$. Moreover, V_i has distance $c_0 \ell(L)$ from ∂L_i , where c_0 is a geometric constant. It is also clear that if τ and σ are two distinct facets of the same cube L with the same dimension, then the distance between any pair of points x, y with $x \in U^\tau$ and $y \in U^\sigma$ is at least $c_0 \ell(L)$. In Figure 1 the various domains are shown in a piece of a 2-dimensional decomposition.

FIGURE 1. The sets U^p , U^σ and V_i .

At a first step we extend N to a new map \bar{N} separately on each U^p , where p are the points in the 0-skeleton. In particular, fix $p \in L$ and let $\text{St}(p)$ be the union of all cubes which contain p . Observe that the Lipschitz constant of $N|_{\mathcal{K} \cap \text{St}(p)}$ is smaller than

$$C (\mathbf{m}_0 d(L)^{\gamma_0} \ell(L)^{\gamma_0})^{\beta_0}$$

and that

$$|N| \leq C \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2}.$$

We can therefore extend the map $N|_{\mathcal{K} \cap \text{St}(p)}$ to $U^p \cup (\mathcal{K} \cap \text{St}(p))$ at the price of enlarging the Lipschitz constant and the height bound by a multiplicative constant, using [6, Theorem 1.7]. Being the U^p disjoint, the resulting map, for which we use the symbol \tilde{N} , is well-defined.

It is obvious that this map has the desired height bound in each Whitney region. We therefore want to estimate its Lipschitz constant. Consider $L \in \mathcal{W}$ and H concentric to L with side-length $\ell(H) = \frac{17}{16} \ell(L)$. Let $x, y \in H$. If $x, y \in U^p \cup (\mathcal{K} \cap \text{St}(p))$ for some p , then there is nothing to check. If $x \in U^p$ and $y \in U^q$ with $p \neq q$, observe however that this would imply that p, q are both vertices of L . Given that $L \setminus \mathcal{K}$ has much smaller measure than L there is at least one point $z \in L \cap \mathcal{K}$. It is then obvious that

$$\mathcal{G}(\bar{N}(x), \bar{N}(y)) \leq \mathcal{G}(\bar{N}(x), \bar{N}(z)) + \mathcal{G}(\bar{N}(z), \bar{N}(y)) \leq C (\mathbf{m}_0 d(L)^{\gamma_0} \ell(L)^{\gamma_0})^{\beta_0} \ell(L),$$

and, since $|x - y| \geq c_0 \ell(L)$, the desired bound readily follows. Observe moreover that, if x is in the closure of some U^q , then we can extend the map continuously to it. By the properties of the Whitney decomposition it follows that the union of the closures of the U^q and of \mathcal{K} is closed and thus, w.l.o.g., we can assume that the domain of this new \tilde{N} is in fact closed.

We can repeat this procedure with the edges of the skeleta, that is in the argument above we simply replace points p with 1-dimensional faces σ , defining $\text{St}(\sigma)$ as the union of the cubes which contain σ . In the final step we then extend over the domains V_i 's: this

time $\text{St}(V_i)$ will be defined as the union of the cubes which intersect the cube $L_i \supset V_i$. The correct height and Lipschitz bounds follow from the same arguments. Since the algorithm is applied 3 times, the original constants have been enlarged by a geometric factor.

Second extension. For each $x \in \mathcal{M}$ let $\mathbf{p}^\perp(x, \cdot) : \mathbb{R}^{m+n} \rightarrow \mathbb{R}^{m+n}$ be the orthogonal projection on $(T_x \mathcal{M})^\perp$ and set $\hat{N}(x) = \sum_i \llbracket \mathbf{p}^\perp(x, \tilde{N}_i(x)) \rrbracket$. Obviously $|\hat{N}(x)| \leq |\tilde{N}(x)|$, so the L^∞ bound is trivial. We now want to show the estimate on the Lipschitz constant. To this aim, fix two points p, q in the same Whitney region associated to L and parameterize the corresponding geodesic segment $\sigma \subset \mathcal{M}$ by arc-length $\gamma : [0, d(p, q)] \rightarrow \sigma$, where $d(p, q)$ denotes the geodesic distance on \mathcal{M} . Use [6, Proposition 1.2] to select Q Lipschitz functions $N'_i : \sigma \rightarrow \mathbf{U}$ such that $\tilde{N}|_\gamma = \sum \llbracket N'_i \rrbracket$ and $\text{Lip}(N'_i) \leq \text{Lip}(\tilde{N})$. Fix a frame ν_1, \dots, ν_n on the normal bundle of $\mathcal{L} \subset \mathcal{M}$ with the property that $\|\nu_i\|_{C^0(\mathcal{L})} \leq C \|D\varphi\|_{C^0} \leq C \mathbf{m}_0^{1/2} d(L)^{\gamma_0}$ and $\|D\nu_i\|_{C^0(\mathcal{L})} \leq C \|D^2\varphi\|_{C^0} \leq \mathbf{m}_0^{1/2} d(L)^{\gamma_0-1}$ (which is possible by [8, Appendix A], indeed we do this in $\mathcal{M} \setminus \{0\}$, where our manifold is C^{3, γ_0}). We have $\hat{N}(\gamma(t)) = \sum_i \llbracket \hat{N}_i(t) \rrbracket$, where

$$\hat{N}_i(t) = \sum [\nu_j(\gamma(t)) \cdot N'_i(\gamma(t))] \nu_j(\gamma(t)).$$

Hence we can estimate

$$\left| \frac{d\hat{N}_i}{dt} \right| \leq C \sum_j [\|D\nu_j\| \|N'_i\|_{C^0} + \text{Lip}(N'_i)] \leq C (\mathbf{m}_0 d(L)^{\gamma_0} \ell(L)^{\gamma_0})^{\beta_0}.$$

Integrating this inequality we find

$$\mathcal{G}(\hat{N}(p), \hat{N}(q)) \leq \sum_{i=1}^Q |\hat{N}_i(d(p, q)) - \hat{N}_i(0)| \leq C (\mathbf{m}_0 d(L)^{\gamma_0} \ell(L)^{\gamma_0})^{\beta_0} d(p, q).$$

Since $d(p, q)$ is comparable to $|p - q|$, we achieve the desired Lipschitz bound.

Third extension and conclusion. We still need to modify the map \hat{N} in the cases (a) and (c) of Definition 0.1. For each $x \in \mathcal{M} \subset \Sigma$ consider the orthogonal complement \varkappa_x of $T_x \mathcal{M}$ in $T_x \Sigma$. Let \mathcal{T} be the fiber bundle $\bigcup_{x \in \mathcal{M} \setminus \{0\}} \varkappa_x$ and observe that, by the regularity of both $\mathcal{M} \setminus \{0\}$ and Σ , there is a C^{2, γ_0} trivialization (argue as in [8, Appendix A]). It is then obvious that there is a C^{0, γ_0} map $\Xi : \mathcal{T} \rightarrow \mathbb{R}^{m+n}$ with the following property: for each (x, v) , $q := x + \Xi(x, v)$ is the only point in Σ which is orthogonal to $T_x \mathcal{M}$ and such that $\mathbf{p}_{\varkappa_x}(q - x) = v$. Let us denote by $\Omega(x, q)$ the map $\Xi(x, \mathbf{p}_{\varkappa_x}(q))$. This map extends to a C^{0, γ_0} map at the origin with the estimates

$$|D_x \Omega(x, q)| \leq C \mathbf{m}_0^{1/2} |x|^{\gamma_0-1} \quad \forall x \in \mathfrak{B} \setminus \{0\} \quad \forall q \text{ with } |q| \leq 1 \quad (9.12)$$

$$|D_x^2 \Omega(x, q)| \leq C \mathbf{m}_0^{1/2} |x|^{\gamma_0-2} \quad \forall x \in \mathfrak{B} \setminus \{0\} \quad \forall q \text{ with } |q| \leq 1 \quad (9.13)$$

We then set $N(x) = \sum_i \llbracket \Omega(x, \hat{N}_i(x)) \rrbracket$. Obviously, $N(x) = \hat{N}(x) = 0$ for $x \in \mathcal{K}$, simply because in this case $x + \hat{N}_i(x) = x$ belongs to Σ .

In order to show the Lipschitz bound, notice that, by the regularity of \mathcal{M} and Σ ,

$$|\Omega(x, q) - \Omega(x, p)| \leq C |q - p|. \quad (9.14)$$

Moreover, since $\Omega(x, 0) = 0$ for every $x \in \mathcal{M} \subset \Sigma$, we have $D_x \Omega(x, 0) = 0$. We therefore conclude that $|D_x \Omega(x, q)| \leq C \mathbf{m}_0^{1/2} |x|^{\gamma_0-1} |q|$ and hence that

$$|\Omega(x, q) - \Omega(y, q)| \leq C \mathbf{m}_0^{1/2} |x|^{\gamma_0-1} |q| |y - x|. \quad (9.15)$$

Thus, fix two points x, y in any Whitney region \mathcal{L} and let us assume that $\mathcal{G}(\hat{N}(x), \hat{N}(y))^2 = \sum_i |\hat{N}_i(x) - \hat{N}_i(y)|^2$ (which can be achieved by a simple relabeling). We then conclude

$$\begin{aligned} \mathcal{G}(N(x), N(y))^2 &\leq 2 \sum_i |\Omega(x, \hat{N}_i(x)) - \Omega(x, \hat{N}_i(y))|^2 + 2 \sum_i |\Omega(x, \hat{N}_i(y)) - \Omega(y, \hat{N}_i(y))|^2 \\ &\leq C \mathbf{m}_0^{1/2} \mathcal{G}(\hat{N}(x), \hat{N}(y))^2 + C |x|^{2\gamma_0-2} \sum_i |\hat{N}_i(y)|^2 |x - y|^2 \\ &\leq C (\mathbf{m}_0 d(L)^{\gamma_0} \ell(L)^{\gamma_0})^{2\beta_0} |x - y|^2 \\ &\quad + C \mathbf{m}_0 d(L)^{2\gamma_0-2+\gamma_0-2\beta_2} \ell(L)^{2+2\beta_2} |x - y|^2 \end{aligned} \quad (9.16)$$

$$\leq C (\mathbf{m}_0 d(L)^{\gamma_0} \ell(L)^{\gamma_0})^{2\beta_0} |x - y|^2, \quad (9.17)$$

which proves the desired Lipschitz bound. Finally, using the fact that $\Omega(x, 0) = 0$, we have $|\Omega(x, v)| \leq C|v|$ and the L^∞ bound readily follows.

9.3. Proof of Theorem 4.3, Part II. In this section we show the estimates (4.3) and (4.4). We start with the first one. Fix a Whitney region \mathcal{L} and a corresponding square $L \in \mathcal{W}$. First consider the cylinder $\mathbf{C} := \mathbf{C}_{8r_L}(p_L, \pi_L)$, the interpolating function g_L and the tilted interpolating function h_L . Denote by $\vec{\mathcal{M}}$ the unit m -vector orienting $T\mathcal{M}$ and by $\vec{\tau}$ the one orienting $T\mathbf{G}_{h_L} = T\mathbf{G}_{g_L}$. Recalling that g_L and φ coincide in a neighborhood of (z_L, w_L) of L , by Theorem 3.11 we have

$$\sup_{p \in \mathcal{M} \cap \mathbf{C}} |\vec{\tau}(z_L, g_L(z_L, w_L)) - \vec{\mathcal{M}}(p)| \leq C \|D^2 \varphi\|_{C^0} \ell(L) \leq C \mathbf{m}_0^{1/2} d(L)^{\gamma_0-1} \ell(L).$$

On the other hand recalling (7.5) in Proposition 7.1, we have

$$|\pi_L - \vec{\tau}(z_L, g_L(z_L, w_L))| \leq C \mathbf{m}_0^{1/2} d(L)^{\gamma_0-1+\delta_1} \ell(L)^{1-\delta_1}.$$

This in turn implies that

$$\sup_{\mathbf{C} \cap \mathcal{M}} |\vec{\mathcal{M}} - \pi_L| \leq C \mathbf{m}_0^{1/2} d(L)^{\gamma_0-1+\delta_1} \ell(L)^{1-\delta_1}. \quad (9.18)$$

Therefore, we can estimate

$$\begin{aligned} &\int_{\mathbf{p}^{-1}(\mathcal{L})} |\vec{\mathbf{T}}_F(x) - \vec{\mathcal{M}}(\mathbf{p}(x))|^2 d\|\mathbf{T}_F\|(x) \\ &\leq C \int_{\mathbf{p}^{-1}(\mathcal{L})} |\vec{T}(x) - \vec{\mathcal{M}}(\mathbf{p}(x))|^2 d\|T\|(x) + C \mathbf{m}_0^{1+\beta_0} d(L)^{2(1+\beta_0)\gamma_0-2} \ell(L)^4 \\ &\leq C \int_{\mathbf{p}^{-1}(\mathcal{L})} |\vec{T}(x) - \pi_L|^2 d\|T\|(x) + C \mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell(L)^{4-2\delta_1}. \end{aligned} \quad (9.19)$$

Since $\mathbf{p}^{-1}(\mathcal{L}) \cap \text{spt}(T_L) \subset \mathbf{C}$, the integral in (9.19) is bounded by $C\ell(L)^2 \mathbf{E}(T_L, \mathbf{C}, \pi_L)$. By [8, Proposition 3.4] and using Proposition 6.1 we then conclude

$$\begin{aligned} \int_{\mathcal{L}} |DN|^2 &\leq C \int_{\mathbf{p}^{-1}(\mathcal{L})} |\vec{\mathbf{T}}_F(x) - \vec{\mathcal{M}}(\mathbf{p}(x))|^2 d\|\mathbf{T}_F\|(x) + C \|A_{\mathcal{M}}\|_{C^0(\mathbf{C}_{d(L)} \setminus \mathbf{C}_{d(L)/4})}^2 \int_{\mathcal{L}} |N|^2 \\ &\leq C \mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell(L)^{4-2\delta_1} + C \mathbf{m}_0 d(L)^{2\gamma_0-2} \ell(L)^{4+2\beta_2}, \end{aligned}$$

where we have used $\|A_{\mathcal{M}}\|_{C^0(\mathbf{C}_{d(L)} \setminus \mathbf{C}_{d(L)/4})} \leq C \mathbf{m}_0^{1/2} \text{dist}(L, 0)^{\gamma_0-1}$. This shows (4.3).

We finally come to (4.4). First observe that, by (4.1) and (4.2),

$$\begin{aligned} \int_{\mathcal{L} \setminus \mathcal{K}} |\boldsymbol{\eta} \circ N| &\leq C \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2} |\mathcal{L} \setminus \mathcal{K}| \\ &\leq C \mathbf{m}_0^{1+\beta_0+1/4} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)+(\gamma_0/2-\beta_2)} \ell(L)^{3+\beta_2+(1+\beta_0)(2-2\delta_1)}. \end{aligned} \quad (9.20)$$

Fix now $p \in \mathcal{K}$. Recalling that $F_L(p) = \sum_j [p + N_j(p)]$ is given by [8, Theorem 5.1] applied to the map f_L , we can use [8, Theorem 5.1(5.4)] to conclude

$$\begin{aligned} |\boldsymbol{\eta} \circ N_L(p)| &\leq C |\boldsymbol{\eta} \circ f_L(\mathbf{p}_{\pi_L}(p)) - \mathbf{p}_{\pi_L}^\perp(p)| + C \text{Lip}(f_L) |T_p \mathcal{M} - \pi_L| |N_L|(p) \\ &\stackrel{(9.18)}{\leq} C |\boldsymbol{\eta} \circ f_L(\mathbf{p}_{\pi_L}(p)) - \mathbf{p}_{\pi_L}^\perp(p)| \\ &\quad + C \mathbf{m}_0^{1/2+\beta_0} d(L)^{\beta_0(2\gamma_0-2+2\delta_1)+\gamma_0-1+\delta_1} \ell(L)^{1-\delta_1+\beta_0(2-2\delta_1)} \\ &\quad \cdot [\mathcal{G}(N_L(p), Q[\boldsymbol{\eta} \circ N_L(p)]) + Q|\boldsymbol{\eta} \circ N_L|(p)]. \end{aligned} \quad (9.21)$$

Note that with a slight abuse of notation we have denoted by \mathbf{p}_{π_L} the orthogonal projection onto $p_L + \pi_L$ (rather than onto π_L ; alternatively we could shift the origin so that $p_L = 0$). For ε_2 sufficiently small (depending only on $\beta_2, \gamma_2, M_0, N_0, C_e, C_h$), we then conclude that

$$\begin{aligned} |\boldsymbol{\eta} \circ N_L(p)| &\leq C |\boldsymbol{\eta} \circ f_L(\mathbf{p}_{\pi_L}(p)) - \mathbf{p}_{\pi_L}^\perp(p)| \\ &\quad + C \mathbf{m}_0^{1/2+\beta_0} d(L)^{\beta_0(2\gamma_0-2+2\delta_1)+\gamma_0-1+\delta_1} \ell(L)^{1-\delta_1+\beta_0(2-2\delta_1)} \mathcal{G}(N_L(p), Q[\boldsymbol{\eta} \circ N_L(p)]) \end{aligned} \quad (9.22)$$

Let next $\boldsymbol{\varphi}' : p_L + \pi_L \rightarrow \pi_L^\perp$ such that $\mathbf{G}_{\boldsymbol{\varphi}'} = \mathcal{M}$. Applying [9, Lemma B.1] we conclude that

$$\int_{\mathcal{K} \cap \mathcal{V}} |\boldsymbol{\eta} \circ f_L(\mathbf{p}_{\pi_L}(p)) - \mathbf{p}_{\pi_L}^\perp(p)| \leq \int_{\mathbf{p}_{\pi_L}(\mathcal{K} \cap \mathcal{V})} |\boldsymbol{\eta} \circ f_L(x) - \boldsymbol{\varphi}'(x)| \leq C \|g_L - \boldsymbol{\varphi}\|_{L^1(H)},$$

where H is a cube concentric to L with side-length $\ell(H) = \frac{9}{8}\ell(L)$. Next assume $L \in \mathcal{W}^j$ and let $k \geq j + 2$. Consider the subset $\mathcal{P}^k(L)$ of all cubes in \mathcal{P}^k which intersect L and recall that $\boldsymbol{\varphi}$ coincides with the map φ_k on H (recall Definition 3.10 and Theorem 3.11). Thus we can estimate

$$\begin{aligned} \|\boldsymbol{\varphi} - g_L\|_{L^1(H)} &\leq C \sum_{L' \in \mathcal{P}^k(L)} \|g_{L'} - g_L\|_{L^1(B_{r_L}(p_L, \pi_0))} \\ &\leq C \mathbf{m}_0 d(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(L)^{5+\kappa}, \end{aligned} \quad (9.23)$$

where in the last inequality we used (7.6). We then conclude

$$\|\varphi - g_L\|_{L^1(H)} \leq C\mathbf{m}_0 \text{dist}(L)^{2(1+\beta_0)\gamma_0-2-\beta_2} \ell(L)^{5+\kappa}$$

and (4.4) follows integrating (9.22) over $\mathcal{V} \cap \mathcal{K}$ and using (9.20).

10. SEPARATION AND SPLITTING BEFORE TILTING

10.1. Vertical separation. In this section we prove Proposition 4.4 and Corollary 4.5.

Proof of Proposition 4.4. Let J be the father of L . By Lemma 3.7 and Proposition 3.5, Theorem A.2 can be applied to the cylinder $\mathbf{C} := \mathbf{C}_{32r_J}(p_J, \pi_J)$. Moreover, $|p_J - p_L| \leq C_0 \ell(J)$, where C_0 is a geometric constant, and $r_J = 2r_L$. Thus, if M_0 is larger than a geometric constant, we have $\mathbf{B}_L \subset \mathbf{C}_{31r_J}(p_J, \pi_J)$. Denote by $\mathbf{q}_L, \mathbf{q}_J$ the projections $\mathbf{p}_{\pi_L^\perp}$ and $\mathbf{p}_{\pi_J^\perp}$ respectively. Since $L \in \mathcal{W}_h$, there are two points $p_1, p_2 \in \text{spt}(T_L) \cap \mathbf{B}_L$ such that

$$|\mathbf{q}_L(p_1 - p_2)| \geq C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}.$$

On the other hand, recalling Proposition 5.1(iv), $|\pi_J - \pi_L| \leq \bar{C} d(L)^{\gamma_0-1+\delta_1} \ell(L)^{1-\delta_1}$, where \bar{C} depends upon all the parameters except C_h and ε_2 . Thus,

$$\begin{aligned} |\mathbf{q}_J(p_1 - p_2)| &\geq |\mathbf{q}_L(p_1 - p_2)| - C_0 |\pi_L - \pi_J| |p_1 - p_2| \\ &\geq C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2} - \bar{C} \mathbf{m}_0^{1/2} d(L)^{\gamma_0-1+\delta_1} \ell(L)^{2-\delta_1} \\ &\geq C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2} - \bar{C} \mathbf{m}_0^{1/2} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}, \end{aligned}$$

where C_0 is a geometric constant and \bar{C} a constant which does not depend on C_h and ε_2 . Hence, if ε_2 is sufficiently small, we actually conclude

$$|\mathbf{q}_J(p_1 - p_2)| \geq \frac{15}{16} C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2}. \quad (10.1)$$

Set $E := \mathbf{E}(T_J, \mathbf{C}_{32r_J}(p_J, \pi_J))$ and apply Theorem A.2 to T_J and \mathbf{C} : the union of the corresponding ‘‘stripes’’ \mathbf{S}_j contain the set $\text{spt}(T_J) \cap \mathbf{C}_{32r_J(1-CE^{1/24}|\log E|)}(p_J, \pi_J)$, where C is a geometric constant. We can therefore assume that they contain $\text{spt}(T_L) \cap \mathbf{C}_{31r_J}(p_J, \pi_J)$. The width of these stripes is bounded as follows:

$$\begin{aligned} \sup \{ |\mathbf{q}_J(x - y)| : x, y \in \mathbf{S}_j \} &\leq C_0 E^{1/4} r_J \leq C_0 C_e^{1/4} \mathbf{m}_0^{1/4} d(L)^{(2\gamma_0-2+2\delta_1)/4} \ell(L)^{1+(2-2\delta_1)/4} \\ &\leq C_0 C_e^{1/4} \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2} \end{aligned}$$

where C_0 is a geometric constant. So, if C^\sharp is chosen large enough, we actually conclude that p_1 and p_2 must belong to two different stripes, say \mathbf{S}_1 and \mathbf{S}_2 . By Theorem A.2(iii) we conclude that all points in $\mathbf{C}_{31r_J}(p_J, \pi_J)$ have density Θ strictly smaller than $Q - 1$ (because in our case we know that Θ is *everywhere* integer-valued), thereby implying (S1). Moreover, by choosing C^\sharp appropriately, we achieve that

$$|\mathbf{q}_J(x - y)| \geq \frac{7}{8} C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell(L)^{1+\beta_2} \quad \forall x \in \mathbf{S}_1, y \in \mathbf{S}_2. \quad (10.2)$$

Assume next there is $H \in \mathcal{W}_n$ with $\ell(H) \leq \frac{1}{2} \ell(L)$ and $H \cap L \neq \emptyset$. From our construction and Proposition 5.1(iv) it follows that $\ell(H) = \frac{1}{2} \ell(L)$, $d(H) \leq 2d(L)$, $\mathbf{B}_H \subset \mathbf{C}_{31r_J}(p_J, \pi_J)$

and $|\pi_H - \pi_J| \leq \bar{C} \mathbf{m}_0^{1/2} d(L)^{\gamma_0 - 1 + \delta_1} \ell(H)^{1 - \delta_1}$, with \bar{C} which does not depend upon C_h and ε_2 . Hence choosing ε_2 sufficiently small we conclude

$$\begin{aligned} |\mathbf{q}_H(x - y)| &\geq \frac{3}{4} C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2} \\ &\geq \frac{3}{2} \left(\frac{1}{2}\right)^{\gamma_0/2} C_h \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2 - \beta_2} \ell(H)^{1 + \beta_2} \\ &\geq \frac{5}{4} C_h \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2 - \beta_2} \ell(H)^{1 + \beta_2} \quad \forall x \in \mathbf{S}_1, y \in \mathbf{S}_2, \end{aligned} \quad (10.3)$$

where the latter inequality holds because $\gamma_0 \leq \log_2 \frac{6}{5}$. Now, recalling Proposition 5.1, if ε_2 is sufficiently small, $\mathbf{C}_{30r_H}(p_H, \pi_H) \cap \text{spt}(T_H) \subset \mathbf{B}_H$ and $\text{spt}(T_J) \cap \mathbf{B}_H \subset \text{spt}(T_H)$. Moreover, by Theorem A.2(ii),

$$(\mathbf{p}_{\pi_J})_{\sharp}(T_J \llcorner (\mathbf{S}_j \cap \mathbf{C}_{30r_H}(p_H, \pi_J))) = Q_j \llbracket B_{30r_H}(p_H, \pi_J) \rrbracket \quad \text{for } j = 1, 2, \quad Q_j \geq 1.$$

A simple argument already used several other times allows to conclude that indeed

$$(\mathbf{p}_{\pi_H})_{\sharp}(T_H \llcorner (\mathbf{S}_j \cap \mathbf{C}_{30r_H}(p_H, \pi_H))) = Q_j \llbracket B_{30r_H}(p_H, \pi_H) \rrbracket \quad \text{for } j = 1, 2, \quad Q_j \geq 1.$$

Thus, $\mathbf{B}_H \cap \text{spt}(T_H)$ must necessarily contain two points x, y with

$$|\mathbf{q}_H(x - y)| \geq \frac{5}{4} C_h \mathbf{m}_0^{1/4} d(H)^{\gamma_0/2 - \beta_2} \ell(H)^{1 + \beta_2}.$$

But then the refining in H should have stopped because of condition (HT) and so H cannot belong to \mathscr{W}_n .

Coming to (S3), set $\Omega := \Phi(B_{8\ell(L)}((z_L, w_L)))$ and observe that $\mathbf{p}_{\sharp}(T \llcorner (\mathbf{p}^{-1}(\Omega) \cap \mathbf{S}_i)) = Q_i \llbracket \Omega \rrbracket$. Thus, for each $p \in \mathcal{K} \cap \Omega$, the support of $p + N(p)$ must contain at least one point $p + N_1(p) \in \mathbf{S}_1$ and at least one point $p + N_2(p) \in \mathbf{S}_2$. Now,

$$|N_1(p) - N_2(p)| \geq \frac{7}{8} C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2} - C_0 \ell(L) |T_p \mathcal{M} - \pi_J|. \quad (10.4)$$

Recalling, however, Proposition 7.1 and that \mathcal{M} and $\text{Gr}(g_J)$ coincide on a nonempty open set, we easily conclude that (see for instance the proof of (4.3)) $|T_p \mathcal{M} - \pi_J| \leq C \mathbf{m}_0^{1/2} d(L)^{\gamma_0 - 1 + \delta_1} \ell(L)^{1 - \delta_1}$ and, via (10.4),

$$\mathcal{G}(N(p), Q \llbracket \boldsymbol{\eta} \circ N(p) \rrbracket) \geq \frac{1}{2} |N_1(p) - N_2(p)| \geq \frac{3}{8} C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2}.$$

Next observe that, by the property of the Whitney decomposition, any cube touching $B_{4\ell(L)}((z_L, w_L))$ has sidelength at most $4\ell(L)$. Thus the sum of $\ell(H)^2$ over all such H is the 2-dimensional measure of a region of diameter comparable to $\ell(L)$ and from (4.2) we infer

$$|\Omega \setminus \mathcal{K}| \leq C \mathbf{m}_0^{1 + \beta_0} d(L)^{(1 + \beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell(L)^{2 + (1 + \beta_0)(2 - 2\delta_1)}.$$

So, for every point $x \in \Omega$ there exists $q \in \mathcal{K} \cap \Omega$ which has geodesic distance to x at most $C \mathbf{m}_0^{1/2 + \beta_0/2} d(L)^{(1 + \beta_0)(\gamma_0 - 1 + \delta_1)} \ell(L)^{1 + (1 + \beta_0)(1 - \delta_1)}$. Given the Lipschitz bound for N and the

choice $\beta_2 \leq \frac{1}{4}$, we then easily conclude (S3):

$$\begin{aligned} \mathcal{G}(N(x), Q \llbracket \boldsymbol{\eta} \circ N(x) \rrbracket) &\geq \frac{3}{8} C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2} \\ &\quad - C \mathbf{m}_0^{1/2 + 3\beta_0/2} d(L)^{(3\beta_0/2 + 1)\gamma_0 - \beta_2} \ell(L)^{1 + \beta_2} \\ &\geq \frac{1}{4} C_h \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell(L)^{1 + \beta_2}, \end{aligned}$$

where again we need $\varepsilon_2 < c(\beta_2, \delta_2, M_0, N_0, C_e, C_h)$ for a sufficiently small c . \square

Proof of Corollary 4.5. The proof is straightforward. Consider any $H \in \mathcal{W}_n^j$. By definition it has a nonempty intersection with some cube $J \in \mathcal{W}^{j-1}$: this cube cannot belong to \mathcal{W}_h by Proposition 4.4. It is then either an element of \mathcal{W}_e or an element $H_{j-1} \in \mathcal{W}_n^{j-1}$. Proceeding inductively, we then find a chain $H = H_j, H_{j-1}, \dots, H_i =: L$, where $H_{\bar{l}} \cap H_{\bar{l}-1} \neq \emptyset$ for every \bar{l} , $H_{\bar{l}} \in \mathcal{W}_n^{\bar{l}}$ for every $\bar{l} > i$ and $L = H_i \in \mathcal{W}_e^i$. Observe also that

$$|x_H - x_L| \leq \sum_{\bar{l}=i}^{j-1} |x_{H_{\bar{l}}} - x_{H_{\bar{l}+1}}| \leq \sqrt{2} \ell(L) \sum_{\bar{l}=0}^{\infty} 2^{-\bar{l}} \leq 2\sqrt{2} \ell(L).$$

It then follows easily that $H \subset B_{3\sqrt{2}\ell(L)}(L)$. \square

10.2. Unique continuation for Dir-minimizers. We recall for completeness the following two Propositions, whose proof can be found in [9], cf. Lemmas 7.1 and 7.2 therein.

Lemma 10.1 (Unique continuation for Dir-minimizers). *Let $n \in \mathbb{N} \setminus \{0\}$ be fixed. For every $\eta \in (0, 1)$ and $c > 0$, there exists $\gamma > 0$ with the following property. If $w : \mathbb{R}^2 \supset B_{2r} \rightarrow \mathcal{A}_Q(\mathbb{R}^n)$ is Dir-minimizing, $\text{Dir}(w, B_r) \geq c$ and $\text{Dir}(w, B_{2r}) = 1$, then*

$$\text{Dir}(w, B_s(q)) \geq \gamma \quad \text{for every } B_s(q) \subset B_{2r} \text{ with } s \geq \eta r.$$

In the sequel we fix $\lambda > 0$ such that

$$(1 + \lambda)^4 < 2^{\delta_1}. \quad (10.5)$$

Proposition 10.2 (Decay estimate for Dir-minimizers). *Let $n \in \mathbb{N} \setminus \{0\}$. For every $\eta > 0$, there is $\gamma > 0$ with the following property. Let $w : \mathbb{R}^2 \supset B_{2r} \rightarrow \mathcal{A}_Q(\mathbb{R}^n)$ be Dir-minimizing in every $\Omega' \subset\subset B_{2r}$ such that*

$$\int_{B_{(1+\lambda)r}} \mathcal{G}(Dw, Q \llbracket D(\boldsymbol{\eta} \circ w)(0) \rrbracket)^2 \geq 2^{\delta_1 - 4} \text{Dir}(w, B_{2r}). \quad (10.6)$$

Then, if we set $\tilde{w} = \sum_i \llbracket w_i - \boldsymbol{\eta} \circ w \rrbracket$, we have

$$\begin{aligned} \gamma \text{Dir}(w, B_{(1+\lambda)r}) &\leq \int_{B_s(q)} \mathcal{G}(Dw, Q \llbracket D(\boldsymbol{\eta} \circ w) \rrbracket)^2 \\ &\leq \frac{1}{\gamma r^2} \int_{B_s(q)} \mathcal{G}(w, Q \llbracket \boldsymbol{\eta} \circ w \rrbracket)^2 \quad \forall B_s(q) \subset B_{2r} \text{ with } s \geq \eta r. \end{aligned} \quad (10.7)$$

10.3. Splitting before tilting: Proof of Proposition 4.7. As customary we use the convention that constants denoted by C depend upon all the parameters but ε_2 , whereas constants denoted by C_0 depend only upon n, \bar{n} and Q .

Given $L \in \mathscr{W}_e^j$, let us consider its ancestors $H \in \mathscr{S}^{j-1}$ and $J \in \mathscr{S}^{j-6}$, which exists thanks to Proposition 3.5. Set $\ell = \ell(L)$, $\pi = \pi_H$ and $\mathbf{C} := \mathbf{C}_{8r_J}(p_J, \pi)$, and let $f : B_{8r_J}(p_{HJ}, \pi) \rightarrow \mathcal{A}_Q(\pi^\perp)$ be the π -approximation of Definition 3.6, which is the result of [11, Theorem 1.5] applied to T_J in $\mathbf{C}_{32r_J}(p_J, \pi)$ (recall that Proposition 5.1 ensures the applicability of [11, Theorem 1.5] in the latter cylinder).

The following are simple consequences of Proposition 5.1 and Proposition 6.1:

$$E := \mathbf{E}(T_J, \mathbf{C}_{32r_J}(p_J, \pi)) \leq C \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell^{2-2\delta_1}, \quad (10.8)$$

$$\mathbf{h}(T_J, \mathbf{C}, \pi_H) \leq C \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell^{1+\beta_2}, \quad (10.9)$$

$$c C_e \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell^{2-2\delta_1} \leq E, \quad (10.10)$$

where (10.10) follows from $\mathbf{B}_L \subset \mathbf{C}$, $L \in \mathscr{W}_e$ and $r_L/r_J = 2^{-6}$. In particular the positive constants c and C do not depend on ε_2 . We divide the proof of Proposition 4.7 in three steps.

Step 1: decay estimate for f . Let $2\rho := 64r_H - \underline{C} \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell^{1+\beta_2}$: since $p_H \in \text{spt}(T_J)$, it follows from (10.9) that, upon having chosen \underline{C} appropriately, $\text{spt}(T_J) \cap \mathbf{C}_{2\rho}(p_H, \pi) \subset \text{spt}(T_H) \cap \mathbf{B}_H \subset \mathbf{C}$. Observe in particular that \underline{C} does not depend on ε_2 , although it depends upon the other parameters. Thus, setting $B = B_{2\rho}(p_H, \pi)$, using the Taylor expansion in [8, Corollary 3.3] and the estimates in [11, Theorem 1.5], we get

$$\begin{aligned} \text{Dir}(B, f) &\leq 2|B| \mathbf{E}(T_J, \mathbf{C}_{2\rho}(p_H, \pi)) + C \mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell^{2+(1+\beta_0)(2-2\delta_1)} \\ &\leq 2\omega_2(2\rho)^2 \mathbf{E}(T_H, \mathbf{B}_H) + C \mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell^{2+(1+\beta_0)(2-2\delta_1)}. \end{aligned} \quad (10.11)$$

Recall that $|p_H - p_{HL}| \leq |p_H - p_L| \leq C_0 \ell(H)$, where C_0 is a geometric constant (cf. Proposition 5.1), and set $\sigma := 64r_L + C\ell(H) = 32r_H + C\ell(H)$. If λ is as in (10.5) and M_0 is sufficiently large (thus fixing a lower bound for M_0 which depends only on δ_1) we reach

$$\sigma \leq \left(\frac{1}{2} + \frac{\lambda}{4} \right) 64r_H \leq \left(1 + \frac{\lambda}{2} \right) \rho + \bar{C} \mathbf{m}_0^{1/4} d(L)^{\gamma_0/2 - \beta_2} \ell^{1+\beta_2}.$$

In particular, choosing ε_2 sufficiently small we get $\sigma \leq (1+\lambda)\rho$ and $\mathbf{B}_L \subset \mathbf{C}_{(1+\lambda)\rho}(p_L, \pi) =: \mathbf{C}'$. Define $B' = B_{(1+\lambda)\rho}(p_H, \pi)$. Set $A := f_{B'} D(\boldsymbol{\eta} \circ f)$, $\bar{A} : \pi_H \rightarrow \pi_H^\perp$ the linear map $x \mapsto A \cdot x$ and $\bar{\pi}$ for the plane corresponding to $\mathbf{G}_{\bar{A}}$. Using [8, Theorem 3.5] and [11, Theorem 5.2], we estimate

$$\begin{aligned} \frac{1}{2} \int_{B'} \mathcal{G}(Df, Q[[A]])^2 &\geq |B'| \mathbf{E}(T_J, \mathbf{C}', \bar{\pi}) - C \mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell^{2+(1+\beta_0)(2-2\delta_1)} \\ &\geq |B'| \mathbf{E}(T_J, \mathbf{B}_L, \bar{\pi}) - C \mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell^{2+(1+\beta_0)(2-2\delta_1)} \\ &\geq \omega_2((1+\lambda)\rho)^2 \mathbf{E}(T_L, \mathbf{B}_L) - C \mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell^{2+(1+\beta_0)(2-2\delta_1)}. \end{aligned} \quad (10.12)$$

Next, considering that $\mathbf{B}_H \supset \mathbf{B}_L$ and that, by $L \in \mathscr{W}_e^j$,

$$\mathbf{E}(T_L, \mathbf{B}_L) \geq C_e \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell^{2-2\delta_1},$$

we conclude from (10.11) and (10.12) that

$$\text{Dir}(B, f) \leq 2\omega_2(2\rho)^2(1 + C\mathbf{m}_0^{\beta_0})\mathbf{E}(T_H, \mathbf{B}_H). \quad (10.13)$$

$$\int_{B'} \mathcal{G}(Df, Q[[A]])^2 \geq 2\omega_2((1 + \lambda)\rho)^2(1 - C\mathbf{m}_0^{\beta_0})\mathbf{E}(T_L, \mathbf{B}_L). \quad (10.14)$$

Step 2: harmonic approximation. From now on, to simplify our notation, we use $B_s(y)$ in place of $B_s(y, \pi)$ (and recall that $\pi = \pi_H$). Consistently with [13, 11, 7] we introduce the parameter Ω , which equals

- $\mathbf{A} = \|A_\Sigma\|_{C^0}$ in case (a) of Definition 0.1;
- $\max\{\|d\omega\|_{C^0}, \|A_\Sigma\|_{C^0}\}$ in case (b);
- C_0R^{-1} in case (c).

From (10.10) we infer that, for any $\varepsilon_{32} > 0$, if \bar{r} is chosen sufficiently small, we have

$$8r_J \Omega \leq C\ell(L)\mathbf{m}_0^{1/2} \leq \varepsilon_{32} C_e^{1/2} \mathbf{m}_0^{1/2} d(L)^{\gamma_0-1+\delta_1} \ell(L)^{1-\delta_1} \leq \varepsilon_{32} E^{1/2}, \quad (10.15)$$

because $\ell(L) \leq d(L) \leq \bar{r}$. Therefore, for every positive $\bar{\eta}$, we can apply [7, Theorem 1.6] (in case (a) of Definition 0.1) and [11, Theorem 3.1] (in the cases (b) and (c) of Definition 0.1) to the cylinder \mathbf{C} and achieve a map $w : B_{8r_J}(p_{HJ}, \pi) \rightarrow \mathcal{A}_Q(\pi^\perp)$ of the form $w = (u, \Psi(y, u))$ (in fact $w = u$ in case (b) of definition 0.1) for a Dir-minimizer u and such that

$$(8r_J)^{-2} \int_{B_{8r_J}(p_{HJ})} \mathcal{G}(f, w)^2 + \int_{B_{8r_J}(p_{HJ})} (|Df| - |Dw|)^2 \leq \bar{\eta} E (8r_J)^2, \quad (10.16)$$

$$\int_{B_{8r_J}(p_{HJ})} |D(\boldsymbol{\eta} \circ f) - D(\boldsymbol{\eta} \circ w)|^2 \leq \bar{\eta} E (8r_J)^2. \quad (10.17)$$

In the cases (a) and (c) of Definition 0.1, by the chain rule we have $D(\Psi(y, u(y))) = \sum_j \llbracket D_x \Psi(y, u_j(y)) + D_v \Psi(y, u_j(y)) \cdot Du_j(y) \rrbracket$, so that

$$\int_{B_{(1+\lambda)\rho}(p_H)} |D(\Psi(y, u))|^2 \leq C_0 \mathbf{m}_0 \int_{B_{(1+\lambda)\rho}(p_H)} |Du|^2 + C_0 \mathbf{m}_0 \rho^4, \quad (10.18)$$

where C_0 is a geometric constant. Consider now $\tilde{A} := \int_{B'} D(\boldsymbol{\eta} \circ w)$, and observe that, since $D(\boldsymbol{\eta} \circ u) = \boldsymbol{\eta} \circ Du$ is harmonic, we have $A' := D(\boldsymbol{\eta} \circ u)(p_H) = \int_{B'} \boldsymbol{\eta} \circ Du$, where $B' = B_{(1+\lambda)\rho}(p_H)$. We can use (10.16), (10.17) and (10.18), together with (10.14) to infer,

for ε_2 small enough,

$$\begin{aligned}
& \int_{B'} \mathcal{G}(Du, Q \llbracket \boldsymbol{\eta} \circ Du(p_H) \rrbracket)^2 \\
&= \int_{B'} \mathcal{G}(Du, Q \llbracket A' \rrbracket)^2 \stackrel{(10.18)}{\geq} \int_{B'} \mathcal{G}(Dw, Q \llbracket \tilde{A} \rrbracket)^2 - C_0 \mathbf{m}_0 \rho^4 \\
&\stackrel{(10.16)\&(10.17)}{\geq} \int_{B'} \mathcal{G}(Df, Q \llbracket A \rrbracket)^2 - C_0 \mathbf{m}_0 \rho^4 - C_0 \bar{\eta} E \rho^2 \\
&\stackrel{(10.14)}{\geq} 2\omega_2((1+\lambda)\rho)^2(1 - C\mathbf{m}_0^{\beta_0})\mathbf{E}(T_L, \mathbf{B}_L) - C_0 \mathbf{m}_0 \rho^4 - C_0 \bar{\eta} E \rho^2. \tag{10.19}
\end{aligned}$$

Analogously, using (10.13) and (10.16), we easily deduce

$$\int_{B_{2\rho}(p_H)} |Du|^2 \leq 2\omega_2(2\rho)^2(1 + \mathbf{m}_0^{\beta_0})\mathbf{E}(T_H, \mathbf{B}_H) + C_0 \mathbf{m}_0 \rho^4 + C_0 \bar{\eta} E \rho^2 \tag{10.20}$$

Now recall that, since $d(L) = d(H) = d(J)$, and $L \in \mathscr{W}_e$,

$$\mathbf{E}(T_L, \mathbf{B}_L) \geq C_e \mathbf{m}_0 d(L)^{2\gamma_0 - 2 + 2\delta_1} \ell(L)^{2 - 2\delta_1} \geq 2^{2\delta_1 - 2} \mathbf{E}(T_H, \mathbf{B}_H),$$

and combining this with (10.20) and (10.19) we achieve

$$\int_{B'} \mathcal{G}(Du, Q \llbracket D(\boldsymbol{\eta} \circ u)(p_H) \rrbracket)^2 \geq (2^{2\delta_1 - 4} - C\mathbf{m}_0^{\beta_0}) \int_{B_{2\rho}(p_H)} |Du|^2 - C_0 \mathbf{m}_0 \rho^4 - C_0 \bar{\eta} E \rho^2. \tag{10.21}$$

To estimate the last two errors in terms of the energy of u we use again we use (10.19) to estimate

$$E \rho^2 \leq C_0 \rho^2 \mathbf{E}(T_L, B_L) \leq C_0 \int_{B'} |Du|^2 + C_0 \mathbf{m}_0 \rho^4 + C_0 \bar{\eta} E \rho^2$$

so that, for $\bar{\eta} \leq 1/2C_0$ we have

$$E \rho^2 \leq C_0 \rho^2 \mathbf{E}(T_L, B_L) \leq C_0 \int_{B'} |Du|^2 + C_0 \mathbf{m}_0 \rho^4. \tag{10.22}$$

Next, using once again, $L \in \mathscr{W}_e$ and this last inequality,

$$\mathbf{m}_0 \rho^4 \leq \frac{C_0 \rho^2}{C_e} d(L)^{2 - 2\gamma_0 - 2\delta_1} \mathbf{E}(T_L, \mathbf{B}_L) \leq \frac{C_0}{C_e} \int_{B'} |Du|^2 + \frac{C_0}{C_e} \mathbf{m}_0 \rho^4,$$

which for C_e bigger than a geometric constant implies

$$\mathbf{m}_0 \rho^4 \leq \frac{C_0}{C_e} \int_{B'} |Du|^2. \tag{10.23}$$

We can therefore combine (10.21) with (10.22) and (10.23) to achieve

$$\int_{B_{(1+\lambda)\rho}(p_H)} \mathcal{G}(Du, Q \llbracket D(\boldsymbol{\eta} \circ u)(p_H) \rrbracket)^2 \geq \left(2^{2\delta_1 - 4} - \frac{C_0}{C_e} - C\mathbf{m}_0^{\beta_0} - C_0 \bar{\eta}\right) \int_{B_{2\rho}(p_H)} |Du|^2. \tag{10.24}$$

It is crucial that the constant C , although depending upon $\beta_2, \delta_2, M_0, N_0, C_e$ and C_h , does not depend on η and ε_2 , whereas C_0 depends only upon Q, \bar{n} and n . So, if C_e is chosen

sufficiently large, depending only upon λ (and hence upon δ_1), we can require that $2^{2\delta_1-4} - \frac{C_0}{C_e} \geq 2^{3\delta_1/4-4}$. We then require $\bar{\eta}$ and ε_2 to be sufficiently small so that $2^{3\delta_1/4-4} - C \mathbf{m}_0^{\beta_0} - C\bar{\eta} \geq 2^{\delta_1-4}$.

We can now apply Proposition 10.2 to u and conclude

$$\hat{C}^{-1} \int_{B_{(1+\lambda)\rho}(p_H)} |Du|^2 \leq \int_{B_{\ell/8}(q)} \mathcal{G}(Du, Q \llbracket D(\boldsymbol{\eta} \circ u) \rrbracket)^2 \leq \hat{C} \ell^{-2} \int_{B_{\ell/8}(q)} \mathcal{G}(u, Q \llbracket \boldsymbol{\eta} \circ u \rrbracket)^2, \quad (10.25)$$

for any ball $B_{\ell/8}(q) = B_{\ell/8}(q, \pi) \subset B_{2\rho}(p_H)$, where \hat{C} depends upon δ_1 and M_0 . In particular, being these constants are independent of ε_2 and C_e .

Next recall that $L \in \mathcal{W}_e$, therefore

$$\mathbf{m}_0 \mathbf{d}(L)^{2\gamma_0-2+2\delta_1} \ell^{4-2\delta_1} \leq \tilde{C} \ell^2 \mathbf{E}(T, \mathbf{B}_L). \quad (10.26)$$

On the other hand by (10.19), (10.22) and (10.23), a suitable choice of ε_2 , η and C_e yields

$$\ell^2 \mathbf{E}(T, \mathbf{B}_L) \leq \int_{B_{(1+\lambda)\rho}(p_H)} |Du|^2 \leq C \int_{B_{\ell/8}(q)} \mathcal{G}(Du, Q \llbracket D(\boldsymbol{\eta} \circ u) \rrbracket)^2. \quad (10.27)$$

In turn, (10.17) and the definition of w implies

$$\int_{B_{\ell/8}(q)} \mathcal{G}(Du, Q \llbracket D(\boldsymbol{\eta} \circ u) \rrbracket)^2 \leq \int_{B_{\ell/8}(q)} \mathcal{G}(Df, Q \llbracket D(\boldsymbol{\eta} \circ f) \rrbracket)^2 + \eta E$$

and taking into account (10.23) and (10.25) we can once again assume that, for an appropriate choice of the parameters ε_2 , η and C_e we achieve

$$\int_{B_{\ell/8}(q)} \mathcal{G}(Du, Q \llbracket D(\boldsymbol{\eta} \circ u) \rrbracket)^2 \leq 2 \int_{B_{\ell/8}(q)} \mathcal{G}(Df, Q \llbracket D(\boldsymbol{\eta} \circ f) \rrbracket)^2.$$

Finally, using again (10.16), (10.23) and (10.25) we conclude in analogous way that

$$\int_{B_{\ell/8}(q)} \mathcal{G}(u, Q \llbracket \boldsymbol{\eta} \circ u \rrbracket)^2 \leq 2 \int_{B_{\ell/8}(q)} \mathcal{G}(f, Q \llbracket \boldsymbol{\eta} \circ f \rrbracket)^2.$$

Summarizing all the conclusions reached so far, we have

$$\begin{aligned} \mathbf{m}_0 \mathbf{d}(L)^{2\gamma_0-2+2\delta_1} \ell^{4-2\delta_1} &\leq \tilde{C} \ell^2 \mathbf{E}(T, \mathbf{B}_L) \leq \bar{C} \int_{B_{\ell/8}(q)} \mathcal{G}(Df, Q \llbracket D(\boldsymbol{\eta} \circ f) \rrbracket)^2 \\ &\leq \check{C} \ell^{-2} \int_{B_{\ell/8}(q)} \mathcal{G}(f, Q \llbracket \boldsymbol{\eta} \circ f \rrbracket)^2, \end{aligned} \quad (10.28)$$

where \tilde{C} , \bar{C} and \check{C} are constants which depend upon δ_1 , M_0 and C_e , but not on ε_2 .

Step 3: Estimate for the \mathcal{M} -normal approximation. We next complete the proof showing (4.5) and (4.6). Now, consider any ball $B_{\ell/4}(q, \pi_0)$ with $q \in \mathfrak{B}$ and $\text{dist}(L, q) \leq 4\sqrt{2}\ell$ and let $\Omega := \Phi(B_{\ell/4}(q, \pi_0))$. Recall that $\pi = \pi_H$ and by a slight abuse of notation let \mathbf{p}_π be the projection onto $p_H + \pi$. Observe that $\mathbf{p}_\pi(\Omega)$ must contain a ball $B_{\ell/8}(q', \pi)$,

because of $\|D\boldsymbol{\varphi}\|_{C^0} \leq C\mathbf{m}_0^{1/2}$ and $|\pi_0 - \pi| \leq C\mathbf{m}_0^{1/2}$, and in turn it must be contained in $B_{8r_J}(p_{HJ}, \pi)$.

Applying [9, Lemma B.1] let $\boldsymbol{\varphi}' : B_{8r_J}(p_{HJ}, \pi) \rightarrow \pi^\perp$ be such that $\mathbf{G}_{\boldsymbol{\varphi}'} = \llbracket \mathcal{M} \rrbracket \lrcorner \mathbf{C}_{8r_J}(p_J, \pi)$ and let $\boldsymbol{\Phi}'(z) = (z, \boldsymbol{\varphi}'(z))$. Since $D(\boldsymbol{\eta} \circ f)(z) = \boldsymbol{\eta} \circ Df(z)$ for a.e. z , we obviously have

$$\int_{B_{\ell/8}(q', \pi)} \mathcal{G}(Df, Q \llbracket D(\boldsymbol{\eta} \circ f) \rrbracket)^2 \leq C_0 \int_{B_{\ell/8}(q', \pi)} \mathcal{G}(Df, Q \llbracket D\boldsymbol{\varphi}' \rrbracket)^2. \quad (10.29)$$

Let now $\vec{\mathbf{G}}_f$ be the orienting tangent 2-vector to \mathbf{G}_f and $\vec{\tau}$ the one to \mathcal{M} . For a.e. z we have the inequality

$$C_0 \sum_j |\vec{\mathbf{G}}_f(z, f_j(z)) - \vec{\tau}(z, \boldsymbol{\varphi}'(z))|^2 \geq \mathcal{G}(Df(z), Q \llbracket D\boldsymbol{\varphi}'(z) \rrbracket)^2,$$

for some geometric constant C_0 , because $|\vec{\mathbf{G}}_f(z, f_j(z)) - \vec{\tau}(z, \boldsymbol{\varphi}'(z))| \leq \mathbf{m}_0^{\beta_0}$. Therefore, using [11, Theorem 5.2],

$$\begin{aligned} \int_{B_{\ell/8}(q', \pi)} \mathcal{G}(Df, Q \llbracket D\boldsymbol{\varphi}' \rrbracket)^2 &\leq C \int_{\mathbf{C}_{\ell/8}(q', \pi)} |\vec{\mathbf{G}}_f(z) - \vec{\tau}(\boldsymbol{\Phi}'(\mathbf{p}_{\pi_H}(z)))|^2 d\|\mathbf{G}_f\|(z) \\ &\leq C \int_{\mathbf{C}_{\ell/8}(q', \pi)} |\vec{T}_L(z) - \vec{\tau}(\boldsymbol{\Phi}'(\mathbf{p}_{\pi_H}(z)))|^2 d\|T_L\|(z) \\ &\quad + C\mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_2)} \ell^{2+(2-2\delta_2)(1+\beta_0)}. \end{aligned} \quad (10.30)$$

Now, thanks to the height bound (3.13) and to the fact that $|\vec{\tau} - \pi_H| \leq C\mathbf{m}_0^{1/2} d(L)^{\gamma_0/2-1} \ell$ in the cylinder $\hat{\mathbf{C}} = \mathbf{C}_{\ell/8}(q', \pi_H)$ (recall (8.9)), we have the inequality

$$|\mathbf{p}(z) - \boldsymbol{\Phi}'(\mathbf{p}_\pi(z))| \leq C\mathbf{m}_0^{1/4+1/2} d(L)^{\gamma_0-\beta_2} \ell^{2+\beta_2} \quad \forall z \in \text{spt}(T) \cap \hat{\mathbf{C}}.$$

Using the estimate $|D^2\boldsymbol{\varphi}'(\mathbf{p}_\pi(z))| \leq C\mathbf{m}_0^{1/2} d(L)^{\gamma_0/2-1}$ (which is valid for any $z \in \text{spt}(T) \cap \hat{\mathbf{C}}$ by (3.17) and [9, (B.3)]) we then easily conclude from (10.30) that

$$\begin{aligned} &\int_{B_{\ell/8}(q', \pi)} \mathcal{G}(Df, Q \llbracket D\boldsymbol{\varphi}' \rrbracket)^2 \\ &\leq C \int_{\hat{\mathbf{C}}} |\vec{T}_L(z) - \vec{\tau}(\mathbf{p}(z))|^2 d\|T_L\|(z) + C\mathbf{m}_0^{1+\beta_0} d(L)^{2\gamma_0-2-2\beta_2} \ell^{2+2\beta_2} \\ &\leq C \int_{\mathbf{p}^{-1}(\Omega)} |\vec{\mathbf{T}}_F(z) - \tau(\mathbf{p}(z))|^2 d\|\mathbf{T}_F\|(z) + C\mathbf{m}_0^{1+\beta_0} d(L)^{2\gamma_0-2+2\delta_1} \ell^{2-2\delta_1}, \end{aligned}$$

where we used (4.2).

Since, on the region where we are interested, namely Ω , we have the bounds $|DN| \leq C\mathbf{m}_0^{\beta_0} d(L)^{\beta_0\gamma_0}$, $|N| \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell^{1+\beta_2}$ and $\|A_{\mathcal{M}}\|^2 \leq C\mathbf{m}_0 d(L)^{\gamma_0-2}$, applying now

[8, Proposition 3.4] we conclude

$$\begin{aligned} \int_{\mathbf{p}^{-1}(\Omega)} |\vec{\mathbf{T}}_F(x) - \tau(\mathbf{p}(x))|^2 d\|\mathbf{T}_F\|(x) &\leq (1 + C\mathbf{m}_0^{2\beta_0} d(L)^{2\gamma_0\beta_0}) \int_{\Omega} |DN|^2 \\ &\quad + C\mathbf{m}_0^{1+1/2} d(L)^{2\gamma_0-2-2\beta_2} \ell^{2+2\beta_2}. \end{aligned}$$

Thus, combining the latter estimate with (10.28) and (10.30) we achieve

$$\mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell^{2-2\delta_2} \leq C(1 + C\mathbf{m}_0^{2\beta_0} d(L)^{2\gamma_0\beta_0}) \int_{\Omega} |DN|^2 + C\mathbf{m}_0^{1+\beta_0} d(L)^{2\gamma_0-2+2\delta_1} \ell^{2-2\delta_2}. \quad (10.31)$$

Since the constant C might depend on M_0, N_0, C_e and C_h but not on ε_2 , we conclude that for a sufficiently small ε_2 we have

$$\mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell^{2-2\delta_1} \leq C \int_{\Omega} |DN|^2. \quad (10.32)$$

But $\mathbf{E}(T_L, \mathbf{B}_L) \leq C\mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell^{2-2\delta_2}$ and thus (4.5) follows.

We finally show (4.6). Observe that $\mathbf{p}^{-1}(\Omega) \cap \text{spt}(T) \supset \mathbf{C}_{\ell/8}(q', \pi) \cap \text{spt}(T_L)$ and, for an appropriate geometric constant C_0 , Ω cannot intersect a Whitney region \mathcal{L}' corresponding to an L' with $\ell(L') \geq C_0\ell(L)$ or $d(L') \geq 2d(L)$. In particular, Theorem 4.3 implies that

$$\|\mathbf{T}_F - T_L\|(\mathbf{p}^{-1}(\Omega)) + \|\mathbf{T}_F - \mathbf{G}_f\|(\mathbf{p}^{-1}(\Omega)) \leq C\mathbf{m}_0^{1+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)} \ell^{2+(1+\beta_0)(2-2\delta_1)}. \quad (10.33)$$

Let now F' be the map such that $\mathbf{T}_{F'} \llcorner (\mathbf{p}^{-1}(\Omega)) = \mathbf{G}_f \llcorner (\mathbf{p}^{-1}(\Omega))$ and let N' be the corresponding normal part, i.e. $F'(x) = \sum_i \llbracket x + N'_i(x) \rrbracket$ (the existence of F' is guaranteed by [8, Theorem 5.1]). The region over which F and F' differ is contained in the projection onto Ω of $(\text{Im}(F) \setminus \text{spt}(T)) \cup (\text{Im}(F') \setminus \text{spt}(T))$ and therefore its \mathcal{H}^m measure is bounded as in (10.33). Recalling the bound on $\|N\|_{C^0}$ given by (4.1) and that

$$\mathcal{G}(f, Q \llbracket \varphi \rrbracket) \leq C\mathbf{h}(T_L, \mathbf{B}_L),$$

we easily conclude $|N| + |N'| \leq C\mathbf{m}_0^{1/4} d(L)^{\gamma_0/2-\beta_2} \ell^{1+\beta_2}$, which in turn implies

$$\int_{\Omega} |N|^2 \geq \int_{\Omega} |N'|^2 - C\mathbf{m}_0^{1+1/4+\beta_0} d(L)^{(1+\beta_0)(2\gamma_0-2+2\delta_1)+\gamma_0-2\beta_2} \ell^{4+2\beta_2+(2-2\delta_1)(1+\beta_0)}. \quad (10.34)$$

On the other hand, applying [8, Theorem 5.1 (5.3)], we conclude

$$|N'(\Phi'(z))| \geq \frac{1}{2\sqrt{Q}} \mathcal{G}(f(z), Q \llbracket \varphi'(z) \rrbracket) \geq \frac{1}{4\sqrt{Q}} \mathcal{G}(f(z), Q \llbracket \boldsymbol{\eta} \circ f(z) \rrbracket),$$

which in turn implies

$$\mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell^{2-2\delta_2} \stackrel{(10.28)}{\leq} C\ell^{-2} \int_{B_{\ell/8}(q', \pi)} \mathcal{G}(f, Q \llbracket \boldsymbol{\eta} \circ f \rrbracket)^2 \leq C\ell^{-2} \int_{\Omega} |N'|^2. \quad (10.35)$$

For ε_2 sufficiently small, (10.34) and (10.35) lead to the second inequality of (4.6), while the first one comes from Theorem 4.3 and $\mathbf{E}(T, \mathbf{B}_L) \geq C_e \mathbf{m}_0 d(L)^{2\gamma_0-2+2\delta_1} \ell^{2-2\delta_2}$.

11. PROOF OF THEOREM 2.6

We are now ready to define the relevant objects of Theorem 2.6. The center manifold \mathcal{M} is given by Theorem 3.11: the fact that \mathcal{M} is a b -separated admissible \bar{Q} -branching is a simple consequence of the estimates in Theorem 3.11. We then apply Proposition 2.4 to find the map Ψ which is a conformal parametrization of \mathcal{M} in a neighborhood of 0 and, after a suitable scaling, we assume that it is defined on $\mathfrak{B}_{\bar{Q},2}$. Secondly we consider the normal approximation N of the current T on \mathcal{M} constructed in Theorem 4.3. The relation $\bar{Q}Q = \Theta(T, 0)$ is obvious from the construction. Again, after scaling, we assume that:

- The radius r_0 of Theorem 2.6 is 4;
- $\Psi(\mathfrak{B}) \subset \mathbf{C}_3(0)$;

Rather than call the rescaled current S , as it is done in the statement of Theorem 2.6, we keep denoting it by T .

The maps \mathcal{N} and \mathcal{F} are then defined as

$$\mathcal{N}(z, w) := N(\Psi(z, w)) = \sum_i \llbracket N_i(\Psi(z, w)) \rrbracket \quad (11.1)$$

$$\mathcal{F}(z, w) := \sum_i \llbracket \Psi(z, w) + \mathcal{N}_i(z, w) \rrbracket = \sum_i \llbracket \Psi(z, w) + N_i(\Psi(z, w)) \rrbracket. \quad (11.2)$$

By the estimate (3.17) it follows immediately that

$$|A_{\mathcal{M}}(\zeta, \xi)| + |\zeta| |D_{\mathcal{M}} A_{\mathcal{M}}(\zeta, \xi)| \leq C \mathbf{m}_0^{1/2} |\zeta|^{\gamma_0 - 1}$$

at any point $p = (\zeta, \xi) \in \mathcal{M}$ with $\zeta \in \mathbb{R}^2 \setminus 0$. On the other hand by (2.5), if we set $(\zeta, \xi) := \Psi(z, w)$, then we have

$$|z| - C \mathbf{m}_0^{1/4} |z|^{1+\gamma_0} \leq |\zeta| \leq |z| + C \mathbf{m}_0^{1/2} |z|^{1+\gamma_0} \quad (11.3)$$

and thus the estimates in (i) follow. By construction $\mathcal{N}_i(z, w) = N_i(\Psi(z, w))$ is orthogonal to $T_{\Psi(z, w)} \mathcal{M}$, which shows (ii).

The fact that T is contained in a horned neighborhood of \mathcal{M} where the projection \mathbf{p} is well defined is a consequence of Corollary 4.1. Moreover, by (11.3) we can assume $\Psi(B_r(0)) \subset \mathbf{C}_{2r}$ (this is true for a sufficiently small r and hence, after scaling, we can assume it holds for any $r \leq 1$). On the other hand, consider a cube L of \mathscr{W} which intersects $B_{3r/2}(0)$. By construction its sidelength is necessarily smaller than r . Thus (2.12) is a simple consequence of (4.1), Corollary 4.1(iii) and Corollary 4.1(iv).

We are left to show the three estimates claimed in point (iv) of Theorem 2.6: the rest of the section is devoted to this task.

11.1. The special covering. First of all consider the set $\Psi(B_r(0))$ and let $\mathcal{B}_r \subset \mathfrak{B}$ be defined by

$$\mathcal{B}_r := \{(z, w) \in \mathfrak{B} : \Phi(z, w) \in \Psi(B_r(0))\}. \quad (11.4)$$

Observe that, by the estimates on Ψ , the following two facts are obvious for r small:

- (g1) \mathcal{B}_r is star-shaped with respect to the origin, more precisely if $q = (z, w) \in \partial \mathcal{B}_r$, then the geodesic segment σ in \mathfrak{B} joining $(0, 0)$ and q is contained in \mathcal{B}_r ;

- (g2) If \bar{q} denotes the point on σ at distance $\frac{r}{4}$ from the origin, the disk $B_{r/4}(\bar{q})$ is contained in \mathcal{B}_r .

We next select an (at most countable) family of triples $\{(L_j, B_j, U_j)\}_{j \in \mathbb{N}}$ of subsets of $\mathfrak{B}_{\bar{Q}}$ with the following properties:

- (c1) The L_j 's are distinct cubes of the Whitney decomposition with $L_j \in \mathcal{W}_e \cup \mathcal{W}_h$ and $L_j \subset \bar{B}_{2r+6\ell(L_j)}$;
(c2) $B_j = B_{\ell(L_j)/4}(z_j, w_j) \subset \mathcal{B}_r$ are disjoint balls such that $|z_{L_j} - z_j| \leq 7\ell(L_j)$;
(c3) U_j is the union of an at most countable family of cubes $\bar{\mathcal{W}}(L_j) \subset \mathcal{W}$ where $H \subset B_{30\ell(L_j)}(z_{L_j}, w_{L_j})$ for every $H \in \bar{\mathcal{W}}(L_j)$ and $\cup_j \bar{\mathcal{W}}(L_j)$ consists of all cubes in \mathcal{W} which intersect \mathcal{B}_r ; in particular

$$\mathcal{B}_r \subset \Gamma \cup \bigcup_j U_j. \quad (11.5)$$

To this aim we start by selecting all the cubes $L \in \mathcal{W}_e \cup \mathcal{W}_h$ such that either $L \cap \mathcal{B}_r \neq \emptyset$ or there exists $H \in \mathcal{W}_n$ in the domain of influence of L with $H \cap \mathcal{B}_r \neq \emptyset$, and we denote the collection of such cubes by $\mathcal{W}(r)$. Observe that, $\ell(L) \leq C_0 2^{-N_0} r$ and thus, provided N_0 is chosen sufficiently large, we can assume that the ratio $\frac{\ell(L)}{r}$ is smaller than any fixed geometric constant. Moreover, by Corollary 4.5, it is obvious that $L \subset B_{2r+6\ell(L)}$.

The triples above are then chosen according to the following procedure:

- We start selecting recursively $\{L_j\} \subset \mathcal{W}(r)$. L_0 is a cube with the largest sidelength in $\mathcal{W}(r)$. Having chosen $\{L_0, \dots, L_j\}$ we select L_{j+1} as a cube with the largest sidelength among those $L \in \mathcal{W}(r)$ such that $B_{15\ell(L)}(z_L, w_L) \cap B_{15\ell(L_i)}(z_{L_i}, w_{L_i}) = \emptyset$ for all $i \leq j$.
- For every L_j we use the geometric properties (g1) and (g2) to choose a ball B_j as in (c2): for instance we consider $z_j := \frac{z_{L_j}}{|z_{L_j}|} (|z_{L_j}| - \frac{7\sqrt{2}}{2} \ell_{L_j})$ and let (z_j, w_j) be the unique point of \mathfrak{B} that belongs to the connected component of $\mathfrak{B} \cap (B_{L_j} \times \mathbb{C})$ that contains (z_{L_j}, w_{L_j}) . The B_j 's are disjoint because they are contained in $B_{15\ell(L_j)}(z_{L_j}, w_{L_j})$;
- For what concerns U_j , we need to define $\bar{\mathcal{W}}(L_j)$. First of all $L_j \in \bar{\mathcal{W}}(L_j)$. We then consider any other $H \in \mathcal{W}$ such that $H \cap \mathcal{B}_r \neq \emptyset$ and we assign it to one (and only one) family $\bar{\mathcal{W}}(L_j)$ according to the following rules:
 - (a) If $H \in \mathcal{W}_e \cup \mathcal{W}_h$, then $H \in \mathcal{W}(r)$ and we select one L_j with largest sidelength such that $B_{15\ell(L_j)}(z_{L_j}, w_{L_j}) \cap B_{15\ell(H)}(z_H, w_H) \neq \emptyset$;
 - (b) If $H \in \mathcal{W}_n$, then H belongs to the domain of influence $\mathcal{W}_n(L)$ of some $L \in \mathcal{W}(r)$; we then assign H to the family $\bar{\mathcal{W}}(L_j)$ which already contains L .

11.2. Estimates on \mathcal{U}_j and Λ . Let $\mathcal{U}_j = \Phi(U_j)$ and $\mathcal{B}_j := \Phi(B_j)$ and set, for notational convenience, $d_j := d(L_j)$ and $\ell_j := \ell(L_j)$. As a simple consequence of Theorem 4.3 and of

Corollary 4.1(iii) we deduce the following estimates for every $j \in \mathbb{N}$:

$$\int_{\mathcal{U}_j} |\boldsymbol{\eta} \circ N| \leq C \mathbf{m}_0 d_j^{2\gamma_0 - 2 + 2\beta_0 \gamma_0 - \beta_2} \ell_j^{5 + \beta_2/4} + C \mathbf{m}_0^{1/2 + \beta_0} d_j^{\gamma_0 - 1} \ell_j^{1 + \beta_2} \int_{\mathcal{U}_j} |N| \quad (11.6)$$

$$\int_{\mathcal{U}_j} |DN|^2 \leq C \mathbf{m}_0 d_j^{2\gamma_0 - 2 + 2\delta_1} \ell_j^{4 - 2\delta_1}, \quad (11.7)$$

$$\|N\|_{C^0(\mathcal{U}_j)} + \sup_{p \in \text{spt}(T) \cap \mathbf{p}^{-1}(\mathcal{U}_j)} |p - \mathbf{p}(p)| \leq C \mathbf{m}_0^{1/4} d_j^{\gamma_0/2 - \beta_2} \ell_j^{1 + \beta_2}, \quad (11.8)$$

$$\text{Lip}(N|_{\mathcal{U}_j}) \leq C (\mathbf{m}_0 d_j^{\gamma_0} \ell_j^{\gamma_0})^{\beta_0}, \quad (11.9)$$

$$\|T - \mathbf{T}_F\|(\mathbf{p}^{-1}(\mathcal{U}_j)) \leq C \mathbf{m}_0^{1 + \beta_0} d_j^{(1 + \beta_0)(2\gamma_0 - 2 + 2\delta_1)} \ell_j^{2 + (1 + \beta_0)(2 - 2\delta_1)}. \quad (11.10)$$

Indeed, observe that $d(H) \leq d_j \leq 2d(H)$ for every $H \in \bar{\mathcal{W}}(L_j)$ and $\sum_{H \in \bar{\mathcal{W}}(J_i)} \ell(H)^2 \leq C \ell_j^2$, because all $H \in \bar{\mathcal{W}}(J_i)$ are disjoint and contained in a ball of radius comparable to ℓ_j . This in turn implies that $\sum_{H \in \bar{\mathcal{W}}(J_i)} \ell(H)^{2+\varepsilon} \leq C \ell_j^{2+\varepsilon}$, because $\ell(H) \leq \ell_j$ for any $H \in \bar{\mathcal{W}}(L)$, and (11.6) - (11.10) follows easily because the exponents $5 + \beta_2/4$, $4 - 2\delta_1$ and $2 + (1 + \beta_0)(2 - 2\delta_1)$ are all larger than 2.

Next we claim the following inequality for every $t > 0$, where $\eta(t)$ and $C(t)$ are suitable positive functions,

$$\sup_j (\mathbf{m}_0 d_j \ell_j)^t \leq C(t) \boldsymbol{\Lambda}^{\eta(t)}(r), \quad (11.11)$$

Indeed, using Propositions 4.4 and 4.7 we have

$$C_e \mathbf{m}_0 d_j^{2\gamma_0 - 2 + 2\delta_1} \ell_j^{4 - 2\delta_1} \leq C \int_{\mathcal{B}_j} |DN|^2 \quad \text{if } L_j \in \mathcal{W}_e, \quad (11.12)$$

$$C_h^2 \mathbf{m}_0^{1/2} d_j^{\gamma_0 - 2\beta_2} \ell_j^{4 + 2\beta_2} \leq C \int_{\mathcal{B}_j} |N|^2 \quad \text{if } L_j \in \mathcal{W}_h. \quad (11.13)$$

On the other hand, since the \mathcal{B}_j are disjoint and contained in $\mathcal{B}_r = \boldsymbol{\Psi}(B_r)$,

$$\sum_j \int_{\mathcal{B}_j} |DN|^2 \leq \int_{\mathcal{B}_r} |DN|^2 = \int_{B_r} |D\mathcal{N}|^2$$

by conformality of $\boldsymbol{\Psi}$ and

$$\sum_j \int_{\mathcal{B}_j} |N|^2 \leq \int_{\mathcal{B}_r} |N|^2 \leq C \int_{B_r} |\mathcal{N}|^2$$

by the Lipschitz regularity of $\boldsymbol{\Psi}$. Thus (11.11) follows easily by suitably choosing $C(t)$ and $\eta(t)$.

Observe therefore that (2.13) is an obvious consequence of (11.11), (11.9) and the uniform bound on $|D\boldsymbol{\Psi}|$ given in Proposition 2.4.

11.3. **Proof of (2.14).** First of all observe that, by the bounds on Ψ of Proposition 2.4,

$$\int_{B_r} |\zeta|^{\gamma_0-1} |\boldsymbol{\eta} \circ \mathcal{X}(\zeta, \xi)| \leq C \int_{B_r} |z|^{\gamma_0-1} |\boldsymbol{\eta} \circ N(z, w)|.$$

On the other hand, since $U_j \subset B_{30\ell_j}(z_{L_j}, w_{L_j})$ and $\frac{d_j}{2} \leq |z_{L_j}| \leq 2d_j$, we compute

$$\int_{B_r} |z|^{\gamma_0-1} |\boldsymbol{\eta} \circ N(z, w)| \leq C \sum_j d_j^{\gamma_0-1} \int_{U_j} |\boldsymbol{\eta} \circ N(z, w)|.$$

Now considering that $d_j^{3\gamma_0-3+2\beta_0\gamma_0-\beta_2} \ell_j^{5+\beta_2/4} \leq d_j^{3\gamma_0-2} \ell_j^{4+2\beta_2}$ (recall $2\beta_2 \leq \beta_0\gamma_0$), we have

$$\begin{aligned} & \int_{B_r} |z|^{\gamma_0-1} |\boldsymbol{\eta} \circ N(z, w)| \\ & \stackrel{(11.6)}{\leq} C \sum_{j \in \mathbb{N}} \left(\mathbf{m}_0 d_j^{3\gamma_0-2} \ell_j^{4+2\beta_2} + \underbrace{C \mathbf{m}_0^{1/2+\beta_0} d_j^{\gamma_0-1} \ell_j^{1+\beta_2} \int_{U_j} \frac{|N|}{|z|^{1-\gamma_0}}}_{=:A} \right). \end{aligned}$$

We treat the second term in the summand above via Young's inequality inequality;

$$\begin{aligned} A & \leq 2 \left(\mathbf{m}_0^{1/2+\beta_0} d_j^{\gamma_0-1} \ell_j^{2+\beta_2} \right)^2 + 2 \left(\ell_j^{-1} \int_{U_j} \frac{|N|}{|z|^{1-\gamma_0/2}} \right)^2 \\ & \leq 2 \mathbf{m}_0^{1+2\beta_0} d_j^{2\gamma_0-2} \ell_j^{4+2\beta_2} + C \int_{U_j} \frac{|N|^2}{|z|^{2-\gamma_0}}, \end{aligned}$$

where in the second line we have used Cauchy-Schwartz and $|U_j| \leq C\ell_j^2$. Summarizing,

$$\mathbf{m}_0^{\eta_0} \int_{B_r} |z|^{\gamma_0-1} |\boldsymbol{\eta} \circ N(z, w)| \leq C \sum_j \left(\mathbf{m}_0^{1+\eta_0} d_j^{2\gamma_0-2} \ell_j^{4+2\beta_2} + C \mathbf{m}_0^{\eta_0} \int_{U_j} \frac{|N|^2}{|z|^{2-\gamma_0}} \right). \quad (11.14)$$

Moreover, observe that, if $L_j \in \mathscr{W}_h$, then by (11.13) and $\frac{d_j}{2} \leq |z| \leq 2d_j$,

$$\mathbf{m}_0 d_j^{2\gamma_0-2} \ell_j^{4+2\beta_2} \leq C \mathbf{m}_0^{1/2} \int_{U_j} \frac{|N|^2}{|z|^{2-\gamma_0}} \quad (11.15)$$

while, if $L_j \in \mathscr{W}_e$, using (11.12) and (11.11), we deduce, for a suitable choice of η_0 ,

$$\mathbf{m}_0^{1+\eta_0} d_j^{2\gamma_0-2} \ell_j^{4+2\beta_2} \leq C \mathbf{m}_0^{\eta_0} d_j^{\beta_2} \ell_j^{\beta_2} \int_{U_j} |DN|^2 \leq C \Lambda(r)^{\eta_0} \int_{U_j} |DN|^2. \quad (11.16)$$

Using (11.14), (11.15) and (11.16), the conformality of Ψ (which in particular leaves the Dirichlet energy invariant) and the bounds in Proposition 2.4 we conclude

$$\mathbf{m}_0^{\eta_0} \int_{B_r} |\zeta|^{\gamma_0-1} |\boldsymbol{\eta} \circ \mathcal{X}(\zeta, \xi)| \leq C \Lambda(r)^{\eta_0} \mathbf{D}(r) + C \int_{B_r} \frac{|\mathcal{X}|^2(\zeta, \xi)}{|\zeta|^{2-\gamma_0}}.$$

However the later integral is precisely

$$\int_0^t \frac{\mathbf{H}(t)}{t^{2-\gamma_0}}.$$

This shows (2.14).

11.4. **Proof of (2.15).** Observe that $\mathbf{T}_F = \mathbf{T}_{\mathcal{F}}$. Thus using (11.10) we have

$$\|T - \mathbf{T}_{\mathcal{F}}\|(\mathbf{p}^{-1}(\Psi(B_r))) \stackrel{(11.10)}{\leq} C \sum_{j \in \mathbb{N}} \mathbf{m}_0^{1+\beta_0} d_j^{(2\gamma_0-2+2\delta_1)(1+\beta_0)} \ell_j^{2+(2-2\delta_1)(1+\beta_0)}.$$

Now, if $L_j \in \mathscr{W}_e$, then using (11.11) and (11.12) with a suitable η , we have

$$\begin{aligned} \mathbf{m}_0^{1+\beta_0} d_j^{(2\gamma_0-2+2\delta_1)(1+\beta_0)} \ell_j^{2+(2-2\delta_1)(1+\beta_0)} &\leq (\mathbf{m}_0 d_j^{\gamma_0} \ell_j^{\gamma_0})^{\beta_0} \left(\mathbf{m}_0 d_j^{2\gamma_0-2+2\delta_1} \ell_j^{4-2\delta_1} \right) \\ &\leq C \Lambda^\eta(r) \int_{\mathcal{U}_j} |DN|^2. \end{aligned}$$

On the other hand, if $L_j \in \mathscr{W}_h$, then by (11.13) and our choice of the constants,

$$\begin{aligned} \mathbf{m}_0^{1+\beta_0} d_j^{(2\gamma_0-2+2\delta_1)(1+\beta_0)} \ell_j^{2+(2-2\delta_1)(1+\beta_0)} &= \mathbf{m}_0^{1+\beta_0} d_j^{(2\gamma_0-2+2\delta_1)(1+\beta_0)} \ell_j^{-2\delta_1+\beta_0(2-2\delta_1)-2\beta_2} \ell_j^{4+2\beta_2} \\ &\leq \mathbf{m}_0^{1/2+\beta_0} d_j^{2\gamma_0\beta_0} \mathbf{m}_0^{1/2} d_j^{\gamma_0-2\beta_2+\gamma_0-2} \ell_j^{4+2\beta_2} \\ &\leq \mathbf{m}_0^{1/2+\beta_0} d_j^{2\gamma_0\beta_0} \int_{\mathcal{U}_j} \frac{|N|^2}{|z|^{2-\gamma_0}} \end{aligned}$$

where we used that $-2\delta_1 + \beta_0(2 - 2\delta_1) - 2\beta_2 > 0$. Summing both contributions and arguing as in the previous paragraph we conclude the proof of (2.15).

APPENDIX A. DENSITY AND HEIGHT BOUND

In this appendix we record two estimates which are standard for area minimizing currents and can be extended with routine arguments to the three cases of Definition 0.1. Both statements are valid for general m without additional efforts and we therefore do not restrict to $m = 2$ here. Consistently with [13, 8] we introduce the parameter Ω , which equals

- $\mathbf{A} = \|A_\Sigma\|_{C^0}$ in case (a) of Definition 0.1;
- $\max\{\|d\omega\|_{C^0}, \|A_\Sigma\|_{C^0}\}$ in case (b);
- $C_0 R^{-1}$ in case (c).

Lemma A.1. *There is a positive geometric constant $c(m, n)$ with the following property. If T is a current as in Definition 0.1, where $\Omega \leq c(m, n)$, then*

$$\|T\|(\mathbf{B}_\rho(p)) \geq \omega_m \left(\Theta(T, p) - \frac{1}{4}\right) \rho^m \geq \omega_m \frac{3}{4} \rho^m \quad \forall p \in \text{spt}(T), \forall r \in \text{dist}(p, \partial U). \quad (\text{A.1})$$

Proof. By [13, Proposition 1.2] $\|T\|$ is an integral varifold with bounded mean curvature in the sense of Allard, where $C_0 \Omega$ bounds the mean curvature for some geometric constant C_0 . It follows from Allard's monotonicity formula that $e^{C_0 \Omega r} \|T\|(\mathbf{B}_r(x))$ is monotone nondecreasing in r , from which the first inequality in (A.1) follows. The second inequality

is implied by $\Theta(T, p) \geq 1$ for every $p \in \text{spt}(T)$: this holds because the density is an upper semicontinuous function which takes integer values $\|T\|$ -almost everywhere. \square

For the proof of the next statement we refer to [9, Theorem A.1]: in that theorem T satisfies the stronger assumption of being area minimizing (thus covering only case (a) of Definition 0.1), but a close inspection of the proof given in [9] shows that the only property of area minimizing currents relevant to the arguments is the validity of the density lower bound (A.1).

Theorem A.2. *Let Q , m and n be positive integers. Then there are $\varepsilon > 0, c > 0$ and C geometric constants with the following property. Assume that $\pi_0 = \mathbb{R}^m \times \{0\} \subset \mathbb{R}^{m+n}$ and that:*

- (h1) T is an integer rectifiable m -dimensional current as in Definition 0.1 with $U = \mathbf{C}_r(x_0)$ and $\Omega \leq c$;
- (h2) $\partial T \llcorner \mathbf{C}_r(x_0) = 0$, $(\mathbf{p}_{\pi_0})_{\#} T \llcorner \mathbf{C}_r(x_0) = Q \llbracket B_r(\mathbf{p}_{\pi_0}(x_0)) \rrbracket$ and $E := \mathbf{E}(T, \mathbf{C}_r(x_0)) < \varepsilon$.

Then there are $k \in \mathbb{N}$, points $\{y_1, \dots, y_k\} \subset \mathbb{R}^{m+n}$ and positive integers Q_1, \dots, Q_k such that:

- (i) having set $\sigma := CE^{1/2m}$, the open sets $\mathbf{S}_i := \mathbb{R}^m \times (y_i +] - r\sigma, r\sigma[{}^n)$ are pairwise disjoint and $\text{spt}(T) \cap \mathbf{C}_{r(1-\sigma|\log E|)}(x_0) \subset \cup_i \mathbf{S}_i$;
- (ii) $(\mathbf{p}_{\pi_0})_{\#} [T \llcorner (\mathbf{C}_{r(1-\sigma|\log E|)}(x_0) \cap \mathbf{S}_i)] = Q_i \llbracket B_{r(1-\sigma|\log E|)}(\mathbf{p}_{\pi_0}(x_0), \pi_0) \rrbracket \forall i \in \{1, \dots, k\}$.
- (iii) for every $p \in \text{spt}(T) \cap \mathbf{C}_{r(1-\sigma|\log E|)}(x_0)$ we have $\Theta(T, p) < \max\{Q_i\} + \frac{1}{2}$.

APPENDIX B. PROOF OF PROPOSITION 2.4

In order to prove the Proposition we recall the following classical fact about the existence of conformal coordinates. As in the rest of the paper, e denotes the standard euclidean metric.

Lemma B.1. *For every $k \in \mathbb{N}$ and $\alpha, \beta \in]0, 1[$ there are positive constants C_0 and c_0 with the following properties. Let g be a $C^{k, \beta}$ Riemannian metric on the unit disk $B_2 \subset \mathbb{R}^2$ with $\|g - e\|_{C^{0, \alpha}} \leq c_0$. Then there exists an orientation preserving diffeomorphism $\Lambda : \Omega \rightarrow B_2$ and a positive function $\lambda : \Omega \rightarrow \mathbb{R}$ such that*

- (i) $\Lambda^{\#} g = \lambda e$;
- (ii) $\|\Lambda - \text{Id}\|_{C^{1, \alpha}} + \|\lambda - 1\|_{C^{0, \alpha}} \leq C_0 \|g - e\|_{C^{0, \alpha}}$;
- (ii) $\|\Lambda - \text{Id}\|_{C^{k+1, \beta}} + \|\lambda - 1\|_{C^{k, \beta}} \leq C_0 \|g - e\|_{C^{k, \beta}}$.

Although the statement above is a well-known fact (and it follows, for instance, from the treatment of the problem given in [18, Addendum 1 to Chapter 9]), we have not been able to find a classical reference for it. However a complete proof can be found in the Appendix of [5].

Proof of Proposition 2.4. After rescaling we can assume that $\rho \geq 2^Q$. We fix Q and drop subscripts in $\mathfrak{B}_{Q, 2}$. Observe also that, if we rescale by a large factor R , the constants C_i in Definition 1.4 can then be replaced by the constants $C_i R^{-\alpha}$. Hence, without loss of generality we can assume that C_i is sufficiently small.

Let $\Phi : \mathfrak{B} \rightarrow \mathbb{R}^{n+2}$ be the graphical parametrization of the branching and recall that $g = \Phi^\sharp e$. Fix a point $(z_0, w_0) \in \mathfrak{B} \setminus \{0\}$, let $r := |z_0|/2$ and observe that on $B_r(z_0, w_0)$ we can use z as a chart and compute the metric tensor explicitly as

$$g_{ij}(z, w) = \delta_{ij} + \partial_i u(z, w) \partial_j u(z, w) =: \delta_{ij} + \sigma_{ij}.$$

It then follows easily that

$$|D^j \sigma(z)| \leq C_0 C_i^2 |z|^{2\alpha-j} \quad \text{for } j \in \{0, 1, 2\} \quad (\text{B.1})$$

$$[D^2 \sigma]_{\alpha, B_r(z_0, w_0)} \leq C_0 C_i^2 r^{\alpha-2}. \quad (\text{B.2})$$

Step 1. Next consider the map $\mathbf{W} : \mathbf{C} = \mathbb{R}^2 \supset B_2 \rightarrow \mathfrak{B}$ defined by $\mathbf{W}(z) := (z^Q, z)$. We set

$$\bar{g} = \mathbf{W}^\sharp g = (\Phi \circ \mathbf{W})^\sharp e.$$

We then infer that (following Einstein's convention on repeated indices)

$$\bar{g}_{ij}(z) = Q^2 |z|^{2Q-2} \delta_{ij} + \sigma_{kl}(\mathbf{W}(z)) \partial_i \mathbf{W}_l \partial_j \mathbf{W}_k,$$

and we set

$$\tau(z) := (Q^2 |z|^{2Q-2})^{-1} \bar{g}(z).$$

We then easily see that

$$|\tau(z) - e| \leq C_0 |z|^{-(2Q-2)} |D\mathbf{W}(z)|^2 |\mathbf{W}(z)| \leq C_0 C_i^2 |z|^{2Q\alpha}.$$

Differentiating the identity which defines τ we also get

$$\begin{aligned} |D\tau(z)| &\leq C_0 |z|^{-(2Q-1)} |D\mathbf{W}(z)|^2 |\sigma(\mathbf{W}(z))| + C_0 |z|^{-(2Q-2)} |D^2 \mathbf{W}(z)| |D\mathbf{W}(z)| |\sigma(\mathbf{W}(z))| \\ &\quad + C_0 |z|^{-(2Q-2)} |D\mathbf{W}(z)|^2 |D\sigma(\mathbf{W}(z))| |z|^{Q-1} \\ &\leq C_0 C_i^2 |z|^{2Q\alpha-1}. \end{aligned}$$

Analogous computations lead then to the estimates

$$|D^j(\tau - e)|(z) \leq C_0 C_i^2 |z|^{2Q\alpha-j} \quad \text{for } j \in \{0, 1, 2\} \quad (\text{B.3})$$

$$[D^2 \tau]_{\alpha, B_s(z)} \leq C_0 C_i^2 |z|^{2Q\alpha-2-\alpha} \quad \text{for } s = |z|/2. \quad (\text{B.4})$$

Interpolating between the C^1 and the C^0 bound, we easily conclude that

$$[\tau]_{2Q\alpha, B_{2r} \setminus B_r} \leq C_0 C_i^2.$$

Note in particular that τ (unlike g) can be extended to a nondegenerate $C^{0, Q\alpha}$ metric to the origin.

Since C_i can be assumed sufficiently small, we can apply Lemma B.1 to find an orientation preserving diffeomorphism $\Lambda : \Omega \rightarrow B_2$ and a function $\lambda : \Omega \rightarrow \mathbb{R}^+$ such that

$$\Lambda^\sharp \tau = \bar{\lambda} e \quad (\text{B.5})$$

$$\|\Lambda - \text{Id}\|_{C^{1, 2Q\alpha}} + \|\bar{\lambda} - 1\|_{C^{0, 2Q\alpha}} \leq C_0 C_i. \quad (\text{B.6})$$

Observe that, without loss of generality, we can assume that $0 \in \Omega$ and $\Lambda(0) = 0$. In particular (B.6) implies that, for C_i suitably small, $B_1 \subset \Omega$ and hence we will regard Λ and λ as defined on B_1 . Next divide Λ by $\bar{\lambda}(0)^{1/2}$ and keep, by abuse of notation, the

same symbols for the resulting map and the resulting conformal factor in (B.5). After this normalization we achieve that $\bar{\lambda}(0) = 1$ and that the estimates (B.6) still hold with a larger C_0 . Moreover, $\bar{\lambda}(0) = 1$ implies that $D\Lambda(0) \in SO(2)$: composing Λ with an appropriate rotation we can then assume that $D\Lambda(0)$ is the identity. This implies that

$$|\bar{\lambda}(z) - 1| \leq C_0 C_i |z|^{2Q\alpha} \quad (\text{B.7})$$

$$|D^j(\Lambda(z) - z)| \leq C_0 C_i |z|^{1+2Q\alpha-j} \quad \text{for } j \in \{0, 1\}. \quad (\text{B.8})$$

Step 2. We next wish to estimate the higher derivatives of both Λ and $\bar{\lambda}$. We adopt the following procedure. We fix a point $p \neq 0$ and let $r := |p|/2$. We then apply a simple scaling argument to rescale $B_r(p)$ to a ball of radius 2 so that we can apply Lemma B.1. If we rescale back to $B_r(p)$ it is then easy to see that we find maps $\Lambda_p : \Omega_p \rightarrow B_r(p)$, $\lambda_p : \Omega_p \rightarrow \mathbb{R}^+$ with the properties

$$\Lambda_p^\# \tau = \lambda_p g \quad (\text{B.9})$$

$$\|\Lambda_p - \text{Id}\|_{C^{1,2Q\alpha}} + \|\lambda_p - 1\|_{C^{0,2Q\alpha}} \leq C_0 C_i \quad (\text{B.10})$$

$$[\Lambda_p - \text{Id}]_{3,\alpha} + [\lambda_p - 1]_{2,\alpha} \leq C_0 C_i r^{2Q\alpha-2-\alpha}. \quad (\text{B.11})$$

Define $\Xi := \Lambda \circ \Lambda_p^{-1}$. Moreover, its domain is $B_r(p)$. Since

$$\sup_{z \in B_r(p)} |\partial_z(\Xi(z) - z)| \leq C_0 r^{2Q\alpha},$$

we easily conclude the higher derivative estimates

$$\|\partial_z^k(\Xi(z) - z)\| \leq C_0 C_i r^{2Q\alpha-k} \quad \text{for } k \in \{1, 2, 3, 4\},$$

which, by holomorphicity, are actually estimates on the full derivatives. Since $\Lambda = \Xi \circ \Lambda_p$ we then easily conclude that

$$|D^{j+1}\Lambda(z)| + |D^j(\bar{\lambda}(z) - 1)| \leq C_0 C_i |z|^{2Q\alpha-j} \quad \text{for } j \in \{0, 1, 2\} \quad (\text{B.12})$$

$$[D^3\Lambda]_{\alpha, B_r(z)} + [D^2\bar{\lambda}]_{\alpha, B_r(z)} \leq C_0 C_i r^{2Q\alpha-2-\alpha} \quad \text{for } r = |z|/2 > 0. \quad (\text{B.13})$$

Finally notice that

$$(\Lambda^\# \bar{g})(z) = Q^2 |\Lambda(z)|^{2Q-2} \bar{\lambda}(z) e. \quad (\text{B.14})$$

Step 3. We are finally ready to define $\Psi := \Phi \circ \mathbf{W} \circ \Lambda \circ \mathbf{W}^{-1}$. First of all observe that

$$(\Psi^\# e)(z, w) = ((\mathbf{W}^{-1})^\# \Lambda^\# \bar{g})(z, w) = \frac{|\Lambda(\mathbf{W}^{-1}(z, w))|^{2Q-2}}{|z|^{2-2/Q}} \bar{\lambda}(\mathbf{W}^{-1}(z, w)) e_Q =: \lambda(z, w) e_Q.$$

Since $|\mathbf{W}^{-1}(z, w)| = |z|^{1/Q}$, we can also estimate

$$\begin{aligned} |\lambda(z, w) - 1| &\leq \frac{|\Lambda(\mathbf{W}^{-1}(z, w))|^{2Q-2}}{|z|^{2-2/Q}} |\bar{\lambda}(\mathbf{W}^{-1}(z, w)) - 1| + C \frac{|\Lambda(\mathbf{W}^{-1}(z, w))|^{2Q-2} - |z|^{2-2/Q}}{|z|^{2-2/Q}} \\ &\leq C_0 C_i^2 |\mathbf{W}^{-1}(z, w)|^{2Q\alpha} + C_0 |z|^{-1/Q} (|\Lambda(\mathbf{W}^{-1}(z, w))| - |\mathbf{W}^{-1}(z, w)|) \\ &\leq C_0 C_i^2 |z|^{2\alpha} + C_0 C_i^2 |z|^{-1/Q} |\mathbf{W}^{-1}(z, w)|^{1+2Q\alpha} \leq C_0 C_i^2 |z|^{2\alpha}. \end{aligned}$$

Similarly

$$\begin{aligned} |D\lambda(z, w)| &\leq C_0 |D\bar{\lambda}(\mathbf{W}^{-1}(z, w))| |z|^{-1} + C_0 \left| D \frac{|\Lambda(\mathbf{W}^{-1}(z, w))|^{2Q-2}}{|\mathbf{W}^{-1}(z, w)|^{2Q-2}} \right| \\ &\leq C_0 C_i^2 |z|^{2\alpha-1} + C_0 \left| D \frac{|\Lambda(\mathbf{W}^{-1}(z, w))|}{|\mathbf{W}^{-1}(z, w)|} \right| \end{aligned}$$

and observe that

$$\begin{aligned} \left| D \frac{|\Lambda(\mathbf{W}^{-1})|}{|\mathbf{W}^{-1}|} \right| &= \left| \left(\frac{D\Lambda(\mathbf{W}^{-1})}{|\Lambda(\mathbf{W}^{-1})| |\mathbf{W}^{-1}|} - \frac{|\Lambda(\mathbf{W}^{-1})|}{|\mathbf{W}^{-1}|^3} \text{Id} \right) D\mathbf{W}^{-1} \mathbf{W}^{-1} \right| \\ &\leq C_0 |D\mathbf{W}^{-1}| |\mathbf{W}^{-1}|^{-1} (|D\Lambda(\mathbf{W}^{-1}) - \text{Id}| + |\mathbf{W}^{-1}| (|\Lambda(\mathbf{W}^{-1}) - (\mathbf{W}^{-1})|)) \\ &\leq C_0 C_i^2 |D\mathbf{W}^{-1}| |\mathbf{W}^{-1}|^{2Q\alpha-2}. \end{aligned}$$

Recalling that $|D\mathbf{W}^{-1}(z, w)| \leq |z|^{1/Q-1}$, $|\mathbf{W}^{-1}(z, w)| = |z|^{1/Q}$, we conclude

$$|D\lambda(z, w)| \leq C_0 C_i^2 |z|^{2\alpha-1}.$$

The estimates on the second derivative and its Hölder norm follow from similar computations.

We now come to the estimates on Ψ . Let $\bar{\Lambda} := \mathbf{W} \circ \Lambda \circ \mathbf{W}^{-1}$. Fix $(z_0, w_0) \neq 0$, let $r := |z_0|/2$ and use z as a local chart. It will then suffice to show that

$$|D^j(\bar{\Lambda}(z) - z)| \leq C_0 C_i |z|^{1+\alpha-l} \quad \text{for } j \in \{0, 1, 2, 3\} \quad (\text{B.15})$$

$$[D^3\bar{\Lambda}]_{\alpha, B_r(z_0, w_0)} \leq C_0 C_i |z|^{-2}. \quad (\text{B.16})$$

On the other hand since $\bar{\Lambda}(0, 0) = (0, 0)$, it actually suffices to show the first estimate for $j = 1$ to obtain it in the case $j = 0$.

We start computing the first derivatives:

$$D\bar{\Lambda} = D\mathbf{W}(\Lambda \circ \mathbf{W}^{-1})D\Lambda(\mathbf{W}^{-1})D\mathbf{W}^{-1}.$$

Recalling that $D\mathbf{W}(\mathbf{W}^{-1})D\mathbf{W}^{-1} = \text{Id}$, we estimate

$$\begin{aligned} |D\bar{\Lambda}(z) - \text{Id}| &\leq |D\mathbf{W}(\Lambda(\mathbf{W}^{-1}(z))) - D\mathbf{W}(\mathbf{W}^{-1}(z))| |D\Lambda(\mathbf{W}^{-1}(z))| |D\mathbf{W}^{-1}(z)| \\ &\quad + |D\mathbf{W}(\mathbf{W}^{-1}(z))| |D\Lambda(\mathbf{W}^{-1}(z)) - \text{Id}| |D\mathbf{W}^{-1}(z)| \\ &\leq C_0 |\mathbf{W}^{-1}(z)|^{Q-1} |\Lambda(\mathbf{W}^{-1}(z)) - \mathbf{W}^{-1}(z)| |z|^{1/Q-1} \\ &\leq + C_0 C_i^2 |\mathbf{W}^{-1}(z)|^{Q-1} |\mathbf{W}^{-1}(z)|^{2Q\alpha} |z|^{1/Q-1} \\ &\leq C_0 C_i^2 |\mathbf{W}^{-1}(z)|^{Q+2Q\alpha} |z|^{1/Q-1} + C_0 C_i^2 |z|^{2\alpha} \leq C_0 C_i^2 |z|^{2\alpha}. \end{aligned}$$

Similar computations give the estimates on the higher derivatives. \square
